**THE COUNCIL OF THE CITY OF CARLISLE

(VARIATION No.4: SANDS CENTRE REDEVELOPMENT) ORDER 2019**

The Council of the City of Carlisle (also known as the City Council of Carlisle) (hereinafter referred to as "the Council") in exercise of the powers under Sections 32 and 35 of the Road Traffic Regulation Act 1984 and of part IV of Schedule 9 to the Act and under Part 6 and Schedules 8 & 9 of the Traffic Management Act 2004 ("the Acts") and of all other enabling powers and with the consent of the Council of the County of Cumbria given under Section 39(3) of the Road Traffic Regulation Act and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Road Traffic Regulation Act hereby makes the following Order.

1. The Council of the City of Carlisle (Off Street Parking Places) (Consolidation and Minor Amendment Variation — Pay by Telephone) Order 2012 ("the Order") (as amended) is hereby further amended as follows:
2. In Schedule 3 at "Off Street Pay and Display Parking Places" the area of the Sands Car Park is amended by removing the plan of the Sands Car Park and inserting the new plan annexed hereto and marked Plan 'S' in its stead and showing the extent by red edging
3. In Schedule 9 of the Order the number of spaces for the Car Park listed below is amended as follows:

Sands Car Park

Existing Number of Spaces:270

Number of Spaces with effect from 1st October 2019:120
4. Under Schedule 3(4) and 3(5) and Schedule 9 of the Order the days and times of operation and scale of charges and exemptions for the car park listed below are amended as follows

Swifts Bank Car Park

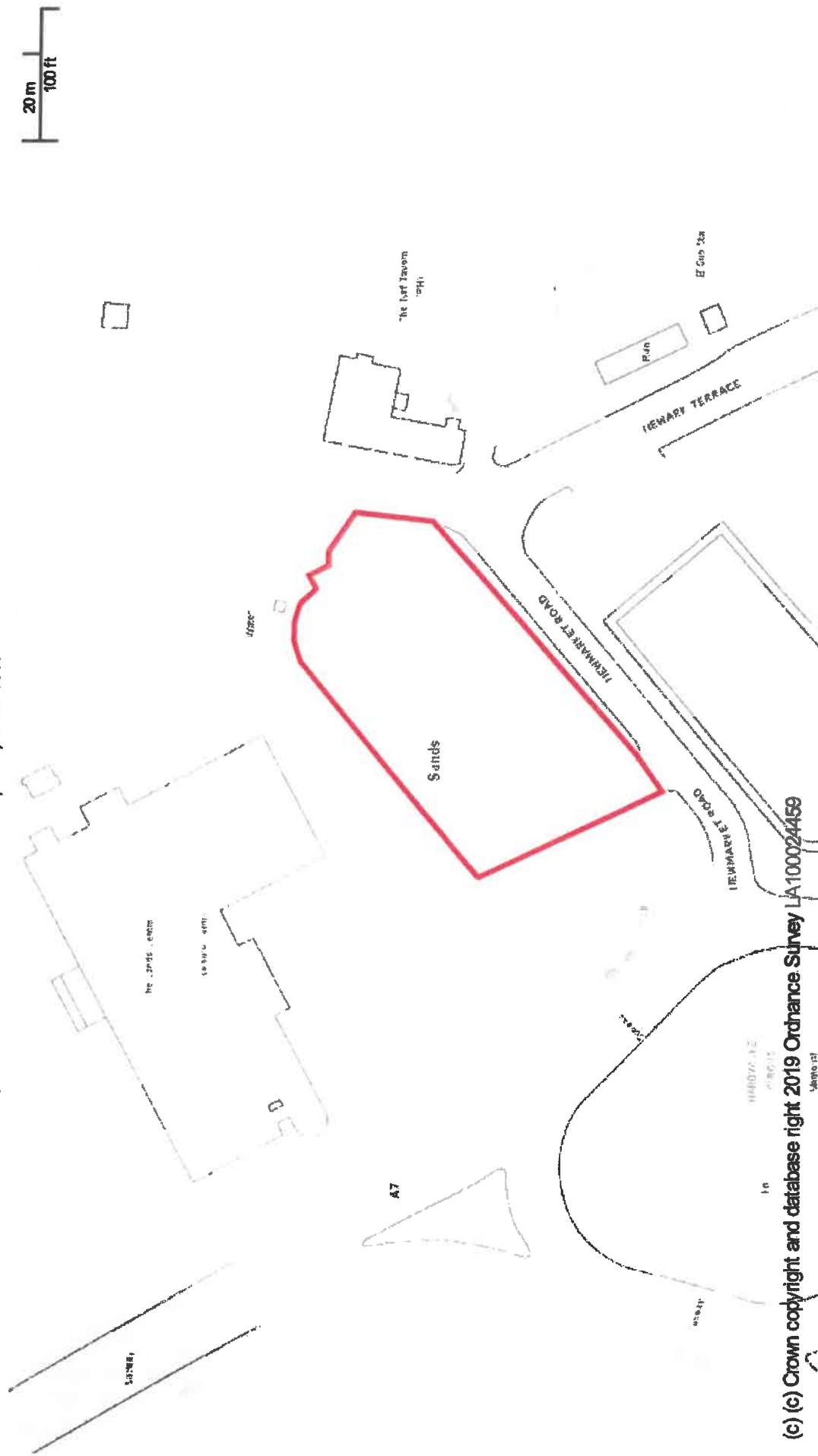

(VARIATION NO 4: SANDS CENTRE REDEVELOPMENT) ORDER 2019**

STATEMENT OF REASONS

The City Council of Carlisle considers that it is expedient to propose to make the above Order for the following reasons:

1. The Sands Centre redevelopment works necessitate the closure of some existing areas of the Sands Car Park to facilitate construction.
2. Extra local car parking capacity is being made available at Swifts Bank car park and at alternative sites elsewhere in Carlisle with a view to relieving potential pressure on central Carlisle car parking facilities which may be occasioned by the reduction in Sands car parking spaces arising from the construction of new buildings at the Sands
3. It is anticipated that local demand for car parking at the Sands Centre may in any event reduce during the Sands Centre redevelopment construction period owing to a phased relocation of some Sands Centre based activity elsewhere within Carlisle thereby triggering concomitant vehicle user transfer to the site identified for the carrying out of the relocated activity
