

**THE CARMARTHENSHIRE COUNTY COUNCIL  
(OFF-STREET PARKING PLACES) (CARMARTHENSHIRE) (PAY AND DISPLAY)  
(CONSOLIDATION) ORDER 2014**

---

**NOTICE** is hereby given that the Carmarthenshire County Council in exercise of their powers under Sections 35 (1) and (3) of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the 1984 Act") as amended by the Parking Act 1989 and the Traffic Management Act 2004 and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the 1984 Act have made the above-named Order the effect of which will be to:

- 1. consolidate the orders listed in Schedule 1 to this Notice having effect in the County of Carmarthenshire as designated by The Road Traffic (Permitted Parking Area and Special Parking Area) (County of Carmarthenshire) Order 2004, and to
- 2. introduce additional days and times of operation and charging hours for parking places.
- 3. disabled (Blue) badge holders receive an allowance of 1 hour free parking, once a pay and display ticket has been purchased.

**THE** Order will revoke the Orders listed in Schedule 1 hereto but the provisions contained in those Orders (as amended) specifying the conditions for the control and use of the parking places will be reproduced and contained in the new Order (save as to charges which have been subsequently revised and amended by notices published in accordance with section 35C of the 1984 Act and to variation in the level of Penalty Charge payable by the owner of any vehicle to which a Penalty Charge Notice is issued). That is to say the Carmarthenshire County Council will be able to continue implementing effectively a system of parking enforcement consequent upon decriminalisation of offences relating to the parking of vehicles and the use of parking places in designated off street parking places in the County of Carmarthen and will empower civil enforcement officers engaged on behalf of the said Council to issue penalty charge notices in respect of offences. The Schedules to the Order, which are replicated below, gives details of the classes of vehicle which may use the parking places, the days and times when a charge for parking will be made, the maximum period of waiting and the scale of charges proposed for each parking place.

The Order will come into operation on the 28th day of August, 2014 and a copy of the Order may be examined at the offices of Carmarthenshire County Council at County Hall, Carmarthen, during normal office hours.

Any person who desires to question the validity of this Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Act or on the grounds that any requirement of the Act or any instrument made under it has not been complied with in relation to the Order, may, within six weeks of the date on which the Order was made, apply to the High Court for this purpose.

**THE CARMARTHENSHIRE COUNTY COUNCIL  
(OFF-STREET PARKING PLACES)  
CONSOLIDATION ORDER 2014**

Carmarthenshire County Council (hereinafter called "the Council") in exercise of its powers under Section 35(1) and (3) of and Part IV of Schedule 9 to the Road Traffic Regulation Act, 1984, ("the 1984 Act") as amended by the Parking Act 1989 and by the Traffic Management Act 2004 and of all other enabling powers and after consultation with the Chief Office of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:

**1. CITATION**

This Order shall come into operation on the 28th day of August, 2014 and may be cited as The Carmarthenshire County Council (Off-Street Parking Places) (Consolidation) Order 2014.

**2. INTERPRETATION**

- (i) Any reference in this Order to a numbered Article is a reference to the Article bearing that number in this Order and any reference in this Order to a numbered schedule is to the schedule to this order which is so numbered.
- (ii) The Interpretation Act 1978 shall apply to the interpretation of this Order as it applies to the interpretation of an Act of Parliament.
- (iii) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, or re-enacted by, or as having effect by virtue of, any subsequent enactment.
- (iv) In this Order, except where the context otherwise requires, the following expressions have the meanings respectively assigned to them:

"Charging Days" means those days which are specified in Schedule 2 of this Order for each Parking Place respectively.

"Charging Hours" means the period which is specified in the schedules included with this Order for each Parking Place respectively.

"The Council" means Carmarthenshire County Council.

"Disabled Persons' Badge" means a badge issued by any Local Authority in accordance with the provisions of the Disabled Persons (Badges for Motor Vehicles) (Wales) Regulations 2000 or a badge having effect under those regulations as if it were a disabled person's badge.

"Owner" means the person by whom the vehicle is kept. In determining who was the owner of a vehicle at any time it shall be presumed that the owner was the person in whose name the vehicle was at that time registered under the Vehicle Excise and Registration Act 1994.

"Civil Enforcement Officer" has the meaning given by section 76 of the Traffic Management Act 2004 ('the 2004 Act').

"Parking Bay" means any area in a Parking Place marked on the surface of the Parking Place by lines, studs or other indications, which is provided for the leaving of a vehicle.

"Parking Charge" means the charge prescribed in Schedule 3 of this Order to be paid for vehicles left in a Parking Place.

"Parking Place" means an area of land specified in Schedule 2 of this Order included with this Order and provided by the Council pursuant to Section 32(1) of the 1984 Act for the purpose of vehicle parking which includes all entrances and egresses therefrom and not closed (in part or in whole) by a Notice erected thereon by authority of the Council.

"Penalty Charge" and "Reduced Penalty Charge" means a charge set by the Council under the provisions of Part 6 of the 2004 Act and with the approval of the Welsh Ministers which is to be paid to the Council within 28 days beginning with the date of the notice, or 14 days in the case of a reduced penalty charge, following the issue of a Penalty Charge.

"Penalty Charge Notice" means a notice issued or served by a Civil Enforcement Officer pursuant the provisions of Part 6 of the 2004 Act and the Civil Enforcement of The Road Traffic Contraventions (General Provisions) (Wales) Regulations 2013

"Relevant Position" means

- (a) in the case of a vehicle which is fitted with a transparent windscreen, by attaching the parking ticket to the inside surface of the windscreen so that it is facing forwards and can be easily seen and read from in front of the vehicle or alternatively behind a nearside window; or

- (b) in the case of a vehicle not fitted with a transparent windscreen, by attaching the parking ticket in a conspicuous position on the front of the vehicle.

"Season Ticket" means a ticket purchased from the Council, subject to certain conditions, valid for the period specified on the ticket for use in parking places specified on the ticket.

"Ticket Machine" means a device of a type and design, approved by the Welsh Ministers, for the purpose, inter alia, of this Order, being a device designed to indicate the time by a clock, and to issue parking tickets which show that a payment has been made of an amount, or for a period specified thereon, and which specify the date and the time at which the vehicle must leave the Parking Place.

"Ticket" or "Tickets" shall be construed as reference to a ticket or tickets purchased from a Ticket Machine by the insertion therein of an appropriate coin or coins.

"Vehicle" means any vehicle whether or not it is in a fit state for use on roads and includes any chassis, with or without wheels, appearing to form or have formed part of such a vehicle and any load carried by or anything attached to such a vehicle. "Vehicle" shall include caravans and trailers. For the purpose of this Order the term Vehicle shall include "Motor Vehicle", "Motor Car", "Trailer", "Motor Cycle" and "Invalid Carriage" as defined in section 136 of the 1984 Act and a "caravan" as defined in the Caravan Sites and Control of Development Act 1960;

- (v) Sub-sections (4) and (5) of Section 47 of the 1984 Act shall apply to the Parking Places as if they were Parking Places provided on a highway.

### 3. USE OF PARKING PLACES

- (i) Each Parking Place may be used, subject to the following provisions of this Order, as a Parking Place for such vehicles or classes of vehicles in such positions and on such days and during such hours as are specified in relation thereto in Schedule 2 of this Order.
- (ii) No person shall cause or permit a vehicle to wait in a bay marked for Disabled Persons unless the vehicle displays a valid Disabled Person's Badge in the manner prescribed by Regulation 12 of the Disabled Person's (Badges for Motor Vehicles) (Wales) Regulations 2000 and the vehicle is being driven or used by the person to whom the badge is issued.

- (iii) Nothing in this article shall prohibit a vehicle on which a valid Disabled Persons Badge is displayed from being parked in any other bay provided the vehicle is of the class permitted by or under this Order to park in such other Parking Bay.
- (iv) Nothing in this article shall prohibit a vehicle from being parked in a bay marked for Public Service Vehicles/Buses at Whitland Leisure Centre Coach Park outside the hours designated for use of those bays by such classes of vehicle
- (v) Nothing in this Order shall prevent the Council by notice displayed in the Parking Place
  - (a) from closing the Parking Place or any part thereof for any period; and/or
  - (b) from setting aside the Parking Place or any part or parts thereof on all days or on certain days or during certain parts of days for use only by particular vehicles.
- (vi) The driver of a vehicle using a Parking Place shall not leave the vehicle in any position in the Parking Place in which it will obstruct access to or egress from that Parking Place (including any emergency access or egress) or to any premises adjoining the Parking Place or park in the access roads within the Parking Place or park on diagonal yellow lines.
- (vii) The driver of a vehicle whilst in a Parking Place shall comply with any instructions given to him or her by a Civil Enforcement Officer as to the manner of parking of the vehicle and shall remove the vehicle from the Parking Place on being required by the Civil Enforcement Officer to do so.

#### **4. POSITION OF VEHICLES**

- (i) Motorcycles and pedal cycles permitted in the parking places identified in Schedule 2 and specified in Article 3 of this Order shall be positioned in bays (if any) specifically provided for motorcycles and pedal cycles on the Parking Place.
- (ii) All other vehicles permitted to wait in the parking places identified in Schedule 2 and specified in Article 3 of this Order shall be positioned in any other bays marked on the Parking Place.
- (iii) If the dimensions of a vehicle authorised by this Order to be parked exceed those of a single bay, that vehicle shall be parked wholly within the limits of the smallest number of adjoining parking bays required.

#### **5. MANNER OF PARKING OF TRAILERS**

The driver of a vehicle drawing a trailer shall not permit the vehicle or the trailer to wait in a Parking Place unless they have been disconnected, and for the purposes of this Order the vehicle and the trailer shall be deemed to be separate vehicles and the driver of the leading vehicle shall be deemed to be the driver of both of the vehicles.

#### **6. USE OF VEHICLES IN PARKING PLACES**

- (i) No person shall use a vehicle or a trailer, while it is in a Parking Place, in

connection with the sale or attempted sale of any article to persons in or near the Parking Place, or in connection with the selling or offering for hire of his skill or services, unless duly authorised by the Council in writing so to do.

- (ii) No person shall use a vehicle or a trailer, while it is in a Parking Place as a dwelling or for any domestic or sanitary purpose.
- (iii) The driver of a vehicle using a Parking Place shall stop the engine as soon as the vehicle is in a position in the Parking Place and shall not start the engine except when about to change the position of the vehicle in or to depart from the Parking Place.

## **7. REPAIR OF VEHICLES IN PARKING PLACES**

No person shall, while a vehicle is in a Parking Place, permit the carrying out of any work of maintenance or repair thereto except such as may be necessary to enable the vehicle to be moved from the Parking Place.

## **8. MAXIMUM PERIOD OF WAITING**

The maximum periods of waiting in the parking places and limitations on returning to them shall apply as specified in Schedule 2 of this Order.

## **9. REMOVAL OF A VEHICLE FROM PARKING PLACES**

Where a person duly authorised by the Council is of the opinion that any of the provisions contained in any article of this Order have been contravened, or not complied with in respect of a vehicle left in a Parking Place, he/she may, under the provisions of the Removal and Disposal of Vehicles Regulations 1986, remove the vehicle or cause it to be removed from the Parking Place, and, where it is so removed, shall provide for the safe custody of the vehicle.

## **10. MOVEMENT OF VEHICLES IN A PARKING PLACE IN EMERGENCIES**

- (i) A Police Constable in uniform or any other person duly authorised by the Council may, in case of emergency, move or cause to be moved, vehicles left in a Parking Place to any place he/she thinks fit.
- (ii) Where a vehicle is left in a Parking Place in a position other than that specified in Article 4 and Schedule 2, a Police Constable in uniform or any other person duly authorised by the Council may move the vehicle or cause it to be moved to a position which complies with that specified in Article 4 and the schedules included with this order.

## **11. MANNER OF MOVING VEHICLES**

Any person moving or removing a vehicle in accordance with Articles 9 or 10 may do so by towing or driving the vehicle, or in such other manner as he may think necessary, and may take such measures in relation to the vehicle as he/she may think necessary to enable him

or her to move or remove it as aforesaid.

## **12 SAFE CUSTODY OF VEHICLES**

When a person authorised by the Council removes a vehicle or causes it to be removed from a Parking Place in accordance with Articles 10 and 11 of this Order, he/she shall make such arrangements as may be reasonably necessary for the safe custody of the vehicle.

## **13 DIRECTION IN WHICH VEHICLES MUST BE DRIVEN**

No person shall drive or cause or permit to be driven any vehicle on any length of road or aisle in any Parking Place contrary to the directions given by the appropriate carriageway markings or signs.

## **14. ENTRY AND EXIT**

The driver of a vehicle shall not cause it to enter a Parking Place at a point marked "No Entry" or to leave a Parking Place at a point marked "No Exit".

## **15 "PAY AND DISPLAY" PARKING TICKETS**

The driver of a vehicle left in accordance with the provisions of this Order in a Parking Place indicated in Schedule 2 of this Order shall purchase a valid parking ticket at the price and for the period indicated in Schedule 3 of this Order and exhibit the parking ticket on the vehicle in the Relevant Position.

## **16 A parking ticket used in a Parking Place indicated in Schedule 2 of this Order shall only be a valid parking ticket if:**

- (i) it has been purchased from a Ticket Machine in the Parking Place where the vehicle is left with exception of a ticket purchased from a Ticket Machine located in any of the parking places situated in the towns of Ammanford (with the exception to Hall Street Car Park, Ammanford) Llandeilo, Llandovery and Newcastle Emlyn which shall be during the permitted hours or period described in paragraph (iii) below be transferrable between each and every of the parking places located in any of the said towns.
- (ii) it is exhibited on the vehicle in a Relevant Position; AND
- (iii) it has been purchased in accordance with the provisions that in the parking places specified in Schedule 2 of this Order, one ticket per vehicle shall be valid either:
  - (a) for the number of hours or for the period specified on the Ticket commencing, if purchased during Charging Hours, at the time of purchase or if purchased outside Charging Hours, at the beginning of the next following period of Charging Hours; OR
  - (b) from the time of purchase or if purchased outside Charging Hours from the beginning of the next following period of Charging Hours to the expiry time

specified on the Ticket so however that no such ticket shall be valid after the vehicle has exceeded in any one period of Charging Hours the maximum period of waiting (if any) specified in Article 9 hereof;

## **17 RESTRICTION ON REMOVAL OF PARKING TICKETS**

When a parking ticket or season ticket has been exhibited on a vehicle, in accordance with the provisions of Article 16(ii), no person shall remove the parking ticket or season ticket from the vehicle until the vehicle is removed from the Parking Place.

## **18 PEDAL CYCLES AND MOTOR CYCLES**

The driver of a motorcycle or a pedal cycle, which is left in accordance with the provisions of this Order in a Parking Place in the position, specified for such vehicles, as specified in Article 4 and in Schedule 2 of this Order, shall be exempt from purchasing a parking ticket.

## **19 DISABLED PERSONS' VEHICLES**

The restrictions imposed by Article 8 of this Order shall apply to vehicles displaying a Disabled Person's Badge, with the additional allowance of 1 hour free parking when a pay a display ticket has been purchased.

## **20. ABSENCE OF TICKET MACHINE**

If at the time when a vehicle is left in a Parking Place specified in Schedule 2 of this Order during the Charging Hours there is no Ticket Machine at the Parking Place, or all the Ticket Machines at that Parking Place carry notices placed upon them by a person duly authorised by the Council indicating that they are out of order, the charge shall be payable to a person authorised to receive such a payment by the Council. In the absence of such arrangements, the driver of that vehicle shall be exempt from purchasing a parking ticket.

## **21 SEASON TICKETS**

- (i) Season tickets shall be available for the parking places as specified in Schedule 2 of this Order but each season ticket shall be valid only for the Parking Place or places specified upon it.
- (ii) The driver of a vehicle left in accordance with the provisions of this Order in a relevant Parking Place as specified in Schedule 2 of this Order shall be exempt from purchasing a parking ticket if there is displayed in the Relevant Position a valid season ticket purchased from the Council.
- (iii) The price of a season ticket shall be in accordance with Schedule 3 of this Order.

## **22. CONTRAVENTIONS**

If a vehicle is left in a Parking Place specified in the Schedule 2 of this Order during

the Charging Hours without complying with the requirements of this Order, a contravention shall have occurred and a Penalty Charge shall be payable. A Penalty Charge Notice showing the information required by The Civil Enforcement of The Road Traffic Contraventions (General Provisions) (Wales) Regulations 2013 may then be issued by a Civil Enforcement Officer in accordance with the requirements as prescribed therein.

### **23. NOTICE OF PENALTY CHARGE**

- (i) In the case of a vehicle in respect of which the Penalty Charge may have been incurred, it shall be the duty of a Civil Enforcement Officer to attach to the vehicle in a conspicuous position a Notice which shall include such particulars as are required by the Civil Enforcement of The Road Traffic Contraventions (General Provisions) (Wales) Regulations 2013 or any other regulations which amends or replaces these regulations.
- (ii) A Penalty Charge Notice fixed to a vehicle in accordance with this section shall not be removed or interfered with except by or under the authority of:
  - (a) the owner, or person in charge of, of the vehicle;
  - (b) the Authority for the place in which the vehicle in question was found.

### **24. RESTRICTION ON REMOVAL OF NOTICES**

Where a Notice has been attached to a vehicle in accordance with the provisions of Article 23, no person who is not a Civil Enforcement Officer or some other person duly authorised by the Council shall remove the Notice from the vehicle, until the vehicle has been removed from the Parking Place.

### **25. PAYMENT OF PENALTY CHARGE**

- (i) The Penalty Charge may be paid to the Council within 28 days of the issue of the Penalty Charge by cheque, postal order, in cash, by credit card or debit card in person at any Council office which accepts such payment OR as indicated on the Penalty Charge Notice not later than as aforesaid.
- (ii) If the Penalty Charge is paid before the end of the period of 14 days beginning with the date of the Notice, the amount of the penalty charge will be reduced by the specified proportion.

If the Penalty Charge is not paid by the end of the 28 day period, a Notice to Owner may be served; and if the charge is then not paid within a further 28 days it may be increased by the amount of the applicable surcharge on the issue of a Charge Certificate in accordance with the Civil Enforcement of The Road Traffic Contraventions (General Provisions) (Wales) Regulations 2013 and provisions of Schedule 9 of the 2004 Act.

- (iii) Continuing failure to pay may result in a judgement in the County Court against the owner to enable the Council to recover payments due.

**26 OTHER PROVISIONS**

- (i) In a Parking Place, no person shall:
  - (a) erect or cause or permit to be erected any tent, booth, stand, building or other structure without the written consent of the Council.
  - (b) light or cause or permit to be lit any fire.

**27** The Council, its servants or agents, shall not be responsible for any loss or damage howsoever occasioned to any person or thing entering, within or leaving the Parking Place.

**28 REVOCATIONS**

The Orders specified in Schedule 1 to this Order are hereby revoked.
