

PUBLIC NOTICE

THE COUNTY OF CARMARTHENSHIRE (CARMARTHEN) (WAITING RESTRICTION AND STREET PARKING PLACES) CONSOLIDATION (VARIATION No. 2) ORDER 2004

NOTICE is hereby given that on the 1st day of October, 2004 the Carmarthenshire County Council made an Order under Sections 1(1), 2(1) to (3), 4(2), 32, 35 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") as amended by the Road Traffic Act 1991

The effect of this Order will be to amend The County of Carmarthenshire (Carmarthen) (Waiting Restrictions and Street Parking Places) Consolidation Order 2004 ("the Consolidation Order") (which provides for decriminalised enforcement of contraventions of waiting prohibitions and restrictions) by substituting the plans annexed thereto denoting Areas BR137, BR138, BS135, BS136, BS137, BT135 and BQ138 with the plans annexed to the Order. The consequence of the amendment will:

1. Prohibit waiting at any time on side of road specified in Schedule 1 to this Notice
2. Prohibit waiting at any time on the sides of road specified in Schedule 2 to this Notice with no exemptions for loading and unloading of vehicles or for passengers to board and alight from a vehicle. The usual parking concession for disabled persons will also be removed.
3. Limit waiting to 1 hour with return prohibited within 2 hours between the hours of 9.00 a.m. and 5.00 p.m. on any day except Sunday on the sides of road specified in Schedule 3 to this Notice
4. Limit waiting to 30 minutes with return prohibited within 1 hour between the hours of 8.00 a.m. and 6.00 p.m. on any day except Sunday on the side of road specified in Schedule 4 to this Notice.
5. To prohibit parking between the hours of 8.00 a.m. and 6.00 p.m. on any day except Sunday on the side of road specified in Schedule 5 to this Notice except for goods vehicles
6. To prohibit parking on the side of road specified in Schedule 6 to this Notice except for disabled persons' parked in accordance with the provisions contained in the Consolidation Order and on such days and during such hours as identified on the relevant plan
7. To limit the period of waiting for disabled vehicles parked in the designated parking bays in King Street to one hour
8. To permit goods to be loaded on or unloaded from vehicles insofar as it relates to the sides of road specified in Schedule 7 to this Notice

9. To revoke "The County of Carmarthenshire (Carmarthen)(Waiting Restrictions and Street Parking Places) Consolidation Order 2004 in so far as it relates to the sides of road specified in Schedule 8 to this Notice

and will replace the existing prohibitions and restrictions (if any) that affect the parts of the roads referred to above

The provisions for the usual exemptions contained in the Consolidation Order will apply in relation to the roads referred to in paragraphs 1, 3 and 4 above. These include the right for passengers to board or alight from a vehicle, for the loading and unloading of goods, for the carrying out of building operations and other works, for the performance of statutory powers or duties, and to enable a vehicle to take in petrol, oil, water or air from any garage situated adjacent to such parts of the roads affected by the proposed restriction.

In addition, the Consolidated Order contains where applicable the usual parking concessions for disabled persons in accordance with the Blue Badge Scheme.

The Order will come into operation on the 22nd day of October 2004 and a copy of the Order, together with maps indicating the roads affected, may be inspected at the offices of the Carmarthenshire County Council at County Hall, Carmarthen during normal office hours.

Any person who desires to question the validity of this Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Act or on the grounds that any requirement of the Act or of any instrument made under it has not been complied with in relation to the Order, may, within six weeks of the date on which the Order was made, apply to the High Court for this purpose.
