

THE COUNTY OF CARMARTHENSHIRE (CARMARTHEN) SPECIAL PARKING AREA (RESIDENTS PARKING PLACES)(VARIATION NO. 1) ORDER 2006

The Carmarthenshire County Council in exercise of their powers under Sections 45, 46, 49, 53 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 as amended and the Road Traffic Act 1991 and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 and with the Road Traffic Act 1991, hereby make the following Order:-

The County of Carmarthenshire (Carmarthen) Special Parking Area (Residents Parking Places) Order 2004 ("the Order") is hereby varied by the attachment thereto of the plans attached to this Order which has the effect of imposing on such parts of the roads identified and for the periods identified in the plans attached to this Order:

1. Provision of resident parking places
2. Amendment of the boundary zone
3. Have effect as though for paragraph (iv) of Article 8 there were substituted the following paragraph:
 - iv The charge for the issue of a replacement of lost, worn or damaged permit shall be £20.00 per resident's parking permit and £50.00 per business permit which shall be valid for twelve months from the date of reissue and £20.00 per visitors parking permit when replaced within twelve months from the date of issue.
4. Revocation of "The County of Carmarthenshire (Carmarthen) Special Parking Area (Residents Parking Places) Order 2004"
5. Revocation of "The County of Carmarthenshire (Carmarthen) Waiting Restriction and Street Parking Places) Consolidation (Variation No. 1) Order 2004"

in accordance with the provisions of the Order

The Order shall come into operation on the 15th day of December, 2006 and may be cited as The County of Carmarthenshire (Carmarthen) Special Parking Area (Residents Parking Places) (Variation No. 1) Order, 2006

PUBLIC NOTICE

THE COUNTY OF CARMARTHENSHIRE (CARMARTHEN) SPECIAL PARKING AREA (RESIDENTS PARKING PLACES)(VARIATION NO. 1) ORDER 2006

NOTICE is hereby given that on the 4th day of December, 2006 the Carmarthenshire County Council made an Order under Sections 45, 46, 49, 53 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 as amended and the Road Traffic Act 1991 and all other enabling powers.

The effect of this Order will be to amend The County of Carmarthenshire (Carmarthen) Special Parking Area (Residents Parking Places) Order 2004 ("the Order") by substituting the plans annexed thereto denoting zones C2 and C4 with the plans annexed to the Order. The consequence of the amendment will:

1. Provide resident parking places with charges in parts of the roads listed in Schedule 1 to this Notice between the hours of 8.00 a.m. and 6.00 p.m. on all days except Sunday. During such days and hours of operation the Order will prohibit parking along such parts of the said roads except for vehicles displaying a valid parking permit issued by Carmarthenshire County Council.
2. Amend the boundary of the zone specified in column 1 of the Schedule to this Notice to include the road specified in Schedule 2 to this Notice.
3. Have effect as though for paragraph (iv) of Article 8 there were substituted the following paragraph:
 - iv The charge for the issue of a replacement of lost, worn or damaged permit shall be £20.00 per resident's parking permit and £50.00 per business permit which shall be valid for twelve months from the date of reissue and £20.00 per visitors parking permit when replaced within twelve months from the date of issue.
- 4 To revoke "The County of Carmarthenshire (Carmarthen) Special Parking Area (Residents Parking Places) Order 2004" insofar as it relates to the sides of road specified in Schedule 3 to this Notice.
5. To revoke "The County of Carmarthenshire (Carmarthen) Waiting Restriction and Street Parking Places) Consolidation (Variation No. 1) Order 2004 insofar as it relates to the sides of road specified in Schedules 4 and 5 to this Notice.

The provisions for the usual exemptions contained in the Order will apply in relation to the roads referred to in paragraphs 1 and 2 above. These include the right for passengers to board or alight from a vehicle, for the loading and unloading of goods, for the carrying out of building operations and other works, for the performance of statutory powers or duties situated adjacent to such parts of the roads affected by the proposed restriction.

In addition, the Order contains the usual parking concessions for disabled persons in accordance with the Blue Badge Scheme and for motor cycles.

The Order will come into operation on the 15th day of December, 2006 and a copy of the Order, together with maps indicating the roads affected, may be inspected at the offices of the Carmarthenshire County Council at County Hall, Carmarthen during normal office hours.

Any person who desires to question the validity of this Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Act or on the grounds that any requirement of the Act or of any instrument made under it has not been complied with in relation to the Order, may, within six weeks of the date on which the Order was made, apply to the High Court for this purpose. If you wish to object to the proposed Order you should send the grounds for your objection in writing to Lyn Thomas, Head of Administration and Law by the 12th day of October, 2006.
