

**THE COUNTY OF CARMARTHENSHIRE (CARMARTHEN) (WAITING  
RESTRICTION AND STREET PARKING PLACES) CONSOLIDATION  
(VARIATION No. 4) ORDER 2006**

The Carmarthenshire County Council in exercise of their powers under Section 1(1), 2(1) to (3) and 4(2) of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (which said Act is hereinafter referred to as "the Act of 1984") as amended and the Road Traffic Act 1991 and of all other powers them enabling and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 and with the Road Traffic Act 1991, hereby make the following Order:-

1. The County of Carmarthenshire (Carmarthen) (Waiting Restriction And Street Parking Places) Consolidation Order 2004 ("the Consolidation Order") is hereby varied by the attachment thereto of the plans attached to this Order which has the effect of imposing on such parts of the road identified and for the periods identified in the plans attached to this Order:

- (a) prohibition of waiting at any time
- (b) prohibition of loading and unloading of goods
- (c) revocation of residents parking

in accordance with the provisions of the Consolidation Order.

2. The Order shall come into operation on the 15<sup>th</sup> day of December Two Thousand and Six and may be cited as The County of Carmarthenshire (Carmarthen) (Waiting Restriction And Street Parking Places) Consolidation (Variation No.4) Order 2006

## **PUBLIC NOTICE**

### **THE COUNTY OF CARMARTHENSHIRE (CARMARTHEN) (WAITING RESTRICTION AND STREET PARKING PLACES) CONSOLIDATION (VARIATION NO. 4) ORDER 2006**

**NOTICE** is hereby given that on the 4<sup>th</sup> day of December, 2006 the Carmarthenshire County Council made an Order under Section 1(1), 2(1) to (3), 4(2), of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") as amended by the Road Traffic Act 1991.

The effect of this Order will be to amend The County of Carmarthenshire (Carmarthen) (Waiting Restrictions and Street Parking Places) Consolidation Order 2004 ("the Consolidation Order") (which provides for decriminalised enforcement of contraventions of waiting prohibitions and restrictions) by substituting the plans annexed thereto denoting Areas BP136, BP137, BP138, and BR137 with the plans annexed to the Order. The consequence of the amendment will:

1. Prohibit waiting at any time on parts of the roads specified in Schedule 1 to this Notice.
2. Prohibit goods to be loaded on or unloaded from vehicles insofar as it relates to the sides of roads specified in Schedule 2 to this Notice.
3. To revoke "The County of Carmarthenshire (Carmarthen) (Waiting Restrictions and Street Parking Places) Order 2004 insofar as it relates to the sides of road specified in Schedule 2 to this Notice.

and will replace the existing prohibitions and restrictions (if any) that affect the parts of the roads.

The provisions for the usual exemptions contained in the consolidation Order will apply in relation to the roads referred to in paragraph 1 above. These include the right for passengers to board or alight from a vehicle, for the loading and unloading of goods, for the carrying out of building operations and other works, for the performance of statutory powers or duties, and to enable a vehicle to take in petrol, oil, water or air from any garage situated adjacent to such parts of the roads affected by the proposed restriction.

In addition, the Consolidated Order contains where applicable the usual parking concessions for disabled persons in accordance with the Blue Badge Scheme.

The Order will come into operation on the 15<sup>th</sup> day of December, 2006 and a copy of the Order, together with maps indicating the roads affected, may be inspected at the offices of the Carmarthenshire County Council at County Hall, Carmarthen during normal office hours.

Any person who desires to question the validity of this Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Act or on the grounds that any requirement of the Act or of any instrument made under it has not been complied with in relation to the Order, may, within six weeks of the date on which the Order was made, apply to the High Court for his purpose.

### **Prohibition of Waiting at any time**

<b>Name of Road</b>	<b>Side of Road</b>
Picton Terrace	On the north side: From a point 51 metres west of the centre of its junction with Picton Place for a distance of approximately 25 metres in a westerly direction.
Penbryn Avenue	On both sides: From its junction with Picton Place for a distance of approximately 15 metres in a south westerly direction
Picton Place	On both sides: From a point 145 metres north west of its junction with Picton Terrace for a distance of approximately 21 metres in a general north westerly direction
College Road	On the south side: From a point 32 metres west of the centre of its junction with Parcmaen Street for a distance of approximately 40 metres in a westerly direction  On the north side: From a point 23 metres west of the centre of its junction with Millbrook Crescent for a distance of approximately 90 metres in a westerly direction
St. David's Avenue	On both sides

## **SCHEDULE 2**

### **Prohibition of Loading and Unloading**

<b>Name of Road</b>	<b>Side of Road</b>
Cambrian Place	On both sides: From its junction with Chapel Street for a distance of approximately 70 metres in a north westerly direction
Merlin Lane	On both sides: From its junction with Cambrian Place for a distance of approximately in a westerly direction
