

THE ESSEX COUNTY COUNCIL (CASTLE POINT BOROUGH) (PROHIBITION OF WAITING, LOADING AND STOPPING) AND (ON-STREET PARKING PLACES) (CIVIL ENFORCEMENT AREA) (AMENDMENT NO. 9) ORDER 2023

NOTICE IS HEREBY GIVEN that Chelmsford City Council acting on behalf of the South Essex Parking Partnership in exercise of the delegated powers of the traffic authority Essex County Council granted under an Agreement dated 30 June 2022 has made the above Order under Sections 1(1), 2(1) to (3), 4(1), 4(2), 32, 35, 45, 46, 49 and 53 and Parts III and IV of schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers.

Effect of the Order: To introduce parking restrictions in Thundersley on the following lengths of roads in the Borough of Castle Point as specified. All measurements are taken as accurately as possible and are taken from the extended kerb line unless stated otherwise:

1. To introduce 'No Waiting at Any Time':

Kingston Road,	BOTH SIDES: From its junction with A13 Kiln Road northwards for 25 metres.

Date of operation: This Order will come into operation on 21st June 2023.

Application to the High Court: Anyone who wishes to question the validity of the Order, or any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act, or any instrument made under it, has not been complied with in relation to the Order, may within six weeks from the making of the Order apply to the High Court for this purpose.
