(CONSOLIDATION) ORDER 2008) (EXPERIMENTAL VARIATION NO.2) ORDER 2019

The Central Bedfordshire Council (the "Council") in exercise of its powers under sections 1(1), 2(1) to (3), 4 (2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("The Act") and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of schedule 9 to the Act, hereby makes the following Order:

- This Order shall come into operation on 3<sup>rd</sup> June 2019 and may be cited as "Central Bedfordshire Council (Bedfordshire County Council (District of South Bedfordshire) (Civil Enforcement Area and Special Enforcement Area) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2008) (Experimental Variation No.2) Order 2019"
- 2. As from the date upon which this Order comes into operation, the provisions of the "Bedfordshire County Council (District of Mid Bedfordshire) (Civil Enforcement Area and Special Enforcement Area) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2008" shall be varied as follows:-

To introduce No Waiting at any time on the following length of road in Dunstable:-

- (i) Court Drive, east side, starting from a point approximately 32 metres from it's junction with The Parklands extending in a south-easterly direction for approximately 40 metres.
- (ii) Court Drive, east side, starting from a point approximately 81 metres from it's junction with The Parklands extending in a south-easterly direction for approximately 7 metres.
- (iii) Court Drive, east side, starting from a point approximately 91 metres from it's junction with The Parklands extending in a south-easterly direction for approximately 38 metres.
- (iv) Court Drive, east side, starting from a point approximately 2 metres from it's junction with Kingsway extending in a north-westerly direction for approximately 21 metres.
- (v) Court Drive, west side, starting from a point approximately 25 metres from it's junction with the Parklands extending in a south-easterly direction for approximately 10 metres.
- (vi) Court Drive, west side, starting from a point approximately 46 metres from it's junction with the Parklands extending in a south-easterly direction for approximately 72 metres.
- (vii)Court Drive, west side, starting from a point approximately140 metres from it's junction with the Parklands extending in a south-easterly direction for approximately 3 metres.
- (viii) Court Drive, both sides, from it's junction with Court Drive for it's length to it's junction with Court Drive.
- (ix) Court Drive, both sides, from it's northern junction with Court Drive, extending in an northerly direction for approximately 10 metres.
- (x) Court Drive, both sides, from its southern junction with Court Drive, extending in westerly direction for approximately 3 metres.
