(CONSOLIDATION) ORDER 2008) (VARIATION NO.28) ORDER 2015

The Central Bedfordshire Council (the "Council") in exercise of the powers under sections 1(1), 2(1) to (3), 4 (2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("The Act") and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of schedule 9 to the Act, hereby makes the following Order:

1. This Order shall come into operation on 6th day of November 2015 and may be cited as "Central Bedfordshire Council (Bedfordshire County Council (District of South Bedfordshire) (Civil Enforcement Area and Special Enforcement Area) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2008) (Variation No.28) Order 2015"
2. As from the date upon which this Order comes into operation, the provisions of the "Bedfordshire County Council (District of South Bedfordshire) (Civil Enforcement Area and Special Enforcement Area) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2008" shall be varied as follows:-

To reduce the operational hours of the current Residents' Permit Holders only parking to Monday to Friday between 9am and 5pm and introduce 2 hours Limited Waiting with No Return in 2 hours, on the following lengths of road in Leighton-Linslade:-

- a) Faulkner's Way from its junction with Bossington Lane for its remaining length, with the exception of those lengths covered by No Waiting at any time.

To add 2 hours Limited Waiting with No Return in 2 hours, except Permit Holders, on the following lengths of road in Leighton-Linslade and to add it to the amended Faulkner's Way Residents' Permit Parking zone:-

- a) Stoke Road, east side, from a point in line with the boundary of nos.5 and 7 Faulkner's Way extending in a southerly direction to a point in line with the boundary of nos.3 and 5 Stoke Road.

To reduce the operational hours of the current Residents' Permit Holders only parking to Monday to Friday between 10am and 12noon on the following lengths of road in Leighton-Linslade:-

- a) St Mary's Way, from a point approximately 10 metres south of the property boundary of no.62 Soulbury Road and no.1a St Mary's Way extending in a northerly direction to a point approximately 13 metres north of the property boundary of nos.41 and 43 St Mary's Way.
- b) Beech Grove, for its full length
- c) Hawthorn Close, for its full length.

To reduce the operational hours of the current Residents' Permit Holders only parking to Monday to Friday between 9am and 5pm on the following lengths of road in Leighton-Linslade:-

- a) Southcott Village, from its junction with Chelsea Green to the end.
