The Central Bedfordshire Council (the "Council") in exercise of its powers under sections 1(1), 2(1) to (3), 4 (2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("The Act") and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of schedule 9 to the Act, hereby makes the following Order:

- 1. This Order shall come into operation on 18th day of April 2016 and may be cited as "Central Bedfordshire Council (Bedfordshire County Council (District of South Bedfordshire) (Civil Enforcement Area and Special Enforcement Area) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2008) (Variation No.43) Order 2016"
- 2. As from the date upon which this Order comes into operation, the provisions of the "Bedfordshire County Council (District of South Bedfordshire) (Civil Enforcement Area and Special Enforcement Area) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2008" shall be varied as follows:-

To add Parking Places for Disabled Badge Holders at the following locations:-

- (i) Borough Road, Dunstable, south east side, from a point in line with the boundary of property nos.53 and 55 Borough Road extending in a north-easterly direction for approximately 7 metres.
- (ii) Park Street, Dunstable, south-east side, from a point approximately 3 metres north-east of the north-west flank wall of no.26 Park Street extending in an north-easterly direction for approximately 4 metres (parking space marked at right angles to the road).
- (iii) Conquest Road, Houghton Regis, south side, from a point in line with the boundary of property nos.2 and 3 Longmeadow extending in a westerly direction for approximately 7 metres.
- (iv) Manor Park, Houghton Regis, north-west side, from a point in line with the boundary of nos.8 and 10 Manor Park extending in a south-westerly direction for approximately 7 metres.
- (v) Sycamore Road, Houghton Regis, south-east side, from a point approximately 3 metres west of the front wall of no.2 Gable Way extending in a westerly direction for approximately 7 metres.
- (vi) Cantilupe Close, Houghton Regis, north side, outside no.16 Cantilupe Close from the far eastern end of the constructed parking area extending in a westerly direction for approximately 4 metres (parking space marked at right angles to the road).
- (vii) Wing Road, Linslade, south-east side, from a point in line with the boundary of nos.83 and 85 Wing Road extending in a south-westerly direction for approximately 7 metres.
- (viii) Dudley Street, Leighton Buzzard, south-east side, from a point approximately 2 metres south-west of the boundary of nos.24 and 26 Dudley Street extending in a north-easterly direction for approximately 7 metres.
