BEDFORDSHIRE COUNTY COUNCIL (DISTRICT OF SOUTH BEDFORDSHIRE) (CIVIL ENFORCEMENT AREA AND SPECIAL ENFORCEMENT AREA) (WAITING RESTRICTIONS AND STREET PARKING PLACES) (CONSOLIDATION) (VARIATION NO 5) ORDER 2009

On the 23rd January 2009 Bedfordshire County Council made a Road Traffic Regulation Order as follows:

Effect of the Order:

A. To introduce no waiting at any time and 30 minutes limit on loading/unloading on Middle Row, Ashton Square, Dunstable as follow:-.

Middle Row, Ashton Square, Dunstable which extends from a point in line with the extension of the northern boundary of No. 3a West Street, Dunstable south east for approx 89 metres to a point in line with the extension of the southern boundary of Nos. 38/40 High Street South, Dunstable.

The restrictions are considered necessary for the safety of shoppers, especially elderly shoppers and to protect emergency access to flats above the shops.

B. To make legal the existing Disabled Persons Parking Places at the following locations outside Mayfield Shops, Dunstable:-

The two Disabled Persons Parking Places are located outside the Mayfield Shops, Dunstable, on either side of the pedestrian access to the shops and flats, in the middle of the parking bays.

The days and hours of operation of these parking places will be unrestricted for disabled persons vehicles.

These parking bays need to be made legal to ensure that disabled people are able to park close to the shops.

C. To introduce two hour limited waiting restrictions with no return within one hour from 7am to 7pm Monday to Saturday inclusive outside Mayfield Shops, Dunstable as follows:-

- i. Nine marked out parking bays situated outside the Mayfield Shops, Dunstable on the north west side of the existing Disabled Persons Parking Places and the pedestrian access to the shops and flats.
- ii. Ten marked out parking bays situated outside the Mayfield Shops, Dunstable on the south east side of the existing Disabled Persons Parking Places and the pedestrian access to the shops and flats.

These limited waiting restrictions are considered necessary to deter long term parking by employees of a nearby business.

<u>Date of Operation:</u> The Order will come into operation on the 2nd February 2009.

<u>Further Details</u> of the Order and a plan showing the lengths of road affected may be examined during normal office hours at County Hall, Bedford and normal opening hours at Dunstable Library, Vernon Place, Dunstable.

<u>High Court Challenge:</u> Any person who desires to question the validity of the Order or of any provision contained therein on the ground that it is not within the powers of the relevant Section of the Road Traffic Regulation Act 1984 or on the ground that any requirement of that Section had not been complied with in relation to the Order may, within six weeks of the 1st February 2009 make application for the purpose to the High Court.

The Bedfordshire County Council (the "Council") in exercise of the powers under sections 1(1), 2(1) to (3), 4 (2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("The Act") and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of schedule 9 to the Act, hereby makes the following Order:

- 1. This Order shall come into operation on 2nd day of February 2009 and may be cited as "Bedfordshire County Council (District of South Bedfordshire) (Civil Enforcement Area and Special Enforcement Area) (Waiting Restrictions and Street Parking Places) (Consolidation) (Variation No 5) Order 2009"
- 2. As from the date upon which this Order comes into operation, the provisions of the "Bedfordshire County Council (District of South Bedfordshire) (Civil Enforcement Area and Special Enforcement Area) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2008" shall be varied as follows:-
 - (i) The plan schedule reference "Area Code AB 143: Sheet Revision Number 2" shall be deleted and "Area Code AB 143: Sheet Revision Number 3" shall be substituted.
 - (ii) The plan schedule reference "Area Code Z 139: Sheet Revision Number 2" shall be deleted and Area Code Z 139: Sheet Revision Number 3" shall be substituted.
 - (iii) The plan schedule reference "Area Code Z 140: Sheet Revision Number 1" shall be deleted and Area Code Z140: Sheet Revision Number 2" shall be substituted.
