BEDFORDSHIRE COUNTY COUNCIL (DISTRICT OF MID BEDFORDSHIRE) (CIVIL ENFORCEMENT AREA AND SPECIAL ENFORCEMENT AREA) (WAITING RESTRICTIONS AND STREET PARKING PLACES) (CONSOLIDATION) (VARIATION NO 3) ORDER 2009

On the 30th January 2009 Bedfordshire County Council made a Road Traffic Regulation Order as follows:

Effect of the Order:

A. Introduce no waiting at any time (amending the extents of the existing no waiting at any time) on the following lengths of road in Potton:-

Brook End: South side, from the property boundary of No. 21 Market Square and No. 2 Brook End, east for approx 40 metres.

Brook End: North side, from a projected line from the property boundary of No. 21 Market Square and No. 2 Brook End, east for approx 28 metres.

Market Square: The north side of the south east leg, from a projected line from the property boundary of 2 Brook End and 21 Market Square west then north for approx 9 metres.

Market Square: The south side of the south east leg, from the property boundary of No. 2 Brook End and No. 21 Market Square north west for approx 13 metres.

Market Square: The north side of the north east leg, from a projected line from the north eastern flank wall of 16 Market Square, south west for approx 17 metres.

Market Square: The north side of the north west leg, from the property boundary of No. 2 Bull Street and No. 6 Market Square east for approx 13 metres.

Market Square: The west side of the north west leg, from a projected line from the property boundary of No. 2 Bull Street and No. 6 Market Square east then south for approx 11 metres

Market Square: The west side of the south west leg, from the property boundary of "The Town House" (No. 2 Sun Street) and 1 Market Square, north east for approx 14 metres.

Market Square: The south side of the south west leg, from a projected line from the property boundary of "The Town House" (No. 2 Sun Street) and 1 Market Square, north, then east for approx 16 metres.

Market Square: The west side of the central area, from a point 20 metres west of a projected line from the eastern flank wall of the Library / Police Office, Market Square, generally south west for approx 26 metres.

Market Square: The east side of the central area, from a point 10 metres east of a projected line from the eastern flank wall of the Library / Post Office, Market Square, generally south for approx 22 metres.

B. Introduce no waiting at any time on the following lengths of road in Potton:-

Market Square: The east side of the north east leg, from a point 19 metres south west of the north eastern flank wall of 16 Market Square, south west for approx 8 metres.

C. Amend the existing parts authorised to be used as street parking places with limited waiting for 1 hour with no return for 2 hours, Monday to Saturday inclusive from 9am to 6pm in Market Square, Potton:-

Market Square: The eastern side of the south east leg, from a point approximately 9 metres north west of a projected line from the property boundary of No. 21 Market Square and No. 2 Brook End, north for approx 24 metres.

Market Square: The eastern side of the north east leg, from the north eastern flank wall of No. 16 Market Square, south west for approx 19 metres.

Market Square: The northern side of the north west leg, from a point approximately 13 metres east of the property boundary of No. 2 Bull Street and No. 6 Market Square, east for approx 16 metres.

Market Square: The northern side of the north east leg, from a point 17 metres south west of a projected line from the north eastern flank wall of No. 16 Market Square, west for approx 18 metres.

Market Square: The western side of the south west leg, from a point 14 metres north east of the property boundary of "The Town House" (No. 2 Sun Street) and 1 Market Square, north east for approx 18 metres.

Market Square: The southern side of the south west leg, from a point 13 metres north west of the property boundary of No. 2 Brook End and No. 21 Market Square west for approx 47 metres.

Market Square: The northern side of the central area, from a point approximately 2 metres east of a projected line from the eastern flank wall of the Library / Police Office, Market Square, west for approx 22 metres.

Market Square: The southern side of the central area, from a point approximately 27 metres west of a projected line from the eastern flank wall of the Library / Police Office, Market Square, east for approx 34 metres.

D. Amend the existing Disabled Person's Parking Places in Market Square, Potton

Market Square: The northern side of the north west leg, from a point approximately 29 metres east of the property boundary of No. 2 Bull Street and No. 6 Market Square east for approx 6.6 metres, parallel to the kerb.

Market Square: The southern side of the central area, from a point 7 metres east of a projected line from the eastern flank wall of the Library / Police Office, Market Square, east for approx 3.6 metres, at right angles to the kerb.

The two existing parking places located in the central area of Market Square, one at the western end (3.5 metres wide) and one at the eastern end (2.5 metres wide) shall be revoked.

The days and hours of operation of these parking places will be unrestricted for disabled person's vehicles.

The creation of these parking places is considered necessary to enable a disabled person to park at a convenient location close to local amenities.

<u>Date of Operation:</u> The Order will come into operation on the 9th February 2009.

<u>Further Details</u> of the Order and a plan showing the lengths of road affected may be examined during normal office hours at County Hall, Bedford and normal opening times at Potton Library, Clock House, Potton.

<u>High Court Challenge:</u> Any person who desires to question the validity of the Order or of any provision contained therein on the ground that it is not within the powers of the relevant Section of the Road Traffic Regulation Act 1984 or on the ground that any requirement of that Section had not been complied with in relation to the Order may, within six weeks of the 6th February 2009 make application for the purpose to the High Court.

The Bedfordshire County Council (the "Council") in exercise of the powers under sections 1(1), 2(1) to (3), 4 (2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("The Act") and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of schedule 9 to the Act, hereby makes the following Order:-

- This Order shall come into operation on the 9th day of February 2009 and may be cited as "Bedfordshire County Council (District of Mid Bedfordshire) (Civil Enforcement Area and Special Enforcement Area) (Waiting Restrictions and Street Parking Places) (Consolidation) (Variation No 3) Order 200*"
- 2. As from the date upon which this Order comes into operation, the provisions of the "Bedfordshire County Council (District of Mid Bedfordshire) (Civil Enforcement Area and Special Enforcement Area) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2008" shall be varied as follows:-
 - (i) The plan schedule reference "Area Code BN 30: Sheet Revision Number 1" shall be deleted and "Area Code BN 30: Sheet Revision No 2" shall be substituted.
 - (ii) The plan schedule reference "Area Code BO 30: Sheet Revision Number − 2" shall be deleted and "Area Code BO 30: Sheet Revision No − 3" shall be substituted.
