(i) The plan schedule reference "Area Code BI 49: Sheet Revision Number – 1" shall be deleted from the plans attached to the Order and plan schedule reference "Area Code BI 49: Sheet Revision Number – 2" shall be substituted.

(ii) The plan schedule reference "Area Code BI 50: Sheet Revision Number – 1" shall be added to the plans attached to the Order

(ii) The plan schedule reference "Area Code N 84: Sheet Number 1" shall be added to the plans attached to the Order.

(iv) The plan schedule reference "Area Code N 85: Sheet Number 1" shall be added to the plans attached to the Order.

Date of Operation: The Order will come into operation on the 19th April 2010.

<u>High Court Challenge:</u> Any person who desires to question the validity of the Order or of any provision contained therein on the ground that it is not within the powers of the relevant Section of the Road Traffic Regulation Act 1984 or on the ground that any requirement of that Section had not been complied with in relation to the Order may, within six weeks of the 18th April 2010 make application for the purpose to the High Court.
