(VARIATION NO 13) ORDER 2011

The Central Bedfordshire Council (the “Council”) in exercise of the powers under sections 1(1), 2(1) to (3), 4 (2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (“The Act”) and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of schedule 9 to the Act, hereby makes the following Order:

1. This Order shall come into operation on 7th day of March 2011 and may be cited as “Central Bedfordshire Council (Bedfordshire County Council (District of South Bedfordshire) (Civil Enforcement Area and Special Enforcement Area) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2008) (Variation No 13) Order 2011”
2. As from the date upon which this Order comes into operation, the provisions of the “Bedfordshire County Council (District of South Bedfordshire) (Civil Enforcement Area and Special Enforcement Area) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2008” shall be varied as follows:-
 - (i) The plan schedule reference “Area Code Y139: Sheet Revision Number – 3” shall be deleted from the plans attached to the Order and “Area Code Y139: Sheet Revision Number – 4” shall be substituted.
 - (ii) The plan schedule reference “Area Code Y140: Sheet Revision Number – 3” shall be deleted from the plans attached to the Order and “Area Code Y140: Sheet Revision Number – 4” shall be substituted.

On the 25th February 2011 Central Bedfordshire Council made a Road Traffic Regulation Order as follows:

Effect of the Order:

This Variation Order, following an Experimental Order, introduces No Loading and Unloading on the existing no waiting at any time restrictions listed below and a Loading Bay with an exemption for vehicles displaying a permit

A. To introduce no loading and unloading on the existing no waiting at any time restriction at St Marys Gate Service Road, Dunstable: North side, from a point 18 metres south west of the property boundary between Nos 17 and 19 West Street generally south west for 70 metres.

B. To introduce a Goods Vehicle Loading Bay for Permit Holders at St Marys Gate Service Road, Dunstable: North side, from a point level with the property boundary between Nos 17 and 19 West Street south west for 18 metres.

Date of Operation: The Order will come into operation on the 7th March 2011.

Further Details of the Order and a plan showing the lengths of road affected may be examined during normal opening hours at Dunstable Library, Vernon Place Dunstable LU5 4HA.

High Court Challenge: Any person who desires to question the validity of the Order or of any provision contained therein on the ground that it is not within the powers of the relevant Section of the Road Traffic Regulation Act 1984 or on the ground that any requirement of that Section had not been complied with in relation to the Order may, within six weeks of the 25th February 2011 make application for the purpose to the High Court.
