The Central Bedfordshire Council (the "Council") in exercise of its powers under sections 1(1), 2(1) to (3), 4 (2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("The Act") and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of schedule 9 to the Act, hereby makes the following Order:

1. This Order shall come into operation on 27th day of June 2019 and may be cited as "Central Bedfordshire Council (Bedfordshire County Council (District of Mid Bedfordshire) (Civil Enforcement Area and Special Enforcement Area) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2008) (Variation No.70) Order 2019"
2. As from the date upon which this Order comes into operation, the provisions of the "Bedfordshire County Council (District of Mid Bedfordshire) (Civil Enforcement Area and Special Enforcement Area) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2008" shall be varied as follows:-

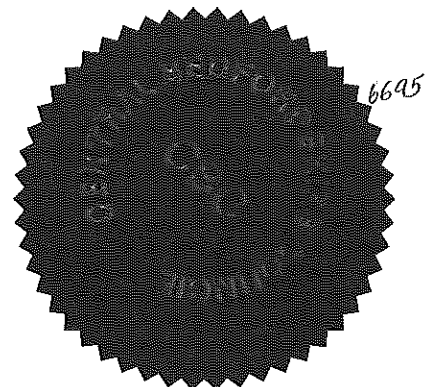
To add No Waiting at any time on the following lengths of road in Woburn:-

- (i) Outside no.26 Timber lane, in line with its eastern boundary extending approximately 9.6m in an easterly direction around its junction with Timber Lane.
- (ii) Outside no.41 Timber Lane, in line with the western boundary extending approximately 9.2m in a westerly direction around the around its junction with Timber Lane.
- (iii) Outside no.42 Timber Lane, 5m in a southwest wards direction from the access road to Timber lane extending approximately 40m in an easterly direction tying in with the access road.
- (iv) From the junction of Timber lane and Leighton street extending approximately 74m in a northerly direction tying in with the access road.
- (v) From the eastern boundary line of no.5 Timber Lane in a south eastern direction to its junction with Leighton street.
- (vi) Opposite the western boundary line of no.38 Leighton Street 15m in an eastern direction towards the junction.
- (vii) Outside the western boundary line of no.16 Leighton street 15m in a western direction towards the junction.
