(CONSOLIDATION) ORDER 2008) (VARIATION NO.67) ORDER 2019

The Central Bedfordshire Council (the "Council") in exercise of its powers under sections 1(1), 2(1) to (3), 4 (2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("The Act") and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of schedule 9 to the Act, hereby makes the following Order:

- 1. This Order shall come into operation on 18th day of April 2019 and may be cited as "Central Bedfordshire Council (Bedfordshire County Council (District of Mid Bedfordshire) (Civil Enforcement Area and Special Enforcement Area) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2008) (Variation No.67) Order 2019
- 2. As from the date upon which this Order comes into operation, the provisions of the "Bedfordshire County Council (District of Mid Bedfordshire) (Civil Enforcement Area and Special Enforcement Area) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2008" shall be varied as follows:-

To add No Waiting at any time on the following lengths of road in Flitwick:-

- (i) Billington Close, both sides, from its junction with Steppingley Road extending in a northerly direction to a point in line with the south flank wall of no.22 Billington Close.
- (ii) Chapel Road, east side, from a point approximately 1 metre south of a point in line with the north flank wall of no.13 Chapel Road extending in a northerly direction for approximately 20 metres.
- (iii) The Thinnings, both sides, from its junction with Chapel Road extending in an easterly direction to a point in line with the west flank wall of no.13 Chapel Road.

To add No Waiting Monday to Friday 10am to 11am on the following lengths of road in Flitwick:-

- (i) Chapel Road, west side, from a point approximately 4 metres north of a point in line with the south flank wall of no.46 Steppingley Road extending in a northerly direction to its junction with Windmill Road.
- (ii) The Thinnings, south side, from a point in line with the west flank wall of no.13 Chapel Road extending in an easterly direction for its full length.

To add No Waiting Monday to Friday 2pm to 3pm on the following lengths of road in Flitwick:-

- (i) Chapel Road, east side, from a point approximately 4 metres north of a point in line with the south flank wall of no.46 Steppingley Road extending in a northerly direction to a point approximately 1 metre south of a point in line with the north flank wall of no.13 Chapel Road.
- (ii) The Thinnings, north side, from a point in line with the west flank wall of no.13 Chapel Road extending in an easterly direction for its full length.
