The Central Bedfordshire Council (the "Council") in exercise of its powers under sections 1(1), 2(1) to (3), 4 (2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("The Act") and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of schedule 9 to the Act, hereby makes the following Order:

- 1. This Order shall come into operation on 17th day of February and may be cited as "Central Bedfordshire Council (Bedfordshire County Council (District of Mid Bedfordshire) (Civil Enforcement Area and Special Enforcement Area) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2008) (Variation No.4) Order 2020"
- 2. As from the date upon which this Order comes into operation, the provisions of the "Bedfordshire County Council (District of Mid Bedfordshire) (Civil Enforcement Area and Special Enforcement Area) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2008" shall be varied as follows:-

To add No Waiting at any time on the following lengths of road in Harlington

- (i) Park Leys, north side, extending in south-western direction from its Junction at Sundon Road to a point 2m past the Gas Governor structure
- (ii) Park Leys, south side, extending in a south-western direction from its junction at Sundon Road to the entrance at number 78 Park Leys.
- (iii) Pilgrims Close, west side, extending from its junction with Park Leys for approximately 10m.
- (iv)Pilgrims Close, east side, extending from its junction with Park Leys for approximately 10m.
- (v) Valiant Close, south side, extending from its junction with Park Leys for approximately 10m.
- (vi)Valiant Close, north side, extending from its junction with Park Leys for approximately 10m.
- (vii) Prudence Close, south side, extending from its junction with Park Leys for approximately 10m.
- (viii) Prudence Close, north side, extending from its junction with Park Leys for approximately 10m.

- (ix)Christian Close, south side, extending from its junction with Park Leys for approximately 10m.
- (x) Christian Close, north side, extending from its junction with Park Leys for approximately 10m.
- (xi)Shepherds Close, south side, extending from its junction with Park Leys for approximately 10m.
- (xii) Shepherds Close, north side, extending from its junction with Park Leys for approximately 10m.
- (xiii) Oak Close, south side, extending from its junction with Park Leys for approximately 10m.
- (xiv)Oak Close, north side, extending from its junction with Park Leys for approximately 10m.
 - (xv) Park Leys, west side, extending north from its junction with Oak End for approximately 10m.
