The Central Bedfordshire Council (the "Council") in exercise of its powers under sections 1(1), 2(1) to (3), 4 (2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("The Act") and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of schedule 9 to the Act, hereby makes the following Order:

1. This Order shall come into operation on 6<sup>th</sup> May 2019 and may be cited as "Central Bedfordshire Council (Bedfordshire County Council (District of Mid Bedfordshire) (Civil Enforcement Area and Special Enforcement Area) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2008) (Variation No.64) Order 2019"
2. As from the date upon which this Order comes into operation, the provisions of the "Bedfordshire County Council (District of Mid Bedfordshire) (Civil Enforcement Area and Special Enforcement Area) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2008" shall be varied as follows:-

To add No Waiting at any time on the following length of road in Biggleswade:-

- (i) Mead End, west side, from a point in line with the boundary of nos.113 and 115 extending in a southerly direction to a point in line with the north flank wall of no.131 Mead End.
- (ii) Mead End, east side, from a point in line with the boundary of nos.125 and 127 extending in a southerly direction to a point approximately 4 metres south of the north flank wall of no.141 Mead End.
- (iii) Mead End, west side, from a point approximately 1 metre north of the boundary of nos.139 and 141 extending in a southerly direction to a point approximately 5 metres south of the boundary of no.71 Oak Crescent and no.108 Mead End.
- (iv) Oak Crescent, both sides, from it's junction with Mead End extending in a westerly direction to a point in line with the boundary of no.56 Oak Crescent and no.106 Mead End.

To add No Waiting Monday to Friday from 8am to 4.30pm on the following lengths of road in Biggleswade:-

- (i) Holme Court Avenue, both sides, from a point in line with the boundary of nos.167 and 169 Holme Court Avenue extending in a southerly direction to a point in line with the north boundary of no.124 Holme Court Avenue Road.
- (ii) Kitelands Road western spur, both sides, from it's junction with Kitelands Road extending in an westerly direction to a point in line with the west flank wall of no.10 Kitelands Road and connecting at the turning head of the cul-de-sac.
