(OFF-STREET PARKING PLACES) (VARIATION) ORDER 2014

CENTRAL BEDFORDSHIRE COUNCIL in exercise of their powers under Sections 32, 33, 35, 35A and 35C and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act") and of all other enabling powers, after consultation with the Chief Officer of Police for the County of Bedfordshire in accordance with Part III of Schedule 9 to the Act hereby direct as follows:

1. This Order may be cited as "Central Bedfordshire Council (Off-Street Parking Places) (Variation) Order 2014" and shall come into operation on the 18th day of April 2014.
2. As from the date upon which this Order comes into operation, the provisions of the "Central Bedfordshire Council (Off-Street Parking Places) Order 2011" shall be varied as follows:-
 - (i) The following shall be added to Schedule 6 – Other Sites

Steppingley Road Car Park, Flitwick (see plan 15)	a) Motor cars, the overall height of which does not exceed 2.1 metres b) Motor cycles	Wholly within a marked bay, subject to the provisions of Article 3(b)	All days All hours	No limit. No parking is permitted at any time on double yellow lines. (Article 3(g))	Monday to Friday £5 per day Saturday and Sunday £1 per day Disabled person's badge holder (designated bays only) £nil
