
**CEREDIGION COUNTY COUNCIL (PROHIBITION AND RESTRICTION OF WAITING AND  
LOADING AND UNLOADING) ORDER 2019  
(Y LANFA, ABERYSTWYTH) (AMENDMENT ORDER NO. 3) 2021**

Ceredigion County Council (hereinafter referred to as “the Council”) in exercise of its powers under Sections 1, 2, 3, 4, 19, 32, 35, 45, 46, 47,49, 53 and 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 as amended, and the Traffic Management Act 2004 and of all other enabling powers, and after consultation with the Chief Officer of Police, in accordance with Part III of Schedule 9 of the 1984 Act, hereby makes the following Order.

1. This Order may be cited as “Ceredigion County Council (Prohibition and Restriction of Waiting and Loading and Unloading) Order 2019 (Y Lanfa, Aberystwyth) (Amendment Order No. 3) 2021” and shall come into operation on the 30th day of June 2021.
2. The effect of this order shall be to amend the Ceredigion County Council (Prohibition and Restriction of Waiting and Loading and Unloading) Order 2019 by the revocation of the plans specified in Column A of Schedule 1 to this Order and the insertion of the plans specified in Column B of Schedule 1 to this Order.
3. If a court, the Welsh Government, the Traffic Penalties Tribunal or the Traffic Enforcement Centre declares any part of this Order to be invalid or unenforceable; such declaration shall not invalidate the remainder of the Order.

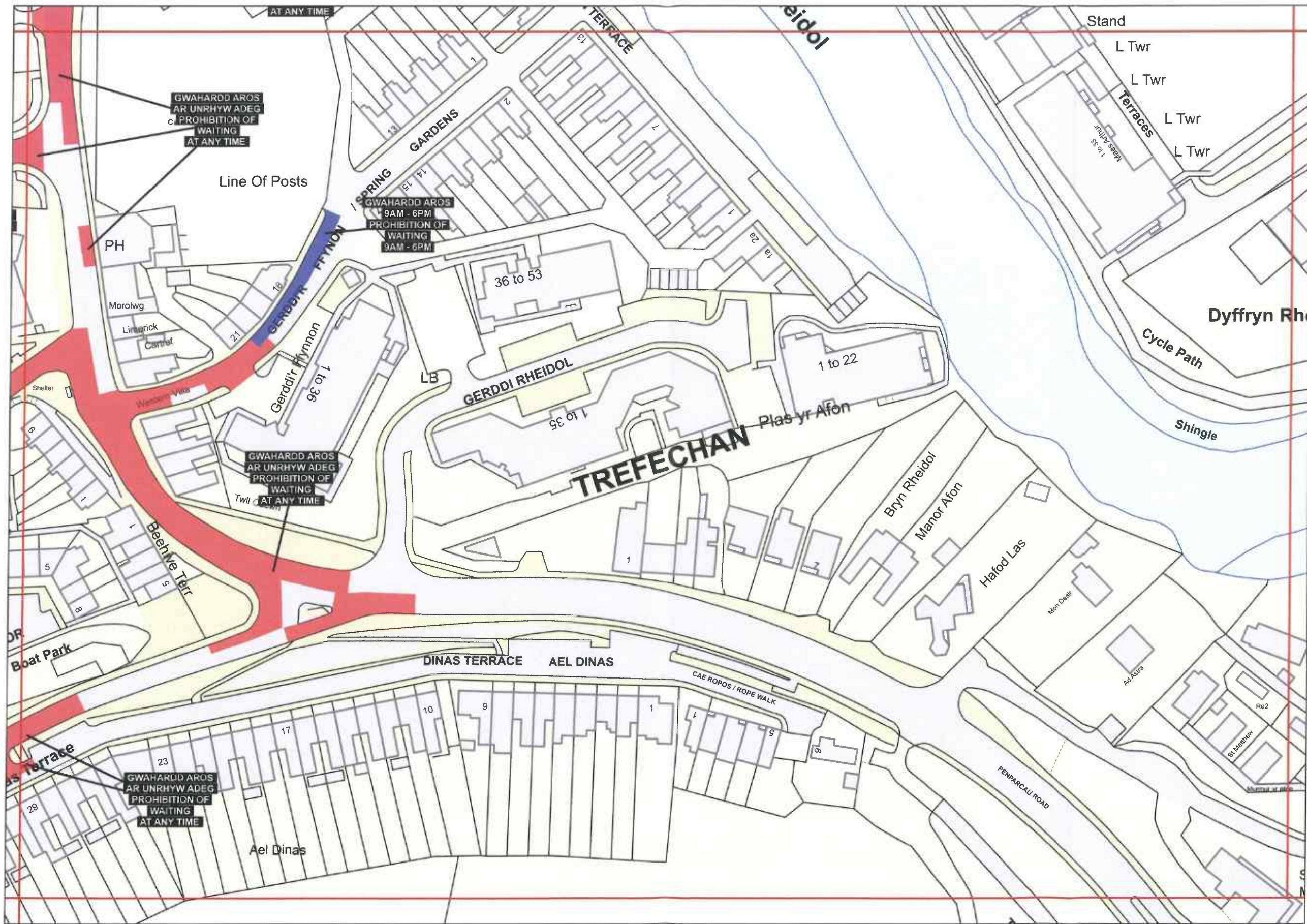

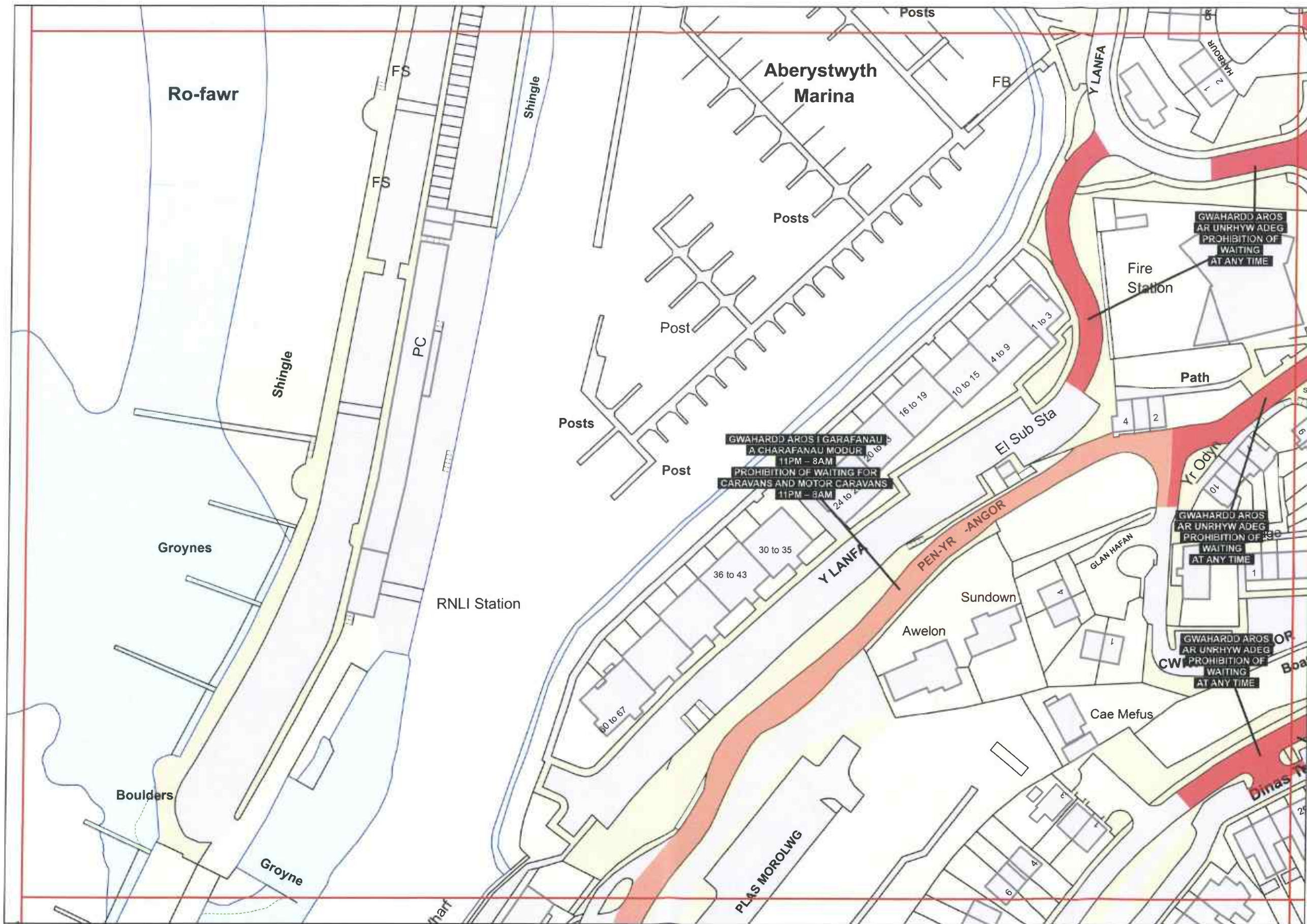
