

THE ESSEX COUNTY COUNCIL (BOROUGH OF CHELMSFORD)
(WAITING, LOADING AND PARKING CONSOLIDATION)
(VARIATION NO.6) ORDER 2012

The Essex County Council in exercise of its powers under Sections 1(1), 2(1) to (3), 4(1) & (2), 32(1), 35(1) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act, hereby make the following Order:-

- 1: This Order shall come into operation for all purposes on the 17 September 2012 and may be cited as The Essex County Council (Borough of Chelmsford) (Waiting, Loading and Parking Consolidation) (Variation No.6) Order 2012.

2. With effect from the date set out in Article 1 of this Order, The Borough Council of Chelmsford (Waiting, Loading and Parking Consolidation) Order 2009, "the 2009 Consolidation Order" as varied shall have effect as though in Schedule 3 to that Order ("Waiting, Stopping, Loading and Unloading Restrictions") –
 - (i) the references to those roads or parts of roads already in that Schedule and indicated in Schedule A to this Order were deleted and the references in Schedule A to this Order were substituted therefor; and

 - (ii) the references to those roads or parts of roads not already included in that Schedule and indicated in Schedule A to this Order were inserted therein.

5. With effect from the date set out in Article 1 of this Order, the 2009 Consolidation Order as varied shall have effect as though in Schedule 9 to that Order ("Limited Waiting Parking Places") –
 - (i) the references to those roads or parts of roads already in that Schedule and indicated in Schedule B to this Order were deleted and the references in Schedule C to this Order were inserted therein.
