

The Essex County Council (Borough of Chelmsford) (Waiting, Loading and Parking Consolidation) (Variation No.7) Order 2013

The Essex County Council in exercise of its powers under Sections 1(1), 2(1) to (3), 3(2), 4(1), 4(2), 32(1), 35(1), 45, 46, 49, 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act, hereby make the following Order:-

1. This Order shall come into operation for all purposes on the twenty-sixth day of June 2013 and may be cited as The Essex County Council (Borough of Chelmsford) (Waiting, Loading and Parking Consolidation) (Variation No.7) Order 2013.

3. With effect from the date set out in Article 1 of this Order, The Borough Council of Chelmsford (Waiting, Loading and Parking Consolidation) Order 2009, "the 2009 Consolidation Order" as varied shall have effect as though in Schedule 7 to that Order ("Disabled Parking Places") –
 - (i) the references to those roads or parts of roads already in that Schedule and indicated in Schedule A to this Order were deleted and the references in Schedule A to this Order were substituted therefor; and

 - (ii) the references to those or parts of roads not already included in that Schedule and indicated in Schedule A to this Order were inserted therein.


4. With effect from the date set out in Article 1 of this Order, the 2009 Consolidation Order as varied shall have effect as though in Schedule 4 to that Order ("Permit Parking Places") –
 - (i) the references to those roads or parts of roads already in that Schedule and indicated in Schedule B to this Order were deleted

and the references in Schedule B to this Order were substituted therefor; and

- (ii) the references to those roads or parts of roads not already included in that Schedule and indicated in Schedule B to this Order were inserted therein.

Back Lane, Pleshey	North side, from a point 20 metres east of its junction with Woolmers Mead, east for a distance of 7.0 metres.
Upper Bridge Road	West side, from a point 45 metres north of its junction with Cherry Garden Lane north for a distance of approximately 6.0 metres.
Woolmers Mead, Pleshey	North side, from a point 80 metres west of its junction with Back Lane, west for a distance of 7.0 metres.

Prykes Drive	North-east side, from a point 0.6 metres south-east of the eastern property wall of No's 32 & 33 Prykes Drive, northwest for a distance of 5.0 metres.
