

THE SOUTH ESSEX PARKING PARTNERSHIP
(CHELMSFORD CITY COUNCIL)
(WAITING, LOADING AND PARKING CONSOLIDATION)
(VARIATION NO.36) ORDER 2015

The Chelmsford City Council acting on behalf of the South Essex Parking Partnership in exercise of the delegated powers of the traffic authority Essex County Council granted under an agreement dated 31 March 2011 (and subsequently varied by Deed of Variation on 15 June 2011 and 27 July 2012) and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") hereby makes the following Order under Sections 1(1), 2(1) to (3), 4(1) 4(2), 32(1), 35(1), 45, 46, 49, 53 and Parts III and Part IV of Schedule 9 of the Act and of all other enabling powers.

1. This Order shall come into operation for all purposes on the 9th day of November 2015 and may be cited as The South Essex Parking Partnership (Chelmsford City Council) (Waiting, Loading and Parking Consolidation) (Variation No.36) Order 2015.
2. With effect from the date set out in Article 1 above, The Borough Council of Chelmsford (Waiting, Loading and Parking Consolidation) Order 2009 ("the 2009 Consolidation Order") shall have effect as though in Schedule 3 to that Order ("Waiting, Stopping, Loading and Unloading Restrictions") the references to those roads indicated in the Schedule to this Order were inserted therein.

Added to Schedule 3 to the 2009 Consolidation Order

(Waiting, Stopping, Loading and Unloading Restrictions)

LOCATION	RESTRICTION	EXTENT
Winsford Way Boreham	No Waiting At Any Time	North east side from its junction with Sheepcotes in a north-westerly direction for a distance of 113 metres.
Oliver Way Chelmsford	No Waiting At Any Time	Both sides from its junction with Partridge Avenue in a westerly direction for a distance of 30 metres.
Oliver Way Chelmsford	No Waiting At Any Time	South west side from a point 15 metres northwest of its junction with Tapley Road in a south easterly direction for a distance of 36 metres.
Oliver Way Chelmsford	No Stopping On Entrance Markings Mon-Fri 8am-9.30am & 2.30pm-4pm	South side from a point 110 metres west of its junction with Partridge Avenue in an easterly direction for a distance of 25.56 metres.
Tapley Road Chelmsford	No Waiting At Any Time	Both sides from its junction with Oliver Way in a south-westerly direction for a distance of 10 metres.
Partridge Avenue Chelmsford	No Waiting At any time	North west side from its junction with Oliver Way in a south westerly direction for a distance of 50 metres.
Partridge Avenue Chelmsford	No Waiting At any time	South east side from its junction with Oliver Way in a south westerly direction to a point 5 metres south west of the north eastern building wall of property No. 23 Partridge Avenue.

Partridge Avenue Chelmsford	No Stopping On Entrance Markings Mon-Fri 8am-9.30am & 2.30pm-4pm	North side from a point 9.2 metres east of the boundary between the school and property No. 1 Partridge Avenue in a westerly direction for a distance of 31.56 metres.
