

**The Essex County Council (City of Chelmsford) (Waiting, Loading and Parking Consolidation) (Variation No.41) Order 2015**

The Essex County Council in exercise of its powers under Sections 1(1), 2(1) to (3), 3(2), 4(1), 4(2), 32(1), 35(1), 45, 46, 49, 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Parts III and IV of Schedule 9 of the Act, hereby make the following Order:-

1. This Order shall come into operation for all purposes on 2 November 2015 and may be cited as The Essex County Council (City of Chelmsford) (Waiting, Loading and Parking Consolidation) (Variation No.41) Order 201\*.
2. With effect from the date set out in Article 1 of this Order, The Borough Council of Chelmsford (Waiting, Loading and Parking Consolidation) Order 2009, "the 2009 Consolidation Order" as varied shall have effect as though in Schedule 3 to that Order ("Waiting, Stopping, Loading and Unloading Restrictions") –
  - (i) The references to those roads or parts of roads already in that Schedule and indicated in Schedule A to this Order were deleted and the references in Schedule A to this Order were substituted therefor; and
  - (ii) The references to those or parts of roads not already included in that Schedule and indicated in Schedule A to this Order were inserted therein.

### Schedule 3

To introduce the following waiting restrictions in the lengths of road specified below in the City of Chelmsford:

LOCATION	RESTRICTION	EXTENT
Access Road leading to Hedgerows Business Park, Springfield	No Waiting At Any Time	BOTH SIDES: From its junction with B1137 Colchester Road/Springfield Lyons Approach roundabout, in a generally north westerly direction for a distance of approximately 18 metres.
B1137 Colchester Road, Springfield	No Waiting At Any Time	<p>NORTH WEST SIDE: From its junction with B1137 Springfield Road/A138 Eastern Approach/ Cuton Hall Lane roundabout, in a generally north-easterly direction, for its entire length to its junction with A130 White Hart Lane/ A130 Colchester Road roundabout.</p> <p>SOUTH EAST SIDE:</p> <ul style="list-style-type: none"> <li>i. From its junction with B1137 Springfield Road/A138 Eastern Approach/ Cuton Hall Lane roundabout, in a generally north-easterly direction, for approximately 381 metres.</li> <li>ii. From its junction with A130 White Hart Lane/A130 Colchester Road roundabout, in a generally south-westerly direction, for approximately 89 metres.</li> </ul>
B1137 Colchester Road, Springfield	No Waiting Mon-Sat 8am-6pm	SOUTH EAST SIDE: From a point approximately 89 metres from its junction with A130 White Hart Lane/A130 Colchester Road roundabout in a generally south-westerly direction, for approximately 62 metres.
