

THE ESSEX COUNTY COUNCIL (CHELMSFORD CITY) (PROHIBITION OF WAITING, LOADING AND STOPPING) AND (ON-STREET PARKING PLACES) (CIVIL ENFORCEMENT AREA) (AMENDMENT NO. 22) ORDER 2021

NOTICE IS HEREBY GIVEN that Chelmsford City Council acting on behalf of the South Essex Parking Partnership in exercise of the delegated powers of the traffic authority Essex County Council granted under an agreement dated 31 March 2011 (and subsequently varied by Deed of Variation on 15 June 2011 and 27 July 2012) has made the above Order under Sections 1(1), 2 (1) to (3), 4(1), 4(2), 32(1), 35(1), 45, 46, 49, 53 and Parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984.

Effect of the Order:

All measurements are taken as accurately as possible and are taken from the extended kerb line unless stated otherwise.

- To introduce a '24-hour Rural Clearway, including the footway and verge' on the following lengths of roads in the City of Chelmsford.**

Southend Road, Rettendon Common (including the eastern service road)	Both sides: from a point 89 metres southeast of its junction with Old Barn Lane south-eastwards to where Southend Road becomes Main Road, including the eastern service road.
Main Road, Rettendon Common (including the eastern service road)	Both sides: from where Southend Road becomes Main Road south-eastwards to a point 93 metres northwest of its junction with Hoe Lane, including the eastern service road but not the western service road.
South Hanningfield Road, Rettendon Common	Both sides: from a point 275 metres southwest of its junction with Main Road north-eastwards to its junction with Main Road.

This Order will be incorporated into The Essex County Council (Chelmsford City Council) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) Consolidation Order 2019 by creating tile numbers TQ760 980 Rev 0, TQ760 982 Rev 0, TQ760 985 Rev 0, TQ760 987 Rev 0, TQ765 970 Rev 0, TQ765 972 Rev 0 and TQ765 975 Rev 0 and substituting tile numbers TQ760 972 Rev 0 to Rev 1, TQ760 975 Rev 0 to Rev 1, TQ760 977 Rev 0 to Rev 1.

This Order will come into effect on **12 April 2021** and will be incorporated into the relevant Schedules to the Essex County Council (Chelmsford City) (Prohibition of Waiting, Loading and Stopping) and (On-street Parking Places) (Civil Enforcement Area) Consolidation Order 2019.

If you wish to question the validity of the Order or any provisions contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act, or of any instrument made under it, has not been complied with in relation to the Order, you may apply within 6 weeks from the date the Order was made, apply to the High Court for this purpose.

1. This Order shall come into operation for all purposes on the 12th day of April 2021 and may be cited as The Essex County Council (Chelmsford City) (Prohibition of Waiting, Loading and Stopping) and (On-street Parking places) (Civil Enforcement Area) (Amendment No.22) Order 2021.
