

THE ESSEX COUNTY COUNCIL (CHELMSFORD CITY) (PROHIBITION OF WAITING, LOADING AND STOPPING) AND (ON-STREET PARKING PLACES) (CIVIL ENFORCEMENT AREA) (AMENDMENT NO. 35) ORDER 2023

NOTICE IS HEREBY GIVEN that Chelmsford City Council acting on behalf of the South Essex Parking Partnership in exercise of the delegated powers of the traffic authority Essex County Council granted under an Agreement dated 30 June 2022 has made the above Order under Sections 1(1), 2(1) to (3), 4(1), 4(2), 32, 35, 45, 46, 49 and 53 and Parts III and IV of schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers.

Effect of the Order: To introduce further parking restrictions on the following length of road in the City of Chelmsford as specified below.

1. To add 'No Stopping on Verge or Footway' to the existing Clearway on the following length of road in the City of Chelmsford:

Princes Road, Chelmsford	Both sides - from the roundabout with Wood Street and Moulsham Street eastwards and then north-eastwards to the roundabout with Waterson Vale and Fortinbras Way. TILES: TL700 052, TL705 052, TL705 055 & TL710 055
