

THE ESSEX COUNTY COUNCIL (CHELMSFORD CITY) (PROHIBITION OF WAITING, LOADING AND STOPPING) AND (ON-STREET PARKING PLACES) (CIVIL ENFORCEMENT AREA) (AMENDMENT NO. 51) ORDER 2023

NOTICE IS HEREBY GIVEN that Chelmsford City Council acting on behalf of the South Essex Parking Partnership in exercise of the delegated powers of the traffic authority Essex County Council granted under an Agreement dated 30 June 2022 has made the above Order under Sections 1(1), 2(1) to (3), 4(1), 4(2), 32, 35, 45, 46, 49 and 53 and Parts III and IV of schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers.

Effect of the Order: To revoke and introduce parking restrictions on the following lengths of road in the City of Chelmsford as specified below.

- 1. To revoke all parking restrictions in the service area of Barrack Square located to the rear of Nos.51-66 High Street and north of Stonebridge Walk and implement 'No Waiting at Any Time' within the whole of the above service area, which covers the public highway. TILE: TL705 065 Rev 1 to Rev 2
- 2. This Order will be incorporated into The Essex County Council (Chelmsford City) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) Consolidation Order 2019 by substituting tile number TL705 065 Rev 1 to Rev 2.

This Order will come into effect on 22nd May 2023 and will be incorporated into the relevant Schedules to the Essex County Council (Chelmsford City) (Prohibition of Waiting, Loading and Stopping) and (On-street Parking Places) (Civil Enforcement Area) Consolidation Order 2019. If you wish to question the validity of the Order or any provisions contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act, or of any instrument made under it, has not been complied with in relation to the Order, you may apply within 6 weeks from the date the Order was made, apply to the High Court for this purpose.
