NOTICE IS HEREBY GIVEN that Chelmsford City Council acting on behalf of the South Essex Parking Partnership in exercise of the delegated powers of the traffic authority Essex County Council granted under an Agreement dated 30 June 2022 has made the above Order under Sections 1(1), 2(1) to (3), 4(1), 4(2), 32, 35, 45, 46, 49 and 53 and Parts III and IV of schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers.

Effect of the Order: To introduce or amend parking restrictions on the following lengths of road in the City of Chelmsford as specified below. All measurements are approximate and are taken from the extended kerb line unless stated otherwise.

#### 1. To introduce 'No Waiting at Any Time':

Nickleby Road,	Both sides – from its junction with Copperfield Road south-eastwards for 15 metres.
Chelmsford	Southwest side - from a point 10 metres northwest of its junction with Pickwick Avenue south-
