

**THE ESSEX COUNTY COUNCIL (CHELMSFORD CITY)  
(PROHIBITION OF WAITING, LOADING AND STOPPING) AND  
(ON-STREET PARKING PLACES) (CIVIL ENFORCEMENT AREA)  
(AMENDMENT NO. 60) ORDER 2025**

**NOTICE IS HEREBY GIVEN** that Chelmsford City Council acting on behalf of the South Essex Parking Partnership in exercise of the delegated powers of the traffic authority Essex County Council granted under an Agreement dated 30 June 2022 has made the above Order under Sections 1(1), 2(1) to (3), 4(1), 4(2), 32, 35, 45, 46, 49 and 53 and Parts III and IV of schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers.

**Effect of the Order:** To introduce parking restrictions on the following lengths of roads in the City of Chelmsford as specified below.

**1. To introduce a 'Resident Permit Parking Area 8am-10am & 2pm-4pm Zone 25 except in signed bay' on the following lengths of roads in the City of Chelmsford:**

Beaulieu Boulevard, Shardelow Avenue, Burnell Gate, Frances Green, Wharton Drive, Billers Chase, Sidney Place, Honor Link, Clunford Place, Multon Lea, Anjou Green, Montagu Gardens, Louvain Drive, Braganza Way, Ratcliffe Gate, Fleetwood Square, Albemarle Link, Beaulieu Park, Springfield	<b>Both sides</b> – covering all lengths of the public highway except for the Limited Waiting Bay in Beaulieu Boulevard <b>Map tiles</b> – TL725 090, TL725 092, TL725 095, TL725 097, TL730 087, TL730 090, TL730 092, TL730 095 & TL730 097
<b>Oak Lodge Tye, Springfield</b>	<b>Both sides</b> – from a point 20 metres southwest of its junction with White Hart Lane covering all lengths of the public highway. <b>Map tiles</b> - TL730 087 & TL730 090

**2. To introduce within the Resident Permit Parking Area 'Limited Waiting 2 hours No return 4 hours' on the following length of road in the City of Chelmsford:**

Beaulieu Boulevard, Beaulieu Park	<b>Northwest side</b> – from a point 20 metres southwest of its junction with Montagu Gardens south-westwards for 20 metres. <b>Map tile</b> - TL730 090

**Application to the High Court:** Anyone who wishes to question the validity of the Order, or any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act, or any instrument made under it, has not been complied with in relation to the Order, may within six weeks from the making of the Order apply to the High Court for this purpose.
