

CHESHIRE COUNTY COUNCIL
(PROHIBITION AND RESTRICTION OF WAITING AND
STREET PARKING PLACES)
(CHESTER AREA)
(CONSOLIDATION) ORDER 2008

The Cheshire County Council (hereinafter referred to as "the Council") in exercise of the powers conferred by Sections 1(1), 2(1) to (3), 4(2), 32, 35, 45, 46, 49, 53, 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the 1984 Act"), Part 6 of the Traffic Management Act 2004 (hereinafter referred to as "the 2004 Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, hereby makes the following Order:-

PART I

CITATION AND INTERPRETATION

1. This Order shall come into operation on 8 January 2009 and may be cited as the Cheshire County Council (Prohibition and Restriction of Waiting and Street Parking Places) (Chester Area) (Consolidation) Order 2008.

2. In this Order-

"the 2007 Regulations" means The Civil Enforcement of Parking Contraventions (England) General Regulations 2007;

"carriageway" means that part of the highway which is intended for the passage of vehicular traffic but excludes a lay-by;

"central reservation" means that part of the highway which separates two carriageways for the safety and guidance of vehicular traffic using that

road;

“civil enforcement officer” means a person employed in accordance with section 76 of the 2004 Act to enforce the prohibitions, restrictions and regulations imposed by this Order. For the time being and as appropriate the term civil enforcement officer also means a person authorised by or on behalf of the Council as a parking attendant under the 1984 Act;

“clearway restriction” means any length of road whether carriageway or central reservation specified on the plans as ‘Clearway’;

“disabled person” and “disabled person’s badge” has the same meaning as in the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000;

“disabled persons’ parking place” means any length of road specified on the plans as ‘Disabled Parking’;

“disabled person’s vehicle” has the same meaning as in Section 142 of the 1984 Act;

“driver” in relation to a vehicle waiting in a parking place or length of road, means the person driving the vehicle at the time it was left in that parking place or length of road;

“enforcement authority” has the same meaning as in section 74 and schedule 8 of the 2004 Act;

“hackney carriage” means a vehicle licensed under Section 37 of The Town Police Clauses Act 1847 or under any similar enactment;

“keep clear zone” means any length of road which is identified by a road marking to diagram 1027.1 in Schedule 6 of the Traffic Signs Regulations and General Directions 2002 and specified on the plans as ‘No Stopping’;

“loading bay” means any length of road specified on the plans as ‘Goods Loading/Unloading’.

“motor vehicle” has the same meaning as the definition used in The Road Vehicles (Construction and Use) Regulations 1986;

“owner” in relation to a vehicle includes any person who, by virtue of regulation 5 of the 2007 Regulations, falls to be treated as the owner of the vehicle;

“parking disc” has the same meaning as in the Local Authorities’ Traffic Orders (Exemptions for Disabled Persons)(England) Regulations 2000;

“penalty charge” means a charge payable in accordance with regulation 4 of the 2007 Regulations and is a charge set by the Council in accordance with The Civil Enforcement of Parking Contraventions (Guidelines on Levels of Charges)(England) Order 2007;

“penalty charge notice” has the same meaning as in regulation 8 of the 2007 Regulations;

“permitted hours” means the periods of time specified for each parking place on the plans during which waiting by specified classes of vehicles is permitted;

“plans” means the plans attached to this Order;

“prohibited road” means any length of road specified on the plans as ‘No Waiting At Any Time’;

“relevant position” in respect of: -

- (a) a disabled person's badge means if it is displayed in the manner prescribed within The Disabled Persons (Badges for Motor Vehicles)(England) Regulations 2000;
- (b) a parking disc has the same meaning as in The Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000; and
- (c) a valid permit means displayed continuously on the windscreen, dashboard or fascia in a conspicuous position on the vehicle so that the whole of the information on the front of the ticket is clearly legible from the outside of the vehicle;

“residents' parking place” means any length of the road specified on the plans as ‘Residents and Designated Parking’;

“restricted hours and days” means in relation to any restricted road, keep clear zone, loading bay or taxi stand, the hours and days during which waiting is prohibited as specified on the plans;

“restricted road” means any length of road specified on the plans as ‘No Waiting’;

“specified class of vehicle” means:

- (a) in the case of a residents' parking place, a motor vehicle displaying in the relevant position a valid permit; and
- (b) in the case of a disabled persons' parking place, a disabled person's vehicle displaying in the relevant position a disabled person's badge

"taxi stand" means any length of road specified on the plans as 'Taxi Stand'.

"traffic sign" means a sign or marking of any size, colour and type prescribed or authorised under, or having effect as though prescribed or authorised under Section 64 of the 1984 Act;

"universal service provider", "provision of universal postal service" and postal packet" shall bear the same meanings as in the Postal Services Act 2000;

"valid permit" means a permit issued by the Council of the City of Chester, with the consent of Cheshire County Council under Section 101 of the Local Government Act 1972 in accordance with a residents' parking scheme agreed between the two authorities following consultation with Cheshire Constabulary

"verge" means any part of the highway which is not carriageway, lay-by or central reservation;

"waiver certificate" means a certificate duly issued by the Council permitting a specified vehicle to wait in specified circumstances on a length or lengths of road where the waiting of that vehicle would otherwise be prohibited or the payment of a charge would otherwise be required.

3. Except where otherwise stated, any reference in this Order to a numbered Article is a reference to the Article bearing that number in this Order and any reference to a plan is a reference to a plan attached to this Order.
4. The prohibitions imposed by this Order shall be in addition to and not in derogation of any restriction, prohibition or requirement imposed by any

Regulations or Orders made or having effect as if made under the 1984 Act, or by or under any other enactment.

5. Save where the contrary is indicated, any reference in this Order to:
- (a) this Order or another Order shall be construed as such a reference to this Order or, as the case may be, such other Order, as the same may have been or may from time to time be amended, varied or supplemented;
 - (b) a Statute or Regulation shall be construed as reference to such Statute or Regulations as the same may have been, or may from time to time be amended or re-enacted.
6. The Interpretation Act 1978 shall apply to the interpretation of this Order as it applies for the interpretation of an Act of Parliament and as if for the purposes of Section 21 of that Act this Order were an Act of Parliament and the Orders revoked by Article 36 were Acts of Parliament thereby repealed.

PART II

PROHIBITION AND RESTRICTION OF WAITING, LOADING AND UNLOADING

PROHIBITION OF WAITING

7. Save as provided in Articles 15, 16 and 18 to this Order no person shall, except upon the direction of or with the permission of a civil enforcement officer or a police constable in uniform, cause or permit any vehicle to wait at any time in (i) any prohibited road; or (ii) on any carriageway or central reservation where a clearway restriction is specified on the plans.

8. No person shall cause or permit any vehicle to wait on any verge immediately adjacent to a carriageway where a clearway restriction is in operation for the purpose of selling goods from that vehicle unless the goods are immediately delivered at or taken into premises adjacent to the vehicle from which the sale is affected.

RESTRICTION OF WAITING

9. Save as provided in Articles 15, 16 and 18 to this Order no person shall, except upon the direction of or with the permission of a civil enforcement officer or a police constable in uniform, cause or permit any vehicle to wait in any restricted road during the restricted hours and days.
10. Save as provided in Articles 15 and 18 to this Order no person shall, except upon the direction of or with the permission of a civil enforcement officer or a police constable in uniform, cause or permit any vehicle to wait in any taxi stand during the restricted hours and days.
11. Save as provided in Articles 15 and 18 to this Order no person shall, except upon the direction of or with the permission of a civil enforcement officer or a police constable in uniform, cause or permit any vehicle to wait in any loading bay during the restricted hours and days.
12. Save as provided in Article 18 to this Order No person shall, except upon the direction of or with the permission of a civil enforcement officer or a police constable in uniform, cause or permit any vehicle to stop in any keep clear zone during the restricted hours and days.
13. Save as provided in Articles 15, 17 and 18 to this Order no person shall, except upon the direction of or with the permission of a civil enforcement officer or a police constable in uniform, cause or permit any vehicle to wait

in the lengths of roads and sides of roads-

- a) in respect of which there is specified on the plans a period in which waiting is allowed, for a period longer than that specified on the plans; or
- b) if a period less than that specified on the plans, as being the period in which the vehicle shall not return, has elapsed since a previous period of waiting by the same vehicle on the same length of road.

RESTRICTION OF LOADING OR UNLOADING

14. No person shall, except upon the direction or with the permission of a civil enforcement officer or a police constable in uniform, cause or permit any vehicle to wait for the purpose of enabling goods to be loaded onto or unloaded from a vehicle on any of the lengths of roads or sides of roads specified on the plans where (i) loading is prohibited during the hours and on the days specified on the plans, or (ii) on a taxi stand during the restricted hours and days.

EXEMPTIONS

15. Nothing in Articles 7, 9, 10, 11 and 13 of this Order shall render it unlawful to cause or permit any vehicle to wait in any of the roads, lengths of road or on the sides of road specified therein for so long as may be necessary to enable:

- (a) except in respect of a taxi stand, a person to board or alight from the vehicle;
- (b) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations, namely:-
 - (i) building, excavation or demolition operations;

- (ii) the removal of any obstruction to traffic;
 - (iii) the maintenance, improvement or reconstruction of the said lengths or sides of road; and
 - (iv) the laying, erection, alteration or repair in or near the said lengths or sides of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus (as defined in the Telecommunications Act 1984) kept installed for the purpose of a telecommunications code system or of any other telecommunications apparatus lawfully kept installed in any position;
- (c) the vehicle, if it cannot conveniently be used for such purpose in any other road, in pursuance of statutory powers or duties;
- (d) the vehicle, if it is the services of or employed by a universal service provider in the course of the provision of a universal postal service, to deliver and/or collect postal packets;
- (e) the vehicle to be used for fire brigade, ambulance or police purposes;
- (f) except where Article 14 applies, goods to be loaded onto or unloaded from the vehicle;
- (g) hackney carriages to wait upon a duly authorised taxi stand;
or

- (h) pedal cycles while parked in a duly authorised cycle parking facility, the location of which has been approved by the highway authority and the police.
- 16. Except where a clearway restriction is specified on the plans, nothing in Articles 7 and 9 of this Order shall render it unlawful to cause or permit a vehicle which lawfully displays in the relevant position a disabled person's badge and a parking disc, on which the driver or other person in charge of the vehicle has marked the time at which the period of waiting began, to wait in any of the roads, lengths of road or on any of the sides of road referred to in those Articles for a period not exceeding three hours (not being a period separated by an interval of less than one hour from a previous period of waiting by the same vehicle in the same length of road or on the same side of road on the same day).
- 17. Nothing in Article 13 of this Order shall render it unlawful to cause or permit a vehicle which lawfully displays in the relevant position a disabled person's badge to wait, without limitation in time, on the lengths of road and sides of roads referred to in that Article.
- 18. Nothing in Articles 7, 9, 10, 11, 12, and 13 of this Order shall prevent any person from causing or permitting a vehicle which displays in the relevant position a valid waiver certificate issued by the Council to wait in any prohibited road or in any restricted road, taxi rank, loading bay or keep clear zone in accordance with the terms and conditions of the waiver certificate.
- 19. A waiver certificate may be cancelled at any time at the sole discretion of the Council and shall thereupon immediately cease to be valid. Notification of such cancellation shall be in writing to the holder of the certificate at any address that the Council believes to be that person's address and the

certificate shall forthwith be surrendered to the Council.

PART III

DESIGNATED PARKING PLACES

DESIGNATION AND SIGNING OF PARKING PLACES

20. Each parking place (for the purposes of this Part III being a residents' parking place or a disabled persons' parking place) identified on the plans is authorised to be used, subject to the following provisions of this Order, as a parking place for waiting, during the permitted hours by the specified class of vehicle relevant to each type of parking place.
21. The Council shall indicate the presence of a parking place by placing and maintaining the appropriate traffic signs.

RESTRICTIONS ON WAITING IN A PARKING PLACE

22. Except as provided by this Order, no person shall cause or permit a vehicle to wait in a parking place during the permitted hours unless:
- (a) it is the specified class of vehicle; and
 - (b) it is parked wholly within a parking bay
23. Subject to the provisions of this Order, the following may be left in a residents' parking place during the permitted hours:
- (a) a motor vehicle waiting for no longer than the period specified on the plans (not being a period separated by an interval of less than one hour from a previous period of waiting by the same motor vehicle on the same day); or
 - (b) a motor vehicle displaying in the relevant position a valid permit ; or
 - (c) a disabled person's vehicle displaying in the relevant position a disabled person's badge.

24. No person shall cause or permit a vehicle to wait in a parking place that has been suspended under Articles 25 and 26.

SUSPENSION OF PARKING PLACES

25. Any person authorised by the Council may suspend the use of a parking place whenever he/she considers such suspension reasonably necessary;
- (a) for the purpose of facilitating the movement of traffic or promoting its safety;
 - (b) for the purposes of any building operation, demolition or excavation, repair or maintenance of property in or adjacent to the parking place or the maintenance, improvement or reconstruction of the road in or adjacent to the parking place or the laying, erection, alteration, removal or repair in or adjacent to the parking place of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus or traffic sign;
 - (c) for the convenience of occupiers of premises adjacent to the parking place at times of weddings or funerals or on other special occasions; or for the removal of furniture from one dwelling house or office to another or the removal of furniture from such premises to a depository or to such premises from a depository;
 - (d) on any occasion on which it is likely by reason of some special attraction that any street will be thronged or obstructed;
 - (e) for the purpose of facilitating the cleansing of the parking place.
26. A police officer in uniform may suspend the use of a parking place for not longer than 24 hours whenever he/she considers such suspension reasonably necessary for the purpose of facilitating the movement of traffic or promoting its safety.
27. Any person suspending the use of a parking place in accordance with the provisions of Articles 25 or 26 shall place in or adjacent to that parking

place a traffic sign indicating that waiting by vehicles is prohibited.

USE OF PARKING PLACES

28. The driver of a motor vehicle using the parking place shall stop the engine as soon as the vehicle is in position in the parking place, and shall not start the engine except when about to change the position of the vehicle in or depart from the parking place.
29. No person shall use a vehicle while it is in a parking place in connection with the sale of any article to persons in or near the parking place or in connection with the selling or offering for hire of his/her skills or services.

EXEMPTIONS

30. Save as provided in Article 24 and subject to the provisions of this Order, a motor vehicle may wait in a parking place for as long as may be necessary to enable:
- (a) a person to board or alight from the vehicle;
 - (b) goods to be loaded onto or unloaded from the vehicle;
 - (c) the vehicle, if it is the services of or employed by a universal service provider in the course of the provision of a universal postal service, to deliver and/or collect postal packets;
 - (d) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations, namely:
 - (i) building, excavation or demolition operations;
 - (ii) the removal of any obstruction to traffic;
 - (iii) the maintenance, improvement or reconstruction of the road in or adjacent to the parking place; or
 - (iv) the laying, erection, alteration or repair in or near the said road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus (as defined in the

Telecommunications Act 1984) kept installed for the purposed of a telecommunications code system or of any other telecommunications apparatus kept lawfully installed in any position;

- (e) to enable the vehicle, if it cannot conveniently used for such purpose in any other road, to be used in pursuance of statutory powers or duties;
- (f) where the vehicle is being used for fire brigade, ambulance or police purposes; or
- (g) where the vehicle is being used by a person medically qualified as a doctor, nurse or carer on call to premises adjacent to the parking place.

PART IV

CONTRAVENTION OF ORDER

CONTRAVENTION

31. If a vehicle is left in contravention or without complying with the requirements of this Order a contravention shall have occurred and the penalty charge shall be payable.

PENALTY CHARGE NOTICE

32. In the case of a vehicle in respect of which a penalty charge is payable, it shall be the duty of
- (i) a civil enforcement officer to serve a penalty charge notice in accordance with regulation 9 of the 2007 Regulations; or
 - (ii) the enforcement authority to serve a penalty charge notice in accordance with regulation 10 of the 2007 Regulations.
33. The owner of the vehicle shall pay the penalty charge on the penalty charge notice to the enforcement authority or its agent as directed on the penalty charge notice.

34. The particulars given in the penalty charge notice served in accordance with Article 32 shall be treated as evidence in any proceedings relating to failure to pay such a penalty charge.
35. A penalty charge notice attached to a vehicle in accordance with the provisions of Article 32 and regulation 9(a) of the 2007 Regulations shall not be removed or interfered with except by or under the authority of the owner or person in charge of the vehicle or by some other person duly authorised by the enforcement authority.

PART V

REVOCATIONS

36. Other than in respect of the roads (or parts thereof) specified below, the traffic regulation orders (or part of an order) listed in Article 37 and any other traffic regulation orders (or part of an order) made by the Council (or any predecessor authority empowered to make such an order) relating to roads in the City of Chester
- (i) imposing any prohibitions or restrictions of waiting, stopping, loading/unloading (which are not moving traffic offences not enforceable by the Council under the 2004 Act); and/or
 - (ii) containing street parking places provisions
- are hereby revoked:
- (a) the sections of the M53 and M56 (and their slip roads) that fall within the City of Chester;
 - (b) the section of the A550 from the boundary of the Borough of Ellesmere Port & Neston to the boundary of the County of Cheshire with the County of Flintshire;
 - (c) the section of the A5117 from
 - (i) its westerly junction with the M56, including the entire roundabout, to its junction with the A540, and

- (ii) the point where it goes under junction 10 of the M53 to the point where it goes over junction 14 of the M56 including in both instances the entire roundabout;
 - (d) the section of the A55 from its commencement at junction 12 of the M53 to the boundary of the County of Cheshire with the County of Flintshire including the slip roads;
 - (e) the section of the A483 from its junction with the A55 to the boundary of the County of Cheshire with the County Borough of Wrexham;
 - (f) the section of the A41 from its junction with the A56 to the boundary of the County of Cheshire with the County of Shropshire;
 - (g) the section of the A54 within the area of the City of Chester from its junction with the A51 to the boundary of the Vale Royal Borough;
 - (h) the section of the A49
 - (i) from the boundary of the Vale Royal Borough at Tarporley to the boundary of the Crewe & Nantwich Borough at Bunbury, and
 - (ii) from the boundary of the Crewe & Nantwich Borough at Cholmondeley to the boundary of the Crewe & Nantwich Borough at the Shropshire Union Canal; and
 - (i) the section of the A540 from its boundary with the Borough of Ellesmere Port & Neston to its junction with the A550; and
 - (j) the section of the A494 from its commencement point where the M56 ceases to the boundary of the County of Cheshire with the County of Flintshire, including the slip roads.

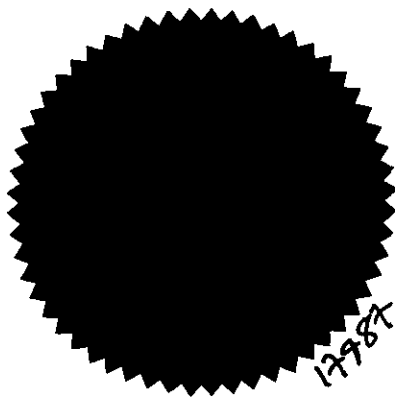
