CHESHIRE WEST AND CHESTER BOROUGH COUNCIL
(HACKNEY CARRIAGE STANDS) (FORMER VALE ROYAL AREA)
(PROHIBITION OF STOPPING EXCEPT FOR TAXIS) ORDER 2013

Cheshire West and Chester Borough Council in exercise of its powers under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 ("the Act"), and of all enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:

1. In this order "hackney carriage" means a vehicle licensed under section 37 of the Town Police Clauses Act 1847.
2. Save as provided in Article 5 of this order no person shall, except upon the direction of a police community safety officer or civil enforcement officer, cause or permit any vehicle, other than a hackney carriage, to wait in a hackney carriage stand on the lengths of road specified in the first column of the schedule during the period of operation specified in the second column of the schedule.
3. No person shall cause or permit any hackney carriage to wait on a hackney carriage stand other than for the purpose of plying for hire.
4. No person shall cause or permit any hackney carriage to wait in a hackney carriage stand outside the period of operation specified in the schedule.
5. Nothing in Article 2 shall render it unlawful to cause or permit any vehicle to wait in the lengths of road or on any of the sides of the road referred to therein for so long as may be necessary to enable:
 - (a) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with :
 - (i) Any operation involving building, demolition or excavation;
 - (ii) The removal of any obstruction to traffic;
 - (iii) The maintenance, improvement or reconstruction of the road;
 - (iv) The laying, erection, alteration, repair or cleaning in or near the length of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity, or of any telecommunications apparatus kept installed for the purpose of a telecommunications code system or of any other telecommunications apparatus lawfully kept installed in any position;

- (b) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in pursuance of statutory powers or duties;
 - (c) the vehicle to be used for fire brigade, ambulance or police purposes.
6. The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Road Traffic Regulation Act 1984.
 7. This Order shall come into operation on 6th day of November 2013 and may be cited as "The Cheshire West and Chester Borough Council (Hackney Carriage Stands) (Former Vale Royal Area)(Prohibition of Stopping Except For Taxis) Order 2013 "

Market Car Park, Applemarket Street, Northwich	24 Hrs All days
Northwich Road, Weaverham (outside Co-op store)	24 Hrs All days
High Street, Frodsham (outside Morrisons Supermarket)	24 Hrs All days
Dingle Lane, Winsford (Service Road 4)	8am-8pm All days
