THE CITY OF CHESTER (VARIOUS ROADS) (CONSOLIDATION OF NO RIGHT TURN AND PRESCRIBED ROUTE) ORDER 1975

The Council of the City of Chester, in exercise of their powers under Section 1(1), (2) and (3) and 84D (1) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, and Schedule 19 to the Local Government Act 1972, and Schedule 6 to the Road Traffic Act 1974, and of all other powers enabling in that behalf, and after consultation with the Chief Officer of police in accordance with Section 84C (1) of the said Act of 1967, hereby make the following Order:-

1. The Order specified in Schedule 1 to this Order, each having effect by virtue of the above powers are revoked.
2. All persons causing their vehicles to proceed along the lengths of roads in the directions specified in Schedule 2 to this Order shall, cause their vehicles to make a left hand turn into the lengths of roads also specified in the Schedule.
3. No person shall drive, or permit to be driven, any vehicle on the roads specified in column 1 of the Schedule 3 to this Order, so as to make a right hand turn into the roads specified in column 2 of the said Schedule.
4. No person shall, between the hours of 4.30 p.m. and 6.30 p.m., Mondays - Saturdays inclusive, cause any vehicle to make a right turn out of the lengths of roads specified in Schedule 4 to this Order.
5. No person shall, between the hours of 8 a.m. and 7 p.m., cause any vehicle to make a right hand turn out of the lengths of roads specified in Schedule 5 to this Order.
6. The Interpretation Act 1889 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament, and as if for the purposes of Section 38 of that Act this Order were an Act of Parliament and the Orders revoked by Article 1 of this Order were Acts of Parliament thereby repealed.

This Order shall come into operation on the 22nd day of December, 1975, and may be cited as the City of Chester (Various Roads) (Consolidation of No Right Turn and Prescribed Route) Order 1975.

(v) Dee Lane and Boughton	- Every person causing any vehicle to proceed in a northerly direction in Dee Lane shall cause that vehicle, on reaching the junction of Dee Lane with Boughton to make a left hand turn into The Bars.
(vi) Volunteer Street and Pepper Street	- Every person causing any vehicle to proceed in a northerly direction in Volunteer Street shall cause that vehicle, on reaching the junction of Volunteer Street with Pepper Street to make a left hand turn into Pepper Street.
(vii) Park Street and Pepper Street	- Every person causing any vehicle to proceed in a northerly direction in Park Street shall cause that vehicle, on reaching the junction of Park Street with Pepper Street, to make a left hand turn into Pepper Street.
