THE BUCKINGHAMSHIRE COUNTY COUNCIL (CHILTERN DISTRICT)(CONSOLIDATION ORDER) 2005

Buckinghamshire County Council in exercise of the powers under Sections 1(1) and (2), 2(1) to (3), 3(2), 4(1) to (3), 32, 33, 35, 37, 38(1), 45, 46, 46A, 49, 51, 53, 63A, 65, 68, 69, 71, 101, 102 and 116, and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act"), and of all other enabling powers and having regard to Section 122 of the Act and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:

- This Order may be cited as "The Buckinghamshire County Council (Chiltern District)(Consolidation Order) 2005" and shall come into operation on 24 November 2005.
- The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirements imposed by any regulations made or having effect as if made under any other enactment.
- 3 In this Order:
 - (a) "bus" has the same meaning given by Regulation 22(2) of the Traffic Signs Regulations and General Directions 2002;
 - (b) "Council" means Buckinghamshire County Council or any person authorised on its behalf;
 - (c) "disabled person's badge" has the same meaning given by Section 142 of the 1984 Act;
 - (d) "disabled person's vehicle" has same the meaning given by Section 142 of the 1984 Act;
 - (e) "goods" means goods of any kind whether animate or inanimate and includes postal packets of any description and the restocking of vending machines; and "delivering" and "collecting" in relation to any goods includes checking the goods for the purpose of their delivery or collection;
 - (f) "motor cycle" has the meaning as in Section 136 of the 1984 Act;
 - (g) "motor vehicle" has the meaning as in Section 136 of the 1984 Act;
 - (h) "obstruction" in relation to the parking of a vehicle, means a parking position that prevents free flow of traffic along the carriageway, footway or cycleway, access to the carriageway or egress from the carriageway;
 - (i) "owner" in relation to a vehicle means the person by whom such vehicle is kept and used;
 - (j) "parking attendant" means a person authorised by or on behalf of the Council to supervise and enforce the restrictions imposed by this Order;

- (k) "parking bay" means any area of a parking place which is provided for the leaving or waiting of a vehicle and indicated by markings on the surface of that parking place;
- (I) "parking disc" has the meaning given by Regulation 8(5) of the Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000;
- (m) "parking place" means any area of a highway designated as a parking place by this Order:
- (n) "permit holder" means a person to whom a permit has been issued under the provisions of Section 10 of this Order;
- (o) "relevant position" means in respect of:
 - (a) a disabled person's badge issued on or after 1 April 2000:
 - (i) the badge is exhibited on the dashboard or fascia of the vehicle; or
 - (ii) in the case of a vehicle not fitted with a dashboard or fascia panel the badge is exhibited in a conspicuous position on the vehicle,

so that the front of the badge is clearly legible from the outside of the vehicle.

- (b) a valid resident permit if:
 - in the case of a vehicle fitted with a front windscreen on the near side of and immediately behind the windscreen in a position so as to allow the details on the obverse face to be legible from outside the vehicle; or
 - (ii) in the case of a vehicle not fitted with a front windscreen the permit is exhibited in a conspicuous position so as to allow the details on the obverse face to be legible from outside the vehicle.
- (p) "resident" means a person whose usual place of abode is at premises the postal address of which is in any street or part of any street described in the Schedule 14;
- (q) "resident permit" means a permit issued under the provisions of Section 6;
- (r) "resident permit holder" means a person to whom a resident permit has been issued;
- (s) "school entrance markings" means any area which is comprised within and indicated by a road marking complying with the Traffic Signs Regulations and General Directions 2002;
- (t) "taxi" has the same meaning as "licensed taxi" as defined in Section 13(3) of the Transport Act 1985;
- "taxi rank" means any area which is comprised within and indicated by a road marking complying with diagram 1028.2 of the Traffic Signs Regulations and General Directions 2002;

- (v) "traffic sign" means a sign of any size, colour and type prescribed or authorised under, or having effect as though prescribed or authorised under Section 64 of the 1984 Act;
- (w) "undertaker" has the same meaning as in Section 48 of the New Roads and Street Works Act 1991;
- (x) "valid permit" means a valid resident permit which is displayed together with a valid tax disc for that vehicle:
- (y) "valid tax disc" means the vehicle excise licence required to be displayed in the vehicle concerned in order for that vehicle to be legally used on a public road;
- (z) "vehicle" has the same meaning as "motor vehicle" in Section 136 of the 1984 Act.

Section 1: No waiting at any time and no loading/unloading during prescribed hours

- 1/01 Save as provided in Articles 1/02, 1/03 and 1/04 hereof no person shall, except upon the direction or with the permission of a police constable in uniform, a traffic warden or a parking attendant, cause or permit any vehicle to wait in the lengths of road specified in Schedule 1 to this Order.
- 1/02 Nothing in Articles 1/01 hereof shall render it unlawful to cause or permit any vehicle to wait for so long as may be necessary for the purpose of enabling goods to be loaded on or unloaded from the vehicle in any of the lengths of road specified in Schedule 1 to this Order at any time on any day except during the times specified in Column 6 thereto.
- 1/03 Nothing in Articles 1/01 hereof shall render it unlawful to cause or permit any vehicle to wait in any of the lengths of road specified therein for so long as may be necessary to enable:
 - (a) a person to board or alight from the vehicle;
 - (b) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations, namely:
 - (i) building, industrial or demolition operations;
 - (ii) the removal of any obstruction to traffic;
 - (iii) the maintenance, improvement or reconstruction of the said lengths of road; or
 - (iv) the laying, erection, alteration or repair in or on land adjacent to the said lengths of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunication system as defined in the Telecommunications Act 1984.
 - (c) the vehicle, if it cannot conveniently be used for such purposes in any other road, to be used in the service of an undertaker or of a water authority in pursuance of statutory powers or duties;
 - (d) the vehicle to wait at or near to any premises situated on or adjacent to any of the said lengths of road for so long as such waiting by that vehicle is reasonably necessary in connection with any wedding or funeral;
 - (e) the vehicle to be used for fire brigade, ambulance or police purposes;
- 1/04 Nothing in Article 1/01 hereof shall render it unlawful to cause or permit a disabled person's vehicle which displays in the relevant position a disabled person's badge, and a parking disc (on which the driver, or other person in charge of the vehicle, has marked the time at which the period of waiting began) to wait in any of the lengths of road referred to in the said Article for a period not exceeding three hours (not being a period separated by an interval of less than one hour from a previous period of waiting by the same vehicle in the same length of road) provided that such period lies entirely outside the period during which the restriction as to loading and unloading specified in Article 1/02 hereof applies.

- 2/01 Save as provided in Articles 2/02 and 2/03 of this Order, no person shall except upon the direction of a police constable in uniform or of a parking attendant cause or permit any vehicle to wait at any time in the lengths of roads referred to in Schedule 2 to this Order.
- 2/02 Nothing in Article 2/01 hereof shall render it unlawful to cause or permit any vehicle to wait in any of the lengths of road referred to therein for so long as may be necessary to enable:
 - (a) a person to board or alight from the vehicle;
 - (b) goods to be loaded on or unloaded from the vehicle;
 - (c) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations, namely:
 - (i) building, industrial or demolition operations;
 - (ii) the removal of any obstruction to traffic;
 - (iii) the maintenance, improvement or reconstruction of the said lengths of road; or
 - (iv) the laying, erection, alteration or repair in or on land adjacent to the said lengths of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunication system as defined in the Telecommunications Act 1984.
 - (d) the vehicle, if it cannot conveniently be used for such purposes in any other road, to be used in the service of an undertaker or of a water authority in pursuance of statutory powers or duties;
 - (e) the vehicle to wait at or near to any premises situated on or adjacent to any of the said lengths of road for so long as such waiting by that vehicle is reasonably necessary in connection with any wedding or funeral;
 - (f) the vehicle to be used for fire brigade, ambulance or police purposes.
- 2/03 Nothing in Article 2/01 hereof shall render it unlawful to cause or permit a disabled person's vehicle which displays in the relevant position a disabled person's badge, and a parking disc (on which the driver, or other person in charge of the vehicle, has marked the time at which the period of waiting began) to wait in any of the lengths of road referred to in the said Article for a period not exceeding three hours (not being a period separated by an interval of less than one hour from a previous period of waiting by the same vehicle in the same length of road).

Section 3: No waiting during prescribed hours

- 3/01 Save as provided by Articles 3/02, 3/03 and 3/04, no person shall except on the direction or with the permission of a police constable in uniform or of a parking attendant cause or permit a vehicle to wait:
 - (a) at anytime on any day other than a Sunday in any of lengths of road referred to in Schedule 3 to this Order;
 - (b) between the hours of 8am and 7pm on any day other than a Sunday in any of lengths of road referred to in Schedule 4 hereto;
 - (c) between the hours of 8am and 6.30pm on any day other than a Sunday in any of lengths of road referred to in Schedule 5 hereto;
 - (d) between the hours of 8am and 6pm on any day other than a Sunday in any of lengths of road referred to in Schedule 6 hereto;
 - (e) between the hours of 8am and 6pm on any day other than a Saturday and Sunday in any of lengths of road referred to in Schedule 7 hereto;
 - (f) between the hours of 7am and 8am, and between 5pm and 6pm on any day other than a Saturday and Sunday in any of lengths of road referred to in Schedule 8 hereto:
 - (g) between the hours of 11am and 12noon on any day other than a Saturday and Sunday in any of lengths of road referred to in Schedule 9 hereto;
 - (h) between the hours of 2pm and 3pm on any day other than a Saturday and Sunday in any of lengths of road referred to in Schedule 10 hereto.
- 3/02 Nothing in Article 3/01 of this Order shall render it unlawful to cause or permit any vehicle to wait in any of the lengths of road referred to therein for so long as may be necessary to enable:
 - (a) a person to board or alight from the vehicle;
 - (b) goods to be loaded on or unloaded from the vehicle;
 - (c) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations, namely:
 - (i) building, industrial or demolition operations;
 - (ii) the removal of any obstruction to traffic;
 - (iii) the maintenance, improvement or reconstruction of the said lengths of road; or
 - (iv) the laying, erection, alteration or repair in or on land adjacent to the said lengths of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunication system as defined in the Telecommunications Act 1984.

- (d) the vehicle, if it cannot conveniently be used for such purposes in any other road, to be used in the service of an undertaker or of a water authority in pursuance of statutory powers or duties;
- (e) the vehicle to wait at or near to any premises situated on or adjacent to any of the said lengths of road for so long as such waiting by that vehicle is reasonably necessary in connection with any wedding or funeral;
- (f) the vehicle to be used for fire brigade, ambulance or police purposes.
- 3/03 Nothing in Article 3/01(a), (b), (c), (d) and (e) shall render it unlawful to cause or permit a disabled person's vehicle which displays in the relevant position a disabled person's badge, and a parking disc (on which the driver, or other person in charge of the vehicle, has marked the time at which the period of waiting began) to wait in any of the lengths of road referred to in the said Articles for a period not exceeding three hours (not being a period separated by an interval of less than one hour from a previous period of waiting by the same vehicle in the same length of road).
- 3/04 Nothing in Article 3/01(f), (g) and (h) shall render it unlawful to cause or permit a disabled person's vehicle which displays in the relevant position a disabled person's badge to wait in the lengths of road referred to in the said Article.

Section 4: Limited waiting during prescribed hours

- 4/01 Save as provided in Articles 4/04 and 4/05 hereof, no person shall except upon the direction of a police constable in uniform or of a parking attendant cause or permit any vehicle to wait in the lengths of roads referred to in Schedule 12 to this Order during the hours prescribed in Column 6 of the said Schedule:
 - (a) for a period exceeding the length of time specified in Column 7 of Schedule 12;
 - (b) during any period separated by an interval of less than the duration specified in Column 8 of Schedule 12 from a previous period of waiting by the same vehicle in the same side and length of road.
- 4/02 Every vehicle left in a parking bay specified in Column 5 of Schedule 12 shall so stand:
 - (a) so that the left or nearside of the vehicle is parallel to the edge of the carriageway; and
 - (b) so that every part of the vehicle is within the limits of the parking bay.
- 4/03 Where any vehicle is standing in a parking bay in contravention of the provisions of 4/02 of this Order, a police constable in uniform or a parking attendant may alter or cause to be altered the position of the vehicle in order that its position shall comply with those provisions.
- 4/04 Nothing in Article 4/01 of this Order shall render it unlawful to cause or permit any vehicle to wait in any of the lengths of road referred to therein for so long as may be necessary to enable:
 - (a) a person to board or alight from the vehicle;
 - (b) goods to be loaded on or unloaded from the vehicle;
 - (c) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations, namely:
 - (i) building, industrial or demolition operations:
 - (ii) the removal of any obstruction to traffic;
 - (iii) the maintenance, improvement or reconstruction of the said lengths of road; or
 - (iv) the laying, erection, alteration or repair in or on land adjacent to the said lengths of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunication system as defined in the Telecommunications Act 1984.
 - (d) the vehicle, if it cannot conveniently be used for such purposes in any other road, to be used in the service of an undertaker or of a water authority in pursuance of statutory powers or duties;

- (e) the vehicle to wait at or near to any premises situated on or adjacent to any of the said lengths of road for so long as such waiting by that vehicle is reasonably necessary in connection with any wedding or funeral;
- (f) the vehicle to be used for fire brigade, ambulance or police purposes.
- 4/05 Nothing in Article 4/01 shall render it unlawful to cause or permit a disabled person's vehicle which displays in the relevant position a disabled person's badge to wait in the lengths of road referred to in the said Article.

- 6/03 (a) Any resident who is the owner of a motor vehicle, motor cycle, or disabled person's vehicle may apply to the Council for the issue of a resident's permit for the parking of that vehicle and any such application shall be made on a form issued by and obtainable from the Council and shall include the information required by such form and shall be accompanied by a remittance for such charge specified in Article 6/06(c) of this Order.
 - (b) The Council may at any time require an applicant for a resident's permit to produce an officer of the Council such evidence in respect of an application for a resident's permit made to them as they may reasonably require to verify any information given to them.
 - (c) On receipt of an application made under the foregoing provisions of this Article, and of the fee specified in Article 6/06(c) of this Order, the Council, upon being satisfied that the applicant is a resident and is the owner of a vehicle of the class specified in paragraph (a) of this Article, shall at the discretion of the Council issue to that applicant one resident's permit for the parking during the permitted hours in a parking space in any parking place of the vehicle to which such resident's permit relates by the owner of such vehicle or by any person using such vehicle with the consent of the owner other than a person to whom such vehicle has been let for hire or reward, provided always that subject to the provisions of Article 6/07(b) of this Order shall not issue a resident's permit to any resident which would be valid for any period during which any other resident's permit issued to that resident extends.
 - (d) Subject only to the provisions of Article 6/06 of this Order nothing herein contained shall require or impose on the Council any obligation to issue any resident's permit pursuant to the provisions of this Order to any applicant if the Council considers the issue of any such further permits would impose such a demand for parking facilities as to exceed the extent of facilities provided by the provisions of Article 6/02 and Schedule 14 of this Order.
 - (e) Any person may cause or permit a motor vehicle, motorcycle or disabled person's vehicle which displays a permit in accordance with Article 6/04 below to wait in any length of road specified in Column 5 of Schedule 14 thereto during the permitted hours for the period of validity of the permit provided the vehicle waits wholly within the limits of any marked parking space.
- 6/04 (a) A permit issued in accordance with this Order shall be displayed:
 - (i) in the case of a vehicle fitted with a front windscreen on the near side of and immediately behind the windscreen so as to be legible from outside the vehicle the details specified in paragraph (ii)(A)(B)(C) and (D) below

or

- (ii) in the case of a vehicle not fitted with a front windscreen the permit is exhibited in a conspicuous position so that the details in (A), (B), (C) and (D) below are legible from outside the vehicle
 - (A) the serial number;
 - (B) the registration mark of the vehicle in respect of which the permit was issued:
 - (C) the date of expiry, and
 - (D) any code number or identification mark from time to time required to be included on the permit by the Council.
- 6/05 (a) A permit holder may surrender a permit to the Council at any time and shall surrender a permit to the Council on the occurrence of any of the events set out in paragraph (c) of this Article.
 - (b) The Council may, by notice in writing served on the permit holder at the address shown by that person on the application for the period or at any other address believed to be that person's residence, revoke a permit if it appears to the Council that any one or more of the events set out in paragraphs (c)(i), (ii)(iii), (iv), (v) or (vi) of this Article has occurred and the permit holder shall surrender the permit to the Council within 48 hours of the receipt of such notice.
 - (c) The events referred to in the foregoing provisions of this Article are:
 - (i) the permit holder ceasing to be a resident;
 - (ii) the permit holder ceasing to be the owner of the vehicle in respect of which the permit was issued;
 - (iii) the vehicle in respect of which such period was issued being adapted or used in such a manner that it is not a vehicle of the class specified in Article 6/03 of this Order:
 - (iv) an application under Article 6/03 is received by and acceptable to the Council but the issue of a permit pursuant thereto would be a contravention of that said Article unless some other permit then subsisting is first surrendered to the Council;
 - (v) the permit was obtained by fraud or misrepresentation.
 - (vi) the permit was issued by mistake.
 - (d) The Council may at any time require a permit holder to produce to an officer of the Council such evidence in respect of any permit issued by them as they may reasonably require.
 - (e) Where a permit is revoked an authorised person shall send written notice to the address given by the applicant for the permit and any such notice shall inform the applicant of his right to make written representations to the Council.

- (f) A person aggrieved by the revocation of a permit or a refusal to issue a permit may make written representations to the Council and may apply for the restoration or issue of a permit.
- (g) Any person may apply for the return to him or to a person nominated by him in writing of a proportional part of the charge paid in respect of a permit at the rate of one twelfth of the charge paid for the permit in respect of each calendar month remaining unexpired on the permit as of the date when the permit is presented for a refund.
- 6/06 (a) Where a person authorised by the Council to issue permits is satisfied that an applicant is entitled to the issue to him of a permit and that the correct charge if any has been paid he may at the discretion of the Council issue a permit.
 - (b) Where an application is made for the issue of a permit and either the applicant is unable to provide at that time the prescribed evidence or an authorised person is not satisfied with the evidence produced to him at that time provided the charge if any for a permit has been paid he may issue a temporary permit.
 - (c) The administrative charge for the issue of a permit shall be £3.00 or such charge as the Council may hereafter by notice provided in accordance with paragraph (d) of this Article.
 - (d) The Council may from time to time by notice publish any charges applicable to permits not less than one month before any such charge is to be effective.
 - (e) A permit is valid until midnight on the date of expiry or until revoked in accordance with the provisions of Article 6/05 above.
- 6/07 (a) A permit may only be transferred between vehicles by a person making an application in the same manner as an application for an issue of a permit save that no charge is payable in respect of such transfer.
 - (b) Where a permit is lost or defaced the person to whom the permit was issued may apply to the Council for the issue without charge of a duplicate permit.
- 6/08 Where any vehicle is standing in a parking place in contravention of the provisions of Article 6/03(e) of this Order a police constable in uniform or a parking attendant may alter or cause to be altered the position of the vehicle in order that its position shall comply with those provisions.
- 6/09 Where a police constable in uniform or a parking attendant is of the opinion that any of the provisions contained in Article 6/03 of this Order have been contravened or not complied with in respect of a vehicle parked in a parking place, he may remove or cause to be removed the vehicle from the parking place, and where it is so removed, shall provide for the safe custody of the vehicle.
- 6/10 A police constable in uniform or a parking attendant may in case of emergency move or cause to be moved any vehicle parked in a parking place to any place he thinks fit.
- 6/11 (a) Any person authorised by the Council may suspend the use of a parking place or any part thereof whenever he considers such suspension reasonably necessary:

- (i) for the purpose of facilitating the movement of traffic or promoting its safety;
- (ii) for the purpose of any building operation, demolition or excavation in or adjacent to the parking place or the maintenance, improvement or reconstruction of the parking place or the laying, erection, alteration, removal or repair in or adjacent to the parking place of any sewer or of any main, pipe or apparatus or the supply of gas, water or electricity or of any telecommunication system or traffic sign;
- (iii) for the convenience of occupiers of premises adjacent to the parking place on any occasion of the removal of furniture from one office or dwellinghouse to another or the removal of furniture from such premises to a depository or to such premises from a depository;
- (iv) on any occasion on which it is likely by reason of some special attraction that any street will be thronged or obstructed; or
- (v) for the convenience of occupiers of premises adjacent to the parking place at times of weddings or funerals, or on other special occasions.
- (b) A police constable in uniform may suspend for not longer than seven days the use of a parking place or any part thereof whenever he considers such suspension reasonably necessary for the purpose of facilitating the movement of traffic or promoting its safety.
- (c) Any person suspending the use of a parking place or any part thereof in accordance with the provisions of paragraph (a) or paragraph (b) of this Article shall thereupon place or cause to be placed in or adjacent to that parking place or the part thereof the use of which is suspended a traffic sign indicating that waiting by vehicles is prohibited.
- (d) No person shall cause or permit a vehicle to be parked in any parking place or part of a parking place during such period as there is in or adjacent to that parking place or part of a parking place a traffic sign placed in pursuance of paragraph (c) of this Article: provided that nothing in this paragraph shall render it unlawful to cause or permit any vehicle being use for fire brigade, ambulance or police purposes or any vehicle being used for any purpose specified in Article 6/13(a)(ii), (iv) or (v) of this Order to be parked in the parking place or part of a parking place during any such period, or to any other vehicle so parked if that vehicle is parked with the permission (i) of the person suspending the use of the parking place or the part thereof in pursuance of paragraph (a) of this Article, (ii) of a police constable in uniform, or (iii) of a parking attendant.
- 6/12 While any vehicle is in a parking place during the permitted hours, no person shall use the vehicle in connection with the sale of any article to any person in or near the parking place or in connection with the selling or offering for sale of his skill or services.
- 6/13 (a) Notwithstanding the foregoing provisions of this Order, any vehicle may wait during the permitted hours anywhere on the carriageway in a parking place (other than a parking place or part of a parking place the use of which has been suspended, under Article 6/11 of this Order) for so long as may be necessary if:

- (i) the vehicle is waiting to enable a person to board or alight from the vehicle:
- (ii) the vehicle is waiting owing to the driver being prevented from proceeding by circumstances beyond his control or to such waiting being necessary in order to avoid accident;
- (iii) the vehicle is a vehicle used for police, fire brigade or ambulance purposes, or a vehicle (other than a passenger vehicle) in the service of a local authority or a water authority which is being used in pursuance of statutory powers or duties;
- (iv) the vehicle is waiting to enable it to be used on connection with the removal of any obstruction to traffic;
- (v) the vehicle is in the service of or employed by the Post Office and is waiting while postal packets addressed to premises adjacent to the parking place in which the vehicle is waiting are being unloaded from the vehicle, or, having been unloaded therefrom, are being delivered or while postal packets are being collected from premises or posting boxes adjacent to the parking place in which the vehicle is waiting, or is in use in connection with the servicing of telephone kiosks adjacent to the parking place;
- (vi) the vehicle (not being a passenger vehicle) is waiting to enable it to be used for any purpose specified in Article 6/11(a)(ii) of this Order;
- (vii) the vehicle (not being a passenger vehicle) is in actual use in connection with the removal of furniture from one office or dwellinghouse to another or the removal of furniture from such premises to a depository or to such premises from a depository;
- (viii) the vehicle is waiting otherwise than in a parking place if goods are being sold or offered from sale from the vehicle by a person who is licensed by the Council to sell goods from a stationary pitch situated in the parking place;
- in any other case the vehicle is waiting for the purpose of delivering or collecting goods including, so far as a Bank is concerned, cash or other valuable securities, or loading or unloading the vehicle at premises adjacent to the parking place in which the vehicle is waiting and the vehicle (not being a goods vehicle) does not wait for such purpose for more than thirty minutes or for such longer period as a police constable in uniform or a parking attendant may authorised, or, being a goods vehicle does not so wait for such purposes for more than thirty minutes or such longer period as aforesaid if it is in any part of a parking space.
- (b) No charge specified in the foregoing provisions of this Order shall be payable in respect of any vehicle waiting in a parking place in accordance with the foregoing provisions of this Article.
- (c) Except as provided in the foregoing provisions of this Article, the driver of a vehicle shall not cause or permit the vehicle to wait in a parking place during the permitted hours.

6/14 A person causing or permitting a vehicle to wait in a parking place by virtue of the provisions of Article 6/13(a)(v), (vi), (vii), (viii) or (ix) of this Order shall take all such steps as are necessary to ensure that the left or nearside of the vehicle is parallel to the edge of the carriageway nearest to the vehicle and the distance between the said edge of the carriageway and the nearest wheel of the vehicle is not more than twelve inches.

Section 7: Parking bays for disabled badge holders only

- 7/01 Subject to the provisions of this Order, the areas specified in Column 5 of Schedule 15 are authorised to be used as parking places to provide parking bays for disabled persons' vehicles.
- 7/02 The driver of a vehicle shall not permit it to wait in the parking bay unless:
 - (a) it is a disabled person's vehicle; and
 - (b) it is parked wholly within the limits of a parking bay; and
 - (c) a disabled person's badge is displayed in the relevant position on the vehicle.
- 7/03 No person shall use a disabled person's vehicle while it is in the parking place in connection with the sale of any article to persons in or near that parking place or in connection with the selling or offering for hire of his skill or services.
- 7/04 Subject to the proviso hereto, when a disabled person's vehicle is left in the parking place in contravention of the provisions contained in Article 7/02 of this Order, a person authorised in that behalf may remove the vehicle or arrange for it to be removed from the parking place provided that when a disabled person's vehicle is waiting in the parking place in contravention of the provision contained in Article 7/02(b) of this Order, a person authorised in that behalf may alter or cause to be altered the position of the vehicle in order that its position may comply with that provision.
- 7/05 Any person removing a vehicle or altering its position by virtue of Article 7/04 of this Order may do so by towing or driving the vehicle or in such other manner as he may think necessary to enable him to remove it or alter its position as the case may be.
- 7/06 Nothing in Article 7/01 shall render it unlawful for a person to cause or permit a vehicle to stop or remain at rest in any length of road specified therein if:
 - (a) the vehicle is being used for the removal of any obstruction to traffic; or
 - (b) the vehicle is being used by or with the written consent of the Council and whilst being so used it is necessary for the vehicle to wait in that length of road; or
 - (c) the person in charge of the vehicle is required by law to stop or is obliged to stop in order to avoid an accident or is prevented from proceeding by circumstances beyond his control; or
 - (d) the vehicle is being used for police, fire brigade, ambulance or other emergency service; or
 - (e) it cannot reasonably be used for such purposes in any other road, for so long as may be necessary to enable the vehicle to be used in connection with:
 - (i) the maintenance, reconstruction or improvement of the said road,
 - (ii) the laying, erection or repair of any sewer, main, pipe or apparatus for the supply of gas, water, electricity or any telecommunications system defined by the Telecommunications Act 1984,or

- (iii) use in the service of an undertaker, the Environment Agency or any public authority in pursuance of statutory powers or duties.
- 7/07 In addition to the exemptions provided by 7/06, nothing shall render it unlawful for a person to cause or permit a vehicle to wait in any length of road specified therein for so long as may be necessary to enable the vehicle:
 - (a) if it cannot reasonably be used for such purpose in any other road, to be used in connection with:
 - (i) building, industrial or demolition operations,
 - (ii) any wedding or funeral,
 - (iii) use by a Universal Service Provider (as defined by Section 4(3) of the Postal Services Act 2000) in connection with the provision of a Universal Postal Services (within the meaning of the Postal Services Act 2000).
 - (b) if it is specially constructed or adapted for the delivery or collection of money or valuable property, to be used for those purposes in relation to premises in the vicinity.

 - (viii) the vehicle is specially constructed or adapted for the delivery of money or valuable securities and is being used for these purposes in relation to premises in the vicinity.
