The effect of the new Order, which will come into operation on 24 November 2005, will be to revoke or amend the above Orders, but the provisions contained in those Orders will remain in force unchanged by virtue of the new Order.

The making of the Order coincides with the designation of the Chiltern Special Parking Area. This designation has the effect of decriminalising most on and off-street parking offences in the area. From 1 September 2005, enforcement became the responsibility of parking attendants rather than the police.

Exemptions to the proposed Order will permit waiting with the permission of a police constable in uniform or a parking attendant; waiting for so long as may be necessary: (a) for

persons to board or alight; (b) for goods to be loaded or unloaded; (c) for enabling works to be carried out; (d) in pursuance of statutory powers or duties; and waiting of disabled persons' vehicles in accordance with the "Blue Badge" Scheme.

A copy of the Order and a set of plans showing the lengths of road referred to may be inspected at the offices of Chiltern District Council, King George V Road, Amersham, Buckinghamshire, during normal opening hours.

If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984 or on the grounds that any requirement of that Act or of any instrument made under it has not been complied with in relation to the Order, you may, within six weeks from 22 November 2005, apply to the High Court for this purpose.
