## CHILTERN DISTRICT COUNCIL

### OFF-STREET PARKING PLACES ORDER 2004

The Council of the Chiltern District in the County of Buckingham (hereinafter referred to as the “the Council”) in exercise of its powers under Section 35 (1) and (3) of the Road Traffic Regulation Act 1984 as amended by the Parking Act 1989 (which said Act of 1984 is hereinafter referred to as the “the Act”) and Part IV of Schedule 9 to the Act and all other enabling powers and with the consent of the Buckinghamshire County Council in accordance with Section 39 (3) of the Act and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, HEREBY MAKES the following Order:-

1 (1) This Order shall come into operation on the fifth day of January 2004 and may be cited as the Chiltern District Council Off-Street Parking Places Order 2004.

(2) The Chiltern District Council Off-Street Parking Places Order 1992 and the Chiltern District Council Off-Street Parking Places Amendment (No.1) Order 1992, the Chiltern District Council Off-Street Parking Places Amendment (No. 2) Order 1992, the Chiltern District Council Off-Street Parking Places Amendment (No. 3) Order 1992, the Chiltern District Council Off-Street Parking Places Amendment (No. 4) Order 1992 and the Chiltern District Council Off-Street Parking Places Amendment (No. 5) Order 1992 are hereby revoked upon the coming into operation of this Order.

2 (1) Any reference in this Order to a numbered Article is a reference to the Article bearing that number in this Order, and any reference in this Order to “the Schedule” or a numbered part is a reference to the Schedule or the part as the case may be to this Order.

(2) In this Order:-

“driver”, in relation to a vehicle waiting in a parking place, means the person driving the vehicle at the time it was left in the parking place;

“owner” in relation to a vehicle means the person by whom such vehicle is kept and used and unless the contrary is proved, the person shown by the appropriate registration authority to have been the registered keeper or owner on the date on which a vehicle was left in the parking place shall be deemed to be the owner for the purposes of this Order and in relation to a vehicle which is subject to a hiring agreement or hire purchase agreement means the person in possession of the vehicle under that agreement.

“parking bay” means any area of a parking place which is provided for the leaving of a vehicle and indicated by markings on the surface of the parking place; and

“parking place” means any area of land together with the respective accesses thereto specified by name in Column 1 of Part I of the Schedule and shown hatched in black for the purpose of identification only on the plans attached

provided by the Council under Section 32(1) of the Act for use as a parking place.

“season ticket” means a ticket or other printed document issued by the Council, to the owner of a specified vehicle, for use in such parking place as is shown on the ticket, and in accordance with Column 5 of Part I of the Schedule, during the period for which it is issued and is not transferable between parking places, save as provided in paragraph 13 of Part II of the Schedule hereto.

“disabled person’s badge” means a badge in the form prescribed by Regulation 11 of the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000 which has not ceased to be in force and which is displayed in accordance with Regulation 12 thereof or any replacement badge issued under Regulation 7.

“credit card” means a card or similar thing issued by any person, use of which enables the holder to defer the payment by him of the charge for parking a vehicle.

“debit card” means a card or similar thing issued by any person, use of which by the holder causes the charge for parking a vehicle to be paid by the electronic transfer of funds from any current account of his at a bank or other institution providing banking services.

## **USE OF LAND AND PARKING PLACE**

- 3 (1) Each area of land specified by name in Column 1 of Part I of the Schedule may be used, subject to the following provisions of this Order, as a parking place only for such classes of vehicles in such positions, on such days, during such hours and at such charges and subject to such Special Conditions as are specified in relation to that area in Parts I, II, III and V of the Schedule PROVIDED THAT:
- (a) the Council may by indication on site temporarily withdraw such parking place or any part thereof from such use;
  - (b) no charge shall be payable by the driver of a vehicle which displays a current Disabled Person’s Badge but all provisions as to maximum length of stay in relation to such parking place must be observed.
- (2) Where in Parts I, II and III of the Schedule a parking place is described as available for vehicles of a specified class or in a specified position, the driver of a vehicle shall not wait or permit it to be left in that parking place unless it is of the class and in the position so specified.
- (3) Where, within a parking place, there is a sign or surface marking which indicates that a parking bay is available only for a vehicle, displaying a Disabled Person’s Badge, the driver of that vehicle shall not wait or permit it to be left in that parking bay.

## **CHARGES AT PARKING PLACES**

- 4 (1) Save as hereinafter provided, no vehicle shall wait or be left in a parking place during the hours that charges for parking as referred to in Column 3 of Part I of the Schedule are to be paid (hereinafter referred to as “the charging hours”) without the owner or driver thereof having first paid the appropriate charge as set out in the said Column 3, Column 5 or Column 6 of Part I of the Schedule (hereinafter referred to as “the initial charge”) in the manner prescribed by this Article.
- (2) The initial charge shall be payable by the insertion of an appropriate coin or coins, bank notes, credit card, debit card, or other approved electronic transaction cards or otherwise as directed into the apparatus or device provided, being an apparatus or device approved in accordance with Section 35 of the Act, and the provisions of Section 35A of the Act shall apply in respect of such apparatus.
- (3) The owner of a vehicle may on application to the Council purchase a season ticket in respect of that vehicle for an initial charge ascertained by reference to the charges specified in Column 5 of Part I of the Schedule and that season ticket shall be only valid in such parking place as specified thereon in accordance with Column 5 of Part I of the Schedule during the period for which it is issued and is not transferable between parking places, save as provided in paragraph 13 of Part II of the Schedule hereto.
- (4) Any ticket issued on payment of the initial charge hereinbefore referred to in paragraph (2) of this Article or any season ticket issued in accordance with paragraph (3) of this Article shall be displayed in a conspicuous position inside the vehicle in order that the ticket can be read from the outside of the vehicle in respect of which it was issued whilst it is left in the parking place. A vehicle shall not be left in a parking place if it displays an expired ticket or expired season ticket.
- (5) The Council may from time to time grant written permission for vehicles to park at such times and in such parking places as it may deem expedient.
- (6) Except as provided by paragraph 4(ii) of Part II of the Schedule tickets issued on payment of the initial charge are only available for use in the parking place where issued and are not transferable either between parking places or users of the car park provided that season tickets issued in respect of a particular car park may also be used in the parking places listed in paragraph 13 of Part II of the Schedule hereto.

## **EXCESS CHARGE AT PARKING PLACE**

- 5 (1) If a vehicle is left in a parking place during the charging hours without a ticket having first been obtained in accordance with this Order or is otherwise left or used in contravention of any other provision of this Order the amount indicated in Part IV in the Schedule (hereinafter referred to as the “excess charge”) shall be payable by the driver or the owner of the vehicle PROVIDED THAT an excess charge notice as provided by Article 6 hereof has been duly attached to the vehicle.

(2) Pursuant to Section 47(4) of the Act if in any proceedings for an offence under Section 35A(1) of the Act or failing to pay the excess charge it is proved that the excess charge or any part of it has not been duly paid the Court shall order payment of the sum not paid and any sum ordered to be paid by virtue of this provision shall be recoverable as a penalty.

(3) Pursuant to Section 47(6) of the Act if in any proceedings for an offence under Section 35A(1) of the Act or failing to pay the excess charge it is not proved that the excess charge had become due but it provided that an initial charge has not been paid the defendant may be convicted of an offence of failing to pay an initial charge.

(4) Nothing herein shall be construed as preventing the institution of proceedings under Section 35A(1) of the Act for contravening any provision of this Order notwithstanding that an excess charge notice has not been affixed to any vehicle involved in the contravention.

### **NOTICE WHERE CONTRAVENTION OF THIS ORDER (EXCESS CHARGE NOTICE)**

6 (1) Where a vehicle is left in contravention of this Order, the Council shall be entitled through its servants or agents to attach to the vehicle in a conspicuous position a notice (herein referred to as an “excess charge notice”) which shall include the following particulars:-

(a) the registration mark of the vehicle or other identifying description or where the vehicle is being used under a trade licence, the number of the trade plate carried by the vehicle;

(b) the time at which the servant or agent observed that the vehicle had been left in contravention of this Order;

(c) a statement that is it an offence under Section 35A(1) of the Act to contravene or not comply with any provision of this Order;

(d) a statement that the excess charge is required to be paid;

(e) the manner and the time in which the excess charge is to be paid.

### **RESTRICTION ON REMOVAL OF NOTICES**

7 When an excess charge notice has been attached to a vehicle in accordance with this Order no person other than a person authorised by the Council in that behalf or the driver or a person authorised by the driver in that behalf shall remove the said excess charge notice from the vehicle. Removal, by whatever means, of an excess charge notice which has been issued and affixed to any vehicle in accordance with this Order shall not negate the excess charge and the provisions of Article 5 of this Order still apply.

## OTHER PROVISIONS

8 The driver of a motor vehicle using a parking place shall stop the engine as soon as the vehicle is in position in the parking place, and shall not start the engine, except when about to change the position of the vehicle, in or to depart from the parking place.

9 (1) Unless the Council's prior written consent is obtained, no person in a parking place shall:-

(a) drive any vehicle or otherwise than for the purpose of leaving it in the parking place in accordance with the provisions of this Order or for the purpose of departing from the parking place;

(b) use a vehicle, while it is in the parking place, in connection with the sale of any article to persons in or near the parking place or in connection with the selling or offering for hire of skills or services;

(c) erect or cause to be erected any tent, booth, stand, building or structure or other thing;

(d) light or cause or permit to be lighted any fire;

(e) display or distribute or cause to be displayed or distributed any notice, leaflet, handbill, booklet, book or other item;

(f) maintain, repair, service or wash any vehicle or part thereof other than is reasonably necessary to enable the vehicle to depart from the parking place;

(g) drive any vehicle and cause it to wait, in a parking place, without displaying a valid ticket, in accordance with Article 4 of this Order.

(2) No person in a parking place shall:-

(a) sound any horn or similar instrument except when necessary for the safety of persons or vehicles in the parking place;

(b) shout or make or permit any noise or otherwise behave to the disturbance or annoyance to users of the parking place, occupants of neighbouring premises or passers-by;

(c) use any threatening, abusive or insulting language, gesture or conduct likely to cause, or causing, a breach of the peace;

(d) use any part of the parking place or any vehicle in it for sleeping, cooking or camping purposes;

(e) use any part of the parking place for skating (using in-line or roller skates), skateboarding or cycling;

(f) engage in any other activity which causes disturbance or annoyance to

users of the parking place, occupants of neighbouring premises or passers-by.

- 10 (1) If a vehicle is left in a parking place in a position other than in accordance with the provisions of Article 3 hereof a person authorised by the Council in that behalf may alter or cause to be altered the position of the vehicle so that its position is in accordance with the said provisions.
- (2) If a vehicle is left in a parking place in contravention of any of the provisions of this Order a person authorised by the Council in that behalf may remove the vehicle from that parking place or arrange for such removal and may recover the costs thereof (including any costs of storage) from the owner or driver of the vehicle as a civil debt.
- (3) For the purpose of meeting the requirements of an emergency, a person authorised in that behalf by the Council or a police officer in uniform may alter or cause to be altered the position of a vehicle in a parking place or remove or arrange for the removal of a vehicle from a parking place.
- (4) Any person altering, or causing the alteration of, the position of a vehicle by virtue of paragraph (1) of this Article, or removing, or causing the removal of, a vehicle by virtue of paragraphs (2) or (3) of this Article, may do so by towing or driving the vehicle or in such other manner as he may think reasonably necessary.
- (5) Any person removing or arranging for the removal of a vehicle by virtue of paragraphs (2) or (3) of this Article, shall make such arrangements as he considers to be reasonably necessary for the safety of the vehicle in the place to which it is removed.

- 11 (1) Where in a parking place signs are erected or surface markings are laid for the purpose of:
- (a) indicating where parking is prohibited, or
  - (b) indicating the entrance to or exit from the parking place, or
  - (c) indicating that a vehicle using the parking place shall proceed in a specified direction within the parking place,

no person shall leave a vehicle in a place where parking is indicated to be prohibited or drive or permit to be driven any vehicle:-

- (i) so that it enters the parking place otherwise than by an entrance, or leaves the parking place otherwise than by an exit, so indicated, or
  - (ii) in a direction other than so specified.
- (2) Any person in a parking place shall comply with any reasonable direction by a person authorised in that behalf by the Council or a police officer in uniform whether as to the driving or positioning of a vehicle or otherwise and shall upon request

provide his name and address and the name and address of the owner of the vehicle which he or she is driving.

- 12 The Council accepts no responsibility, either at common law or under the Occupiers Liability Act 1957, or otherwise, for loss of or damage to vehicles or other property left in any of the Council's parking places.

## **SPECIAL CONDITIONS APPERTAINING**

### **PARKING PLACES ORDER – SCHEDULE**

#### **PART II**

#### **1 COUNCIL OFFICES, CHILTERN AVENUE, AMERSHAM PARKING PLACE**

- i) On weekdays Monday to Friday inclusive the parking place shall be utilised for parking by authorised staff and members of Chiltern District Council and Buckinghamshire County Council and shall be used by no other person during the period specified, except where expressly provided for in writing.
- ii) Except as provided by paragraph (i) hereto the parking place may be used by the public on weekdays Monday to Friday inclusive between the hours of 5.30 pm and midnight at no charge.
- iii) The parking place may also be used by the public on Saturdays, Sundays and Bank Holidays without any restriction on the length of period of parking and at no charge.

#### **2 AMERSHAM BRANCH LIBRARY EXTENDED PARKING PLACE**

- i) Except as provided by paragraph (iii) hereto the parking place shall be utilised for parking by authorised library staff and members of Chiltern District Council and Buckinghamshire County Council and by drivers whilst visiting the Branch Library or the Council Offices only during the hours of 7.30 am to 6.00 pm Monday to Friday inclusive and shall not be so used during the period specified by any other person.
- ii) A driver using the Car Park whilst visiting the Library or the Council Offices shall not cause a motor vehicle to wait or permit it to be left in the parking place for more than two hours in any period of four hours.
- iii) The parking place, excepting those bays so defined in the parking place, may be used by the public on Saturday, during the hours of 7.30 am to 6.00 pm, but subject to the conditions as to length of stay laid out in (ii) hereto and displaying a ticket as required in (iv) hereto.
- iv) A driver using the Library Car Park shall obtain a free ticket from the ticket machine and display it in their vehicle in accordance with Article 4 of this Order.
- v) The parking place may be used by the public on Sundays and Bank Holidays without any restriction on the length of period of parking and at no charge.

### **3 COMMUNITY CENTRE PARKING PLACE, AMERSHAM**

- i) The 42 parking bays within the parking place so designated shall be used for parking only by staff and visitors to the Community Centre, its Annexe and Youth Club. The designated parking bays may at any time be protected by means of barriers or fencing and locked for periods to prevent their use by unauthorised persons.
- ii) The remainder of the parking place may be used by the public and will be operated on the “Pay and Display” method between 7.30 am and 6.00 pm, Monday to Saturday inclusive, at the charges set out in Column 3 of Part 1 of the Schedule.
- iii) A driver shall not cause a vehicle to wait or permit it to be left in the parking place for more than one three hour period per ticket purchased.
- iv) The parking bays, excepting those defined in (i) hereto, may be used on Sundays and Bank Holidays without any restriction on the length of period of parking and at no charge.

### **4 STAR YARD AND CATLINGS, CHESHAM PARKING PLACES**

- i) A driver shall not cause a vehicle to wait or permit it be left in the parking place for more than one three-hour period during the period 7.30 am to 6.00 pm on Monday to Saturday inclusive.
- ii) Tickets, issued on payment of the initial charge at Star Yard, Chesham Parking Place may be used at Catlings, Chesham Parking Place and vice versa but are not transferable between users of these car parks.

### **5 SNELLS WOOD, LITTLE CHALFONT PARKING PLACE**

- i) A driver shall not cause a vehicle to wait or permit it to be left in the parking place for more than one five-hour period per ticket purchased during the period 7.30 am to 6.00 pm on Monday to Saturday inclusive. N
- ii) A fixed number of non-transferable permits are available for use by local residents or local businesses in the parking place, without time restriction, at the same charge as a Group B Season Ticket.

### **6 THE CHILTERN POOLS, AMERSHAM**

- i) The parking place may only be used by customers of The Chiltern Pools, Amersham.

- ii) The parking place will be operated on the “Pay and Display” method between 7.30 am and 6.00 pm, Monday to Saturday inclusive, at the charges set out in Column 3 of Part 1 of the Schedule.
- iii) A driver shall not cause a vehicle to wait or permit it to be left in the parking place for more than one three-hour period per ticket purchased.

**7 COMMERCIAL VEHICLES EXCEEDING 1525 kg IN UNLADEN WEIGHT AND PASSENGER CARRYING VEHICLES (CLASS 5)**

Vehicles which exceed 1525 kg unladen weight and passenger carrying vehicles with a capacity of over 12 seats may park between the hours of 6.00 pm and 7.30 am only, Monday to Sunday inclusive, at a charge of £5.00 at the following parking places:

- a) High Street, Prestwood
- b) Snells Wood, Little Chalfont
- c) Star Yard, Chesham
- d) Church Lane, Chalfont St Peter

Such vehicles may also park in at High Street, Prestwood between 7.30 am and 6.00 pm on Saturdays on payment of £5.00 and between 7.30 am and 6.00 pm on Sundays and Bank Holidays without any payment.

**8 STATION CAR PARK, AMERSHAM**

- i) A number of reserved spaces are available to specifically, designated season ticket holders for their exclusive use on payment the charge set out in accordance with Column 5 of Part I of the Schedule.
- ii) A section of the Car Park is reserved for London Underground Staff who display a valid London Underground permit.
- iii) Smoking is prohibited within the Multi-storey complex.
- iv) Members of the public may not park:
  - a. in a space specifically reserved for designated season ticket holders.
  - b. in the section of the parking place reserved for London Underground Staff.



**9 DOVECOTE MEADOW, AMERSHAM PARKING PLACE**

Vehicles with a width in excess of 2 metres (6ft 6ins) are not permitted to use the parking place as the entrance and exit are restricted by the use of rising bollards.

**10 SYCAMORE ROAD, AMERSHAM PARKING PLACE**

Market Traders' vehicles may be parked in the parking place on Tuesdays only at a charge of £3.00 per day.

**11 WATER MEADOW, CHESHAM PARKING PLACE**

Market Traders' vehicles may be parked in the parking place on Wednesdays and Saturdays at a charge of £3.00 per day.

**12 LOADING AND UNLOADING**

Commercial vehicles in Class 5 (exceeding 1525 kg unladen weight) may remain stationary in the following car parks for the purpose of loading or unloading at any premises accessed from the said car parks provided that no such vehicle shall be left unattended for a period in excess of 10 minutes. The Car Parks where such loading and unloading is permitted are Star Yard, Chesham; Catlings, Chesham; Saffron Meadow, Chesham; Albany Place, Chesham; Water Meadow, Chesham; Sycamore Road, Amersham; Blizzards Yard, Chalfont St Giles; Church Lane, Chalfont St Peter.

**13 INTER-AVAILABILITY OF SEASON TICKETS**

Season tickets issued in respect of a parking place in Group A may be used in any parking place in Groups A or B. Season tickets issued in respect of a parking place in Group B may be used in any parking place in Group B only.

## **14 FORMULA FOR CALCULATION OF SEASON TICKETS**

- i) Season tickets are available at the car parks listed at paragraph 13 hereto for periods of one, three, six and twelve months. The formula for calculating season tickets charges is “all day charge X 5 days X 52 weeks”. A 25% discount is then applied to all season tickets for 12 months, 20% discount for 6 months and 10% discount for 3 months and 1 month.
- ii) The charge for a reserved space, as provided by paragraph 8(i) of Part II of the Schedule, in the Station Car Park, Amersham is 2 times the formula as defined at paragraph 14(i) hereto. Only season tickets for 12 months and 6 months are available. A 25% discount is applicable to all season tickets for 12 months and 20% discount for 6 months.

## **PART III**

### **1 CLASSES OF VEHICLES**

1. Motor cars within the provision of Section 136(2)(a) of the Act.
2. Motor vehicles constructed or adapted for use for the conveyance of goods or burden, the unladen weight of which does not exceed 1525 kg and passenger carrying vehicles with a capacity of 12 seats or under, other than motor cars.
3. Vehicles displaying a Disabled Person’s Badge.
4. Motorcycles as defined in Section 136(4) of the Act.
5. Motor vehicles constructed for use for the conveyance of goods or burden, the unladen weight of which exceeds 1525 kg and passenger carrying vehicles with a capacity of over 12 seats.

### **3 FREE PARKING**

There shall be no charge payable in any parking place for parking a vehicle falling within Class 1 - 4 of paragraph 1 of Part III of the Schedule.

- i) between 6.00 pm and 7.30 am the following morning, or
- ii) between 7.30 am and 6.00 pm on a Sunday or Bank Holiday

## **PART IV**

### **1 EXCESS CHARGE**

- i) The excess charge referred to in the Order shall be £90.00 in respect of a contravention of paragraph (3) of Article 3 of this Order (using a parking bay available only for a disabled person's vehicle), provided that if the excess charge is paid within seven days of the contravention the excess charge shall be reduced to £60.00.
- ii) The excess charge referred to in the Order shall be £60.00 in respect of all other contraventions of the Order provided that if the excess charge is paid within seven days of the contravention the excess charge shall be reduced to £40.00.
