OFF-STREET PARKING PLACES AMENDMENT (No.1) ORDER 2004

The Council of the Chiltern District in the County of Buckingham (hereinafter referred to as “the Council”) in exercise of its powers under Section 35(1) and (3) of the Road Traffic Regulation Act 1984 as amended by the Parking Act 1989 (which said Act of 1984 is hereinafter referred to as “the Act”) and Part IV of Schedule 9 to the Act and all other enabling powers and with the consent of the Buckinghamshire County Council in accordance with Section 39(3) of the Act and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act, HEREBY MAKES the following Order:-

- 1 (1) This Order is supplemental to the Chiltern District Council Off-Street Parking Places Order 2004 (“the Original Order”) which subject as hereinafter mentioned remains in full force and effect.
 - (2) This Order shall come into operation on 10th January 2005 and may be cited as the Chiltern District Council Off-Street Parking Places Amendment (No. 1) Order 2004 (“the Order”).
 - (3) Definitions are set out in the Original Order.
- 2 (1) Page 1 first paragraph of the Original Order shall be amended as follows:
 - (2) Delete “the” before “the Council” and delete “the” before “the Act”.

- 3 (1) Article 2 of Part II of the Schedule of the Original Order shall be amended as follows:
- (2) Delete “AMERSHAM BRANCH LIBRARY EXTENDED PARKING PLACE” and insert as follows:
- “CIVIC CENTRE PARKING PLACE, AMERSHAM
- i) A driver shall not cause a motor vehicle to wait or permit it to be left in the parking place for more than two hours in any period of 4 hours during the period 7.30 am to 6.00 pm on Monday to Saturday inclusive.
- ii) A driver using the Civic Centre Car Park, for a period of half an hour, may do so free of charge but shall obtain a free ticket from the ticket machine and display it in their vehicle in accordance with Article 4 of this Order.”
- (3) Delete Article 2(i), 2(ii), 2(iii), 2(iv) and 2(v).
- (4) Drawing No. PRT 3073 shall be removed from Part V of the Schedule of the Original Order and shall be replaced with Drawing No.PRT 3142.
- 4 (1) Article 3 of Part II of the Schedule of the Original Order shall be amended as follows:
- (2) Delete “COMMUNITY CENTRE PARKING PLACE, AMERSHAM” and insert as follows:
- “CHILTERN AVENUE PARKING PLACE, AMERSHAM
- A driver shall not cause a vehicle to wait or permit it to be left in the parking place for more than one five hour period per ticket purchased during the period 7.30 am to 6.00 pm on Monday to Saturday inclusive.”
- (3) Delete Article 3(i), 3(ii), 3(iii) and 3(iv).
- (4) Drawing No. PRT 3078 shall be removed from Part V of the Schedule of the Original Order and shall be replaced with Drawing No.PRT 3143.
- 5 (1) Article 6(iii) of Part II of the Schedule of the Original Order shall be amended as follows:
- (2) After “per ticket purchased” add “during the period 7.30 am to 6.00 pm on Monday to Saturday inclusive.”

- 6 (1) Row 4 of Part I of the Schedule of the Original Order shall be amended as follows:
- (2) Column 4. Delete “One period not exceeding 5 hours between 7.30 am to 6.00 pm Mon-Sat incl.” and insert as follows:
- “No Limit”
- 7 (1) Row 5 of Part I of the Schedule of the Original Order shall be amended as follows:
- (2) Column 1. Delete “Community Centre” and replace with “Chiltern Avenue”
- (3) Column 3. After “Up to 2 hours – 70p” delete “Up to 3 hours - £2.00” and insert as follows:
- “Up to 4 hours - £2.00
Up to 5 hours - £2.50”
- (4) Column 4. Delete “One period not exceeding 3 Hours between 7.30 am to 6.00 pm” and insert as follows:
- “No Limit”
- 8 (1) Row 16 of Part I of the Schedule of the Original Order shall be amended as follows:
- (2) Column 1. Delete “Library” and replace with “Civic Centre”.
- (3) Column 3. Delete “Mon-Fri incl. (by drivers whilst visiting the Library and Council Offices only) between hours 7.30 am and 6.00 pm No Charge. Free ticket must be obtained from ticket machine and displayed in accordance with Article 4 of this Order. Saturday (by members of the public) between hours 7.30 am and 6.00 pm No Charge. Free ticket must be obtained from ticket machine and displayed in accordance with Article 4 of this Order.”
- and replace with:
- “Mon-Sat incl. between hours 7.30 am and 6.00 pm
Up to ½ hour - No Charge
Up to 1 hour - 30p
Up to 2 hours - 70p
Note: For ½ hour free parking a free ticket must be obtained from the ticket machine and displayed in accordance with Article 4 of this Order.”
- (4) Column 4. Delete the following words as it first appears:

“2 hours in any period of 4 hours between 7.30 am and 6.00 pm.”

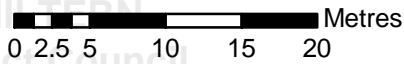
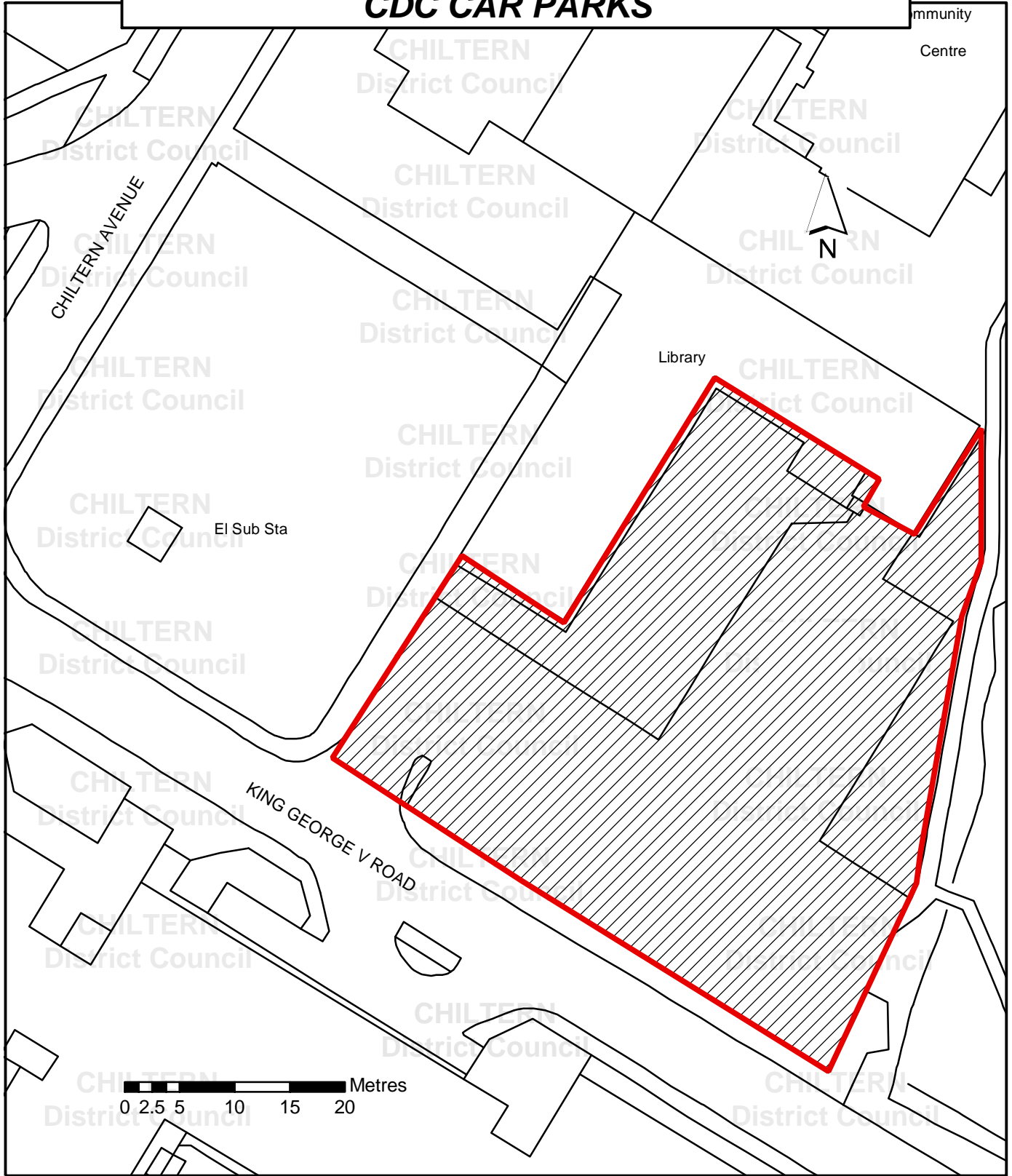
- 9 The Plans attached to this Order shall be treated as plans referred to in Article 3(4) and 4(4) of the Order and Part V of the Original Order.

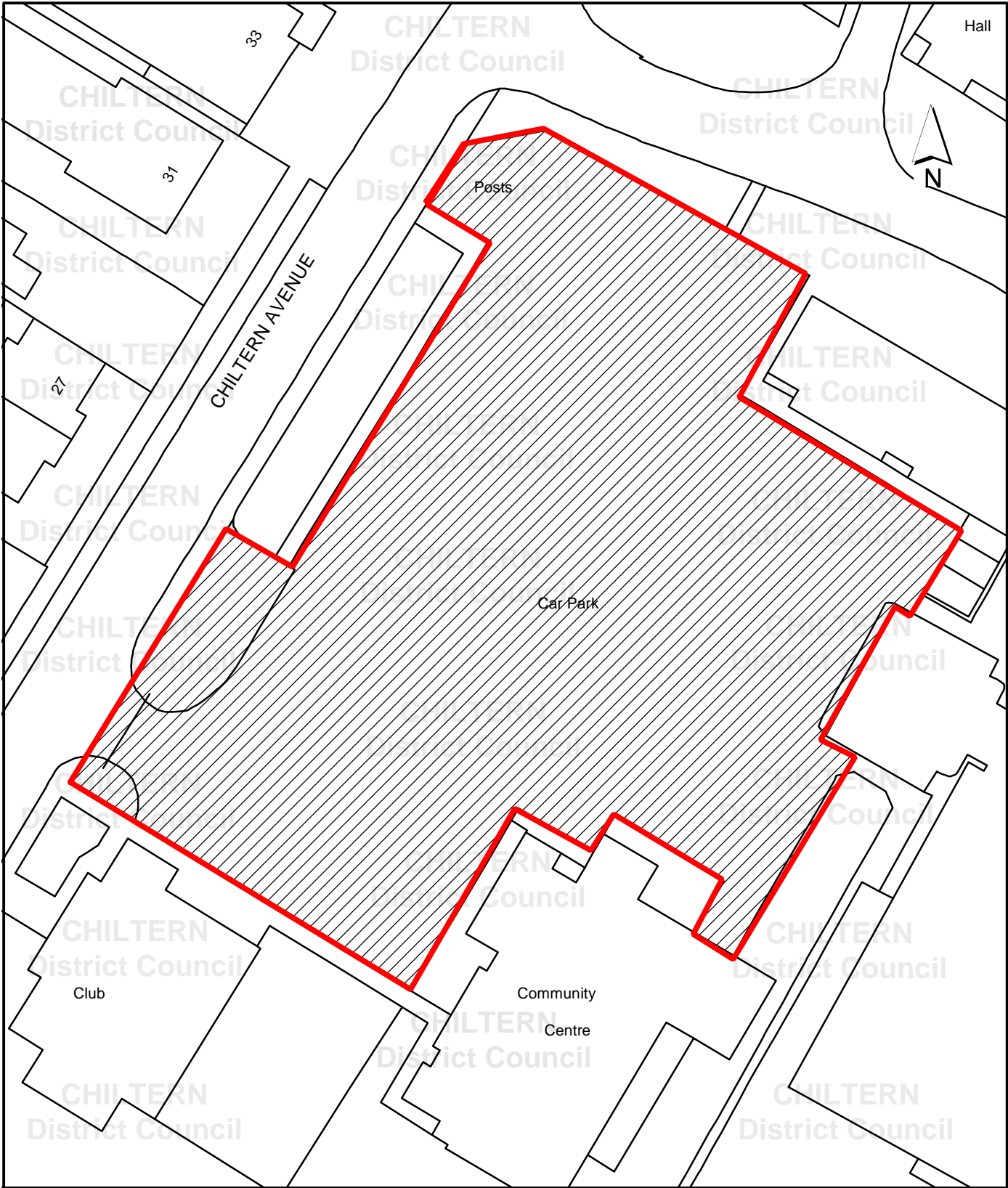
