## **OFF-STREET PARKING PLACES AMENDMENT (No.2) ORDER 2005**

The Council of the Chiltern District in the County of Buckingham (hereinafter referred to as "the Council") in exercise of its powers under Section 35(1) and (3) of the Road Traffic Regulation Act 1984 as amended by the Parking Act 1989 (which said Act of 1984 is hereinafter referred to as "the Act") and Part IV of Schedule 9 to the Act and all other enabling powers and with the consent of the Buckinghamshire County Council in accordance with Section 39(3) of the Act and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act, HEREBY MAKES the following Order:-

- 1 (1) This Order is supplemental to the Chiltern District Council Off-Street Parking Places Order 2004 (as amended) ("the Original Order") which subject as hereinafter mentioned remains in full force and effect.
  - (2) This Order shall come into operation on 18<sup>th</sup> April 2005 and may be cited as the Chiltern District Council Off-Street Parking Places Amendment (No. 2) Order 2005.
  - (3) Definitions are set out in the Original Order.
- 2 (1) After Article 4(1) of the Original Order insert a new Article 4(2) as follows:

"(2) The Council may from time to time determine not to collect a charge and/or charges at a parking place and information relating to a change in the collection of a charge and/or charges would be indicated on the 'Pay and Display' Notice in the parking place where it applied."

- (2) Article 4(2) of the Original Order shall be renumbered as Article 4(3).
- (3) Article 4(3) of the Original Order shall be renumbered as Article 4(4).
- (4) Article 4(4) of the Original Order shall be renumbered as Article 4(5).
- 3 Article 4(5) of the Original Order shall be renumbered as Article 4(6) and amended as follows:

After "expedient" insert "at a charge applicable at the time of application and/or issue."

- 4 Article 4(6) of the Original Order shall be renumbered as Article 4(7).
- 5 Article 6(1)(b) of the Original Order shall be amended as follows:

Insert "the date and" before "the time".

6 Row 4, Column 5 of Part I of the Schedule of the Original Order shall be amended as follows:

After "No Season Tickets" delete "Non-transferable Permits for local residents and business available from the Council – Charge as for Group B Season Tickets."

and insert as follows:

"A fixed number of permits which are not transferable between parking places but are transferable between the users to whom the permits have been issued for local residents and business available from the Council – No Time Limit – Charge as for Group B Season Tickets."

7 Paragraph 5(ii) of Part II of the Schedule of the Original Order shall be amended as follows:

After "A fixed number of" delete "non-transferable permits" and insert as follows:

"permits which are not transferable between parking places but are transferable between the users to whom the permits have been issued"

8 Paragraph 12 of Part II of the Schedule of the Original Order shall be amended as follows:

After "purpose of" insert "constant and reasonable"

delete "Saffron Meadow, Chesham;" After "Catlings, Chesham;" and insert as follows:

"the Access Road which forms part of the Saffron Meadow Car Park, Chesham;"

Paragraph 2 of Part III of the Schedule of the Original Order shall be amended as follows:

Delete "Community Centre Car Park" and insert "Chiltern Avenue Car Park" and delete "Library Car Park" and insert Civic Centre Car Park".

Delete the list of parking places and number of parking bays which are listed after "The number of parking bays provided solely for the use of vehicles displaying a Disabled Person's Badge are detailed below: and insert a new list as follows:

## **Prestwood** High Street Car Park

10 Paragraph 3 of Part III of the Schedule of the Original Order shall be amended as follows:

After "3 FREE PARKING" delete the following:

"There shall be no charge payable in any parking place for parking a vehicle falling within Class 1 - 4 of paragraph 1 of Part III of the Schedule.

- i) between 6.00 pm and 7.30 am the following morning, or
- ii) between 7.30 am and 6.00 pm on a Sunday or Bank Holiday"

and insert as follows:

"i) There shall be no charge payable in any parking place for parking a vehicle falling within Class 1 - 2 of paragraph 1 of Part III of the Schedule.

- a. between 6.00 pm and 7.30 am the following morning, or
- b. between 7.30 am and 6.00 pm on a Sunday or Bank Holiday.
- ii) Vehicles falling in Class 3 and Class 4 of paragraph 1 of Part III of the Schedule are exempt from payment."
