The Council of the Chiltern District in the County of Buckingham (hereinafter referred to as "the Council") in exercise of its powers under Section 35(1) and (3) of the Road Traffic Regulation Act 1984 as amended by the Parking Act 1989 (which said Act of 1984 is hereinafter referred to as "the Act") and Part IV of Schedule 9 to the Act and all other enabling powers and with the consent of the Buckinghamshire County Council in accordance with Section 39(3) of the Act and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act, HEREBY MAKES the following Order:-

- 1 (1) This Order is supplemental to the Chiltern District Council Off-Street
 Parking Places Order 2004 (as amended) ("the Original Order")
 which subject as hereinafter mentioned remains in full force and
 effect.
 - (2) This Order shall come into operation on 2nd July 2007 and may be cited as the Chiltern District Council Off-Street Parking Places Amendment (No. 4) Order 2007.
 - (3) Definitions are set out in the Original Order.
- 2 Row 3, Column 3 of Part I of the Schedule of the Original Order shall be amended as follows:
 - After "Up to 3 hours £1.50" delete "Up to 4 hours £2.00" and "Over 4 hours £3.00".

Row 3, Column 5 of Part I of the Schedule of the Original Order shall be amended as follows:

Delete "1 month - £58.50 3 months - £175.50 6 months - £312.00 12 months - £585.00 Group B".

- Drawing No. PRT3077 shall be removed from Part IV of the Schedule of the Original Order and shall be replaced with Drawing No. PRT3242 which delineates the extent of Sycamore Road Parking Place, Amersham including the extended area which has now been incorporated in the parking place.






SYCAMORE ROAD AMERSHAM
