### OFF-STREET PARKING PLACES AMENDMENT (No. 6) ORDER 2008

The Council of the Chiltern District in the County of Buckinghamshire (hereinafter referred to as “the Council”) in exercise of its powers under Section 35(1) and (3) and under Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (“the Act”) as amended by the Parking Act 1989, the Traffic Management Act 2004 (“the 2004 Act”) and all Regulations and Orders made in exercise of the powers conferred by the 2004 Act and all other enabling powers, with the consent of the Buckinghamshire County Council in accordance with Section 39(3) of the Act and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act, HEREBY MAKES the following Order:-

1.
  - (1) This Order is supplemental to the Chiltern District Council Off-Street Parking Places Order 2004 (as amended) (“the Original Order”) which subject as hereinafter mentioned remains in full force and effect.
  - (2) This Order shall come into operation on 5 January 2009 and may be cited as the Chiltern District Council Off-Street Parking Places Amendment (No. 6) Order 2008 (“the Amendment Order”).
  - (3) Definitions are set out in the Original Order.
2. Paragraph 13 of Part II of the Schedule of the Original Order (Inter-Availability of Season Tickets) shall be amended as follows:

Delete from “Season tickets issued in respect of” to the end of Paragraph 13.

and insert

“Season tickets issued in respect of a parking place in Group A may be used in any parking place in Groups A, B or C. Season tickets issued in respect of

a parking place in Group B may be used in any parking place in Groups B or C. Season tickets issued in respect of a parking place in Group C may be used in any parking place in Group C only.

3. Paragraph 14 of Part II of the Schedule of the Original Order (Formula for Calculation of Season Tickets) shall be amended as follows:

Delete from "i) Season tickets are available" to the end of Paragraph 14.

and insert

"The Formula for Calculation of Season Tickets, as from time to time approved by the Council, is accessible to view on the Council's website and available for public inspection at Customer Services, Council Offices, King George V Road, Amersham, Bucks HP6 5AW during normal office hours."

4. Row 10, Column 5 of Part I of the Schedule of the Original Order shall be amended as follows:

Delete "1 month - £62.40 3 months - £187.20 6 months - £332.80 12 months - £624.00 Group B".

and insert

"1 month - £48.53 3 months - £154.60 6 months - £270.40 12 months - £499.20 Group C".

5. Row 13, Column 5 of Part I of the Schedule of the Original Order shall be amended as follows:

Delete "1 month - £62.40 3 months - £187.20 6 months - £332.80 12 months - £624.00 Group B".

and insert

"1 month - £48.53 3 months - £154.60 6 months - £270.40 12 months - £499.20 Group C".

6. Row 14, Column 5 of Part I of the Schedule of the Original Order shall be amended as follows:

Delete "1 month - £62.40 3 months - £187.20 6 months - £332.80 12 months - £624.00 Group B".

and insert

"1 month - £48.53 3 months - £154.60 6 months - £270.40 12 months - £499.20 Group C".
