## The Essex County Council (Colchester Borough) (Waiting Restriction) (Consolidation) (Amendment No. 4) Order 2008

Essex County Council in exercise of the powers conferred on that County Council under Sections 1(1), 2(1) to (3), 4(1) and 4(2) of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

- 1. This Order may be cited as the Essex County Council (Colchester Borough) (Waiting Restriction) (Consolidation) (Amendment No. 4) Order 2008 and shall come into operation on 14 July 2008.
- 2. The Essex County Council (Colchester Borough) (Waiting Restriction) (Consolidation) Order 2008 is hereby varied to the extent detailed in the Schedule to this Order.
- The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act or by or under any other enactment.

### Schedule

## The Essex County Council (Colchester Borough) (Waiting Restriction) (Consolidation) Order 2008 is varied as follows:-

### Insert new Article 6(Ivii):-

**6(Ivii)** – Save as provided in Article 8A no person shall, except upon the direction or with the permission of a Police Constable in uniform or a Parking Attendant, cause or permit any vehicle to wait between 8.00am and 6.00pm on Mondays to Saturdays inclusive in the length of road specified in Schedule 43B for a longer period than 30 minutes or, if a period of less than 2 hours has elapsed since the previous period of waiting by the same vehicle in the same length of road

### Insert new Article 8A:-

**8A** – Nothing in Article 6(Ivii) shall apply to any vehicle issued with a permit under the terms of Schedule P and Schedules 1 and 2 of The Essex County Council (Colchester Borough) (Permitted Parking Area and Special Parking Area) (Consolidation) Order 2008

Article 9 (1) - add schedule 43B to (c)

### List of Schedules:-

Add the following schedule – Schedule 43B – Limited Waiting 30 mins, no return within 2 hours, except permit holders

<u>Schedule 1 – No Waiting at any Time, The Essex County Council</u>
(Colchester Borough) (Waiting Restriction) (Consolidation) Order 2008 is varied as follows:-

### Butt Road Delete:-

- (i) both sides from its junction with Drury Road to a point 18 metres north-east of its junction with Constantine Road
- (ii) the north-west side from a point 16 metres south-west of its junction with Hamilton Road to a point 26.5 metres north-east of that junction
- (iii) the north-west side from a point 9 metres north-east of its junction with Errington Road to a point 10 metres south-west of that junction
- (iv) the south-east side from its junction with Circular Road West southwest for a distance of 84.5 metres
- (v) the south-east side from its junction with Circular Road West to a point 5.5 metres north-east of that junction

### Insert:-

- (i) the north-west side from its junction with Drury Road to a point 20.5 metres north-east of its junction with Constantine Road
- (ii) the north-west side from a point 14.8 metres south-west of its junction with Hamilton Road north-east to a point 8.8 metres north-east of its junction with Errington Road

- (iii) the south-east side from its junction with Drury Road east then northeast for a distance of 100 metres
- (iv) the south-east side from a point 65 metres south-east of its junction with Circular Road West north-east to a point 46 metres north-east of that junction

### Circular Road West Delete:-

(i) both sides from its junction with Butt Road south-eastwards for a distance of 13.7 metres

### Insert:-

(i) both sides from its junction with Butt Road south-east for a distance of 13 metres

# <u>Schedule 5 – No Waiting Mon-Sat 8am-6pm, The Essex County Council</u> (Colchester Borough) (Waiting Restriction) (Consolidation) Order 2008 is varied as follows:-

### Delete:-

**Butt Road** – the south-east side from a point 5.5 metres north-east of its junction with Circular Road West to a point 30.5 metres north-east of the northern kerbline of Wickham Road

#### Insert:-

**Butt Road** – the south-east side from a point 46 metres north-east of its junction with Circular Road West north-east for a distance of 212.5 metres

# <u>Schedule 43 – Limited Waiting 30 mins no return 2 hours Mon-Sat 8am – 6pm, The Essex County Council (Colchester Borough) (Waiting Restriction)</u> (Consolidation) Order 2008 is varied as follows:-

### Delete:-

**Butt Road** – the south-east side from a point 84.5 metres south-west of its junction with Circular Road West to a point 129 metres north-east of its junction with Drury Road

### <u>Insert new Schedule 43B – Limited Waiting 30 mins no return 2 hours</u> <u>Mon-Sat 8am-6pm except permit holders</u>

**Butt Road** – the south-east side from a point 100 metres north-east of its junction with Drury Road north-east for a distance of 22 metres
