

**The Essex County Council (Colchester Borough) (Permitted Parking Area and Special Parking Area) (Consolidation) (Amendment No.3) Order 2009**

WHEREAS Essex County Council in exercise of the powers conferred on that County Council under Sections 1(1), 2(1) to (3), 4(1), 4(2), 45, 46 and 49 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. This Order may be cited as The Essex County Council (Colchester Borough) (Permitted Parking Area and Special Parking Area) (Consolidation) (Amendment No.3) Order 2009 and shall come into operation on 27 April 2009.
2. The Essex County Council (Colchester Borough) (Permitted Parking Area and Special Parking Area) (Consolidation) Order 2008 is hereby varied to the extent detailed in the Schedule to this Order.
3. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act or by or under any other enactment.

**To introduce/vary 'St Paul's zone' (Schedule H) permit holders only 24 Hours daily** restrictions on the following length of road in Colchester in the Borough of Colchester (these will amend The Essex County Council (Colchester Borough) (Permitted Parking Area and Special Parking Area) (Consolidation) Order 2008:

**John Harper Street**

**To revoke the existing description:**

**North side:** From its western end eastwards for a distance of 30 metres

**To introduce:**

**North side:** From a point 10 metres west of its junction with North Station Road west for a distance of 41 metres

**To introduce 'Oxford Road and Creffield Road Zone' (Schedule E1) permit holders only 8am-6pm Mon-Sat** restrictions on the following length of road in Colchester in the Borough of Colchester (these will amend The Essex County Council (Colchester Borough) (Permitted Parking Area and Special Parking Area) (Consolidation) Order 2008:

**Maldon Road**

**To introduce:**

**North-west side:** From a point 48 metres north-east of its junction with Cambridge Road north-east for a distance of 16 metres
