

**The Essex County Council (Colchester Borough) (Waiting Restriction)  
(Consolidation) (Amendment No.10) Order 2009**

**WHEREAS** the Essex County Council in exercise of its powers under Sections 1(1), 2(1) to (3), 4(1), 4(2), 32, 35, 45, 46, 49 and 53 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. This Order may be cited as the Essex County Council (Colchester Borough) (Waiting Restriction) (Consolidation) (Amendment No.10) Order 2009 and shall come into operation on 22 June 2009.
2. The Essex County Council (Colchester Borough) (Waiting Restriction) (Consolidation) Order 2008 is hereby varied to the extent detailed in the Schedule to this Order.
3. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act or by or under any other enactment.

## SCHEDULE

### The Essex County Council (Colchester Borough) (Waiting Restriction) (Consolidation) Order 2008 is varied as follows:-

#### No Waiting At Any Time restrictions to be introduced (Existing restrictions contained within Schedule 1 of the 2008 Order)

##### Hythe Station Road, Colchester

###### **To introduce:**

- (i) the north side from a point 25 metres west of its junction with Greenstead Road in a westerly direction for a distance of 57 metres
- (ii) the south side from a point 25 metres west of its junction with Greenstead Road in a westerly direction for a distance of 57 metres

#### No Waiting Monday-Saturday 8am-6pm restrictions to be introduced or revoked (Existing restrictions contained within Schedule 5 of the 2008 Order)

##### Hythe Station Road, Colchester

###### **To revoke:**

- (i) the north side from a point 25 metres south-west of its junction with Greenstead Road to a point 121 metres south-west of that junction
- (ii) the north-west side from its junction with Hythe Quay in a north-easterly direction for a distance of 126 metres measured along the kerbline
- (iii) the south side from a point 25 metres south-west of its junction with Greenstead Road to a point 121 metres south-west of that junction

###### **To introduce:**

- (i) both sides from its junction with Hawkins Road to its junction with Hythe Quay
