

**The Essex County Council (Colchester Borough) (Waiting Restriction)
(Consolidation) (Amendment No.8) Order 2009**

WHEREAS the Essex County Council in exercise of its powers under Sections 1(1), 2(1) to (3), 4(1), 4(2), 32, 35, 45, 46, 49 and 53 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. This Order may be cited as The Essex County Council (Colchester Borough) (Waiting Restriction) (Consolidation) (Amendment No. 8) Order 2009 and shall come into operation on 1 September 2009.
2. The Essex County Council (Colchester Borough) (Waiting Restriction) (Consolidation) Order 2008 is hereby varied to the extent detailed in the Schedule to this Order.
3. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act or by or under any other enactment.

SCHEDULE

The Essex County Council (Colchester Borough) (Waiting Restriction) (Consolidation) Order 2008 is varied as follows:-

Insert new Article 16(h):-

6(h) – No person shall, except upon the direction or with the permission of a Police Constable in uniform or a Civil Enforcement Officer, cause or permit any vehicle other than a Hackney Carriage to stop or wait between midnight and 8am Monday, 6pm and 8am Monday to Saturday, 6pm to midnight Saturday and at any time Sunday in the lengths of road specified in Schedule 55A

List of Schedules:-

Add the following schedule – Schedule 55A – Taxi Ranks – Mon-Sat 6pm-8am and at any time Sunday

No Waiting At Any Time/No Loading Mon-Sat 8am – 930am and 4pm – 6pm restrictions to be introduced or revoked (Existing restrictions contained within Schedule 27 of the 2008 Order)

Head Street, Colchester

To revoke:

- (i) the east side from its junction with Headgate to a point 39 metres north of its junction with Sir Isaacs Walk

To introduce:

- (i) the east side from its junction with Sir Isaacs Walk north for a distance of 23 metres

No Stopping except Hackney Carriages – 24 hours daily – restrictions to be introduced (existing restrictions contained within Schedule 55 of the 2008 Order)

Head Street, Colchester

To introduce:

- (i) the east side from a point 23 metres north of its junction with Sir Isaacs Walk north to a point 39 metres north of its junction with Sir Isaacs Walk

No Stopping except Hackney Carriages Mon-Sat 6pm-8am and at any time on Sunday restrictions to be introduced (to be inserted as new Schedule 55A to the 2008 Order)

Queen Street, Colchester

To introduce:

- (i) the west side from a point 39.5 metres north of its junction with St Botolph's Street north for a distance of 23.5 metres

Goods Vehicle Loading Bays Mon-Sat 8am-6pm to be introduced or revoked (existing restrictions contained within Schedule 67 of the 2008 Order)

Queen Street, Colchester

To revoke:

- (i) the west side from a point 52 metres north of its junction with St Botolph's Street north for a distance of 30 metres

To introduce:

- (i) the west side from a point 39.5 metres north of its junction with St Botolph's Street north for a distance of 23.5 metres
