The Essex County Council (Colchester Borough) (Waiting Restriction) (Consolidation) (Amendment No.15) Order 2009

WHEREAS the Essex County Council in exercise of its powers under Sections 1(1), 2(1) to (3), 4(1), 4(2), 32, 35, 45, 46, 49 and 53 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

- This Order may be cited as the Essex County Council (Colchester Borough) (Waiting Restriction) (Consolidation) (Amendment No.15) Order 2009 and shall come into operation on 14 December 2009.
- 2. The Essex County Council (Colchester Borough) (Waiting Restriction) (Consolidation) Order 2008 is hereby varied to the extent detailed in Schedule 1 to this Order.
- 3. The Essex County Council (Colchester Borough) (Waiting Restriction) (Consolidation) (Amendment No.11) Order 2009 is hereby varied to the extent detailed in Schedule 2 to this Order.
- 4. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act or by or under any other enactment.
- 5. The Essex County Council (Colchester Borough) (Waiting Restriction) (Consolidation) (Amendment No.7) Order 2009 is hereby revoked.
