

The Essex County Council (Colchester Borough) (Permitted Parking Area and Special Parking Area) (Consolidation) (Amendment No.5) Order 2010

WHEREAS the Essex County Council in exercise of its powers under Sections 1(1), 2(1) to (3), 4(1), 4(2), 32, 35, 45, 46, 49 and 53 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. This Order may be cited as The Essex County Council (Colchester Borough) (Permitted Parking Area and Special Parking Area) (Consolidation) (Amendment No.5) Order 2010 and shall come into operation on 8 March 2010.
2. The Essex County Council (Colchester Borough) (Permitted Parking Area and Special Parking Area) (Consolidation) Order 2008 is hereby varied to the extent detailed in the Schedule to this Order.
3. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act or by or under any other enactment.

Schedule

The Essex County Council (Colchester Borough) (Permitted Parking Area and Special Parking Area) (Consolidation) Order 2008 is varied as follows:-

Insert new definition in Paragraph 2. of order:-

"Car Share Club vehicle" means a vehicle belonging to any car share organisation

Insert new Article 8(m):-

8(m) – Car Share Club Permit: The Wombat Car Share Club may apply to the Council for a permit for the leaving of a car share club vehicle during the permitted hours in a Parking Place in any authorised parking area specified in Schedule F1 to this Order

To introduce new Schedule F1 – Car Share Club permit holders only - 24 hours daily restrictions on the following length of road in Colchester in the Borough of Colchester

Castle Road

To introduce:

- (i) the east side from a point 2.6 metres north of its junction with the northern kerb line of the east to west leg of Castle Road north for a distance of 6 metres

To introduce/vary 'Roman Road and Castle Road zone' (Schedule F) permit holders only 8am-6pm Mon-Sat (except Public Holidays) restrictions on the following length of road in Colchester in the Borough of Colchester:

Castle Road

To revoke:

- (i) the east side from a point 7 metres south of the boundary between No's 3 & 4 Castle Road northwards for a distance of 86 metres

To introduce:

- (i) the east side from a point 8.6 metres north of its junction with the northern kerb line of the east to west leg of Castle Road north for a distance of 10.5 metres
- (ii) the east side from a point 29.6 metres north of its junction with the northern kerb line of the east to west leg of Castle Road north for a distance of 17.5 metres
- (iii) the east side from a point level with the southern flank wall of No.11 north for a distance of 10.5 metres
- (iv) the east side from a point 3.5 metres north of the northern flank wall of No.13 north for a distance of 52.5 metres
- (v) the east side from a point 6.2 metres north of the northern flank wall of No.23 north for a distance of 50 metres
- (vi) the east side from a point 74 metres south of its junction with Roman Road south for a distance of 16 metres
