- 3. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act or by or under any other enactment.

To introduce/revoke 'St Mary's Area zone' (Schedule G) permit holders only 4pm-10am Mon-Fri & at any time Sats & Suns restrictions on the following length of road in Colchester in the Borough of Colchester:-

Crowhurst Road

To revoke the existing description:

East side: From a point adjacent to the boundary of No.'s 51 & 52 northwards to a point adjacent to the boundary of No.'s 47 & 48

To introduce:

East side: From a point in line with the boundary of No.'s 50 & 51 north to a point in line with the boundary of No.'s 47 & 48

- (i) from a point in line with the southern boundary of No.5 Crowhurst Road north to a point level with the boundary of No.'s 50 & 51

- (ii) from a point 10 metres east of its junction with St Albans Road to a point 9.5 metres west of the extended kerb line of its junction with Rawstorn Road
- (iii) from a point 10 metres east of the extended kerb line of its junction with Rawstorn Road east for a distance of 5.5 metres
- (iv) from a point 21 metres east of the extended kerb line of its junction with Rawstorn Road east to a point 13.7 metres west of its junction with Crowhurst Road

South side:

- (i) from a point 10 metres west of its junction with Rawstorn Road west to a point 3.3 metres east of its western extremity
- (ii) from a point 6.3 metres east of its junction with Rawstorn Road east for a distance of 23.7 metres
- (iii) from a point 8 metres west of its junction with Crowhurst Road west for a distance of 32.5 metres

Pope's Lane

To revoke the existing description:

South side:

(i) from a point 5 metres east of its junction with Crowhurst Road to its eastern end

To introduce:

South side:

(i) from a point 4.8 metres east of its junction with Crowhurst Road east for a distance of 20.4 metres

Rawstorn Road

To revoke the existing descriptions: East side:

- (i) from a point 19 metres south of its junction with Pope's Lane southwards for a distance of 26 metres
- (ii) from a point 51 metres south of its junction with Pope's Lane southwards for a distance of 5 metres
- (iii) from a point 62 metres south of its junction with Pope's Lane to a point 5 metres north of the northern kerb line of Papillon Road
- (iv) from a point 10 metres south of its junction with Papillon Road to a point 19 metres north of its junction with Manor Road
- (v) from a point 5 metres north of its junction with Manor Road northwards for a distance of 5 metres

West side:

- (i) from a point 5 metres south of its junction with Pope's Lane to a point 3 metres north of its junction with Papillon Road

- (iii) from a point 24.5 metres north of its junction with Crouch Street north for a distance of 9.9 metres
- (iv) from a point 5.5 metres south of its junction with Manor Road south for a distance of 5.2 metres

St Alban's Road

East side of the north to south leg:

(i) from a point 20.5 metres north of its junction with Papillon Road north to a point in line with the northern flank wall of No.29

West side of the north to south leg:

- (i) from a point 5 metres north of its junction with Papillon Road north for a distance of 10.3 metres
- (ii) from a point 20.3 metres north of its junction with Papillon Road north to a point 0.7 metres north of the boundary of No.'s 26 and 28

South side of the east to west leg:

(i) from a point 5.5 metres west of the eastern flank wall of No.28 west to a point 16.2 metres east of the eastern garage wall of No.48
