

**The Essex County Council (Colchester Borough) (Waiting Restriction)
(Consolidation) (Amendment No.18) Order 2010**

WHEREAS the Essex County Council in exercise of its powers under Sections 1(1), 2(1) to (3), 4(1), 4(2), 32, 35, 45, 46, 49 and 53 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. This Order may be cited as The Essex County Council (Colchester Borough) (Waiting Restriction) (Consolidation) (Amendment No.18) Order 2010 and shall come into operation on 24 May 2010.
2. The Essex County Council (Colchester Borough) (Waiting Restriction) (Consolidation) Order 2008 is hereby varied to the extent detailed in the Schedule to this Order.
3. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act or by or under any other enactment.

SCHEDULE

The Essex County Council (Colchester Borough) (Waiting Restriction) (Consolidation) Order 2008 is varied as follows:-

No Waiting At Any Time restrictions to be introduced (Existing restrictions contained within Schedule 1 of the 2008 Order)

Mason Road, Colchester

To introduce:

- (i) The north side of its eastern section from its junction with Cowdray Avenue north and west to a point 104 metres east of its junction with the outer kerbline of its western square
- (ii) The north side from its junction with its western square east for a distance of 55 metres
- (iii) The south side from its junction with Cowdray Avenue north and west to its junction with the outer kerbline of its western square
- (iv) The northern outer kerbline of its western square from a point 25 metres east of the eastern flank wall of Unit 16 east then south for a distance of 40 metres
- (v) The eastern outer kerbline of its western square from its junction with the eastern section north for a distance of 38 metres
- (vi) The outer kerbline of the western square from a point 5 metres east of the eastern flank wall of Unit 16 west, south, then east to its junction with the eastern section
- (vii) The inner kerbline of its western square for its entire length

No Waiting Mon-Sat 8am-6pm restrictions to be revoked (existing restrictions contained within Schedule 5 of the 2008 Order)

Mason Road, Colchester

To revoke:

- (i) the north and east sides from a point opposite the south-west corner of No.22 westwards and northwards for a distance of 30 metres
- (ii) southern and western links south and west sides from a point opposite the south-west corner of No.22 westwards and northwards for a distance of 100 metres
- (iii) the north & east side from a point 70 metres north-west of its junction with Cowdray Avenue westwards for a distance of 65 metres
- (iv) the south & west side from a point 47.6 metres north of its junction with Cowdray Avenue north and westwards to a point 15 metres west of its eastern north to south leg
- (v) the north & east side from a point opposite the west side entrance to No.16 eastwards and southwards for a distance of 40 metres
- (vi) the north side northern and eastern sides, from a point 5 metres northwest of the west side access opposite No.16 south-eastwards to a point 5 metres south-east of the east side access opposite No.16
- (vii) the south & west side from a point opposite the west side entrance to No.16 eastwards and southwards for a distance of 30 metres
- (viii) the north side of the east to west leg from a point 15 metres west of its eastern north to south leg to a point 15 metres east of that leg
- (ix) both sides of its eastern north to south leg north from its junction with the east to west leg for a distance of 15 metres
