

**Essex County Council (Colchester Borough) (Waiting Restriction)  
(Consolidation) (Amendment No.19) Order 2010**

Essex County Council in exercise of the powers conferred on that County Council under Sections 1(1), 2(1) to (3), 4(1) and 4(2), 32, 35, 45, 46, 49 and 53 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. This Order may be cited as the Essex County Council (Colchester Borough) (Waiting Restriction) (Consolidation) (Amendment No.19) Order 2010 and shall come into operation on 24 May 2010.
2. The Essex County Council (Colchester Borough) (Waiting Restriction) (Consolidation) Order 2008 is hereby varied to the extent detailed in the Schedule to this Order.
3. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act or by or under any other enactment.

## **SCHEDULE**

### **The Essex County Council (Colchester Borough) (Waiting Restriction) (Consolidation) Order 2008 is varied as follows:-**

#### **No Waiting At Any Time restrictions to be introduced or revoked (Existing restrictions contained within Schedule 1 of the 2008 Order)**

##### **Crouch Street (West), Colchester**

###### **To revoke:**

- (i) the north side from its junction with Rawstorn Road to a point 13.5 metres west of that junction
- (ii) the north side from a point 49.5 metres west of its junction with Rawstorn Road to its western extremity
- (iii) the north side from its junction with Rawstorn Road to a point 21.5 metres east of that junction
- (iv) the south side from its junction with Rawstorn Road to its western extremity
- (v) the south side from its junction with Rawstorn Road to a point 103.5 metres east of that junction

###### **To introduce:**

- (i) the north side from a point 14 metres west of its junction with Rawstorn Road east to a point 21.5 metres east of that junction
- (ii) the north side from a point 30.5 metres west of its junction with Rawstorn Road west for a distance of 3 metres
- (iii) the north side from a point 50 metres west of its junction with Rawstorn Road to and including its western extremity
- (iv) the south side from its junction with its western extremity to a point 113 metres east of its junction with Rawstorn Road including the turning head

##### **Crowhurst Road, Colchester**

###### **To revoke:**

- (i) the east side from its junction with Pope's Lane to a point 14 metres south of that junction
- (ii) the east side from a point in line with the boundary between Nos 47 & 48 Crowhurst Road to a point in line with the northern boundary of No.52 Crowhurst Road
- (iii) the east side from its junction with Manor Road to a point in line with the southern boundary of No.5 Crowhurst Road
- (iv) the west side from its junction with Manor Road to its junction with Papillon Road
- (v) the west side from its junction with Papillon Road to its junction with Pope's Lane

**To introduce:**

- (i) the east side from its junction with Pope's Lane south to a point 14 metres south of that junction
- (ii) the east side from its junction with Manor Road north to a point in line with the southern boundary of No.5
- (iii) the west side from its junction with Manor Road north to its junction with Pope's Lane

**Manor Road, Colchester**

**To revoke:**

- (i) the north side from its junction with Crowhurst Road to its junction with Rawstorn Road
- (ii) the north side from its junction with Crowhurst Road to its eastern extremity including the turning head
- (iii) the north side from its junction with Rawstorn Road to its junction with Hospital Lane
- (iv) the south side from its junction with Rawstorn Road to its eastern extremity
- (v) the south side from its junction with Rawstorn Road to a point 10.5 metres west of that junction
- (vi) the south side from its junction with Hospital Lane to a point 9 metres east of that junction
- (vii) the south side from a point 28 metres west of its junction with Rawstorn Road to a point 9 metres west of that point

**To introduce:**

- (i) both sides from its junction with Rawstorn Road east to its eastern extremity including the turning head
- (ii) the north side from its junction with Rawstorn Road west to its junction with Hospital Lane
- (iii) the south side from its junction with Rawstorn Road west for a distance of 10 metres
- (iv) the south side from its junction with Hospital Lane east for a distance of 5 metres

**Papillon Road, Colchester**

**To revoke:**

- (i) the north side from its junction with St Alban's Road to a point 2.5 metres west of that junction
- (ii) the north side from its junction with St Alban's Road to a point 10.5 metres east of that junction
- (iii) the north side from its junction with Rawstorn Road to a point 7 metres west of that point
- (iv) the north side from its junction with Rawstorn Road to a point 20.5 metres east of that junction
- (v) the north side from its junction with Crowhurst Road to a point 12 metres west of that junction
- (vi) the south side from its junction with Rawstorn Road to a point 15 metres west of that junction

- (vii) the south side from its junction with Crowhurst Road to a point 10.5 metres west of that junction
- (viii) the south side from a point 43 metres west of its junction with Crowhurst Road to a point 6.5 metres west of that point
- (ix) the south side from its junction with Rawstorn Road to a point 6 metres east of that junction

**To introduce:**

- (i) the north side from a point 3 metres west of its junction with St Albans Road to a point 10 metres east of that junction
- (ii) the north side from a point 9.5 metres west of the extended kerbline of its junction with Rawstorn Road to a point 10 metres east of the extended kerbline of that junction
- (iii) the north side from its junction with Crowhurst Road to a point 6 metres west of that junction
- (iv) the south side from its junction with Crowhurst Road to a point 8 metres west of that junction
- (v) the south side from a point 10 metres west of its junction with Rawstorn Road to a point 6.3 metres east of that junction

**Pope's Lane, Colchester**

**To revoke:**

- (i) the north side for its entire length
- (ii) the south side from its junction with Crowhurst Road to a point 3.5 metres east of that junction
- (iii) the south side from its junction with Crowhurst Road to its junction with Rawstorn Road

**To introduce:**

- (i) the north side for its entire length including its eastern extremity
- (ii) the south side from its junction with Rawstorn Road to a point 4.8 metres east of its junction with Crowhurst Road

**Rawstorn Road, Colchester**

**To revoke:**

- (i) both sides from its junction with Southway to its junction with Crouch Street
- (ii) the east side from its junction with Pope's Lane to a point 19 metres south of that junction
- (iii) the east side from a point 43 metres south of its junction with Pope's Lane to a point 8 metres south of that point
- (iv) the east side from a point 56 metres south of its junction with Pope's Lane to a point 6.6 metres south of that point
- (v) the east side from its junction with Papillon Road to a point 5.5 metres north of that junction
- (vi) the east side from its junction with Papillon Road to a point 11 metres south of that junction
- (vii) the east side from a point 9 metres north of its junction with Manor Road to a point 10 metres north of that point



- (viii) the east side from its junction with Manor Road to a point 4 metres north of that junction
- (ix) the east side from its junction with Crouch Street to its junction with Manor Road
- (x) the west side from its junction with Papillon Road to a point 3 metres north of that junction
- (xi) the west side from a point 79 metres north of its junction with Papillon Road to a point 39.5 metres north then east from that point
- (xii) the west side from its junction with Papillon Road to a point 10 metres south of that junction
- (xiii) the west side from its junction with Manor Road to a point 5.5 metres north of that junction
- (xiv) the west side from its junction with Crouch Street to a point 24 metres north of that junction
- (xv) the west side from its junction with Crouch Street to a point 35 metres north of its junction with Crouch Street to a point 4 metres north of that point
- (xvi) the west side from its junction with Manor Road to a point 7.3 metres south of that junction

**To introduce:**

- (i) both sides between its junctions with Southway and Crouch Street
- (ii) the east side from its junction with Crouch Street to a point 5 metres north of its junction with Manor Road
- (iii) the east side from a point 3.4 metres north of its junction with Papillon Road to a point 9.7 metres south of that junction
- (iv) the east side from its junction with Pope's Lane south for a distance of 20.7 metres
- (v) the west side from its junction with Crouch Street north for a distance of 24.5 metres
- (vi) the west side from a point 5.2 metres north to a point 5.5 metres south of its junction with Manor Road
- (vii) the west side from a point 3.4 metres north to a point 10 metres south of its junction with Papillon Road
- (viii) the west side from its junction with Pope's Lane south for a distance of 5.1 metres

**St Alban's Road, Colchester**

**To revoke:**

- (i) the east side from its junction with Papillon Road to a point 19 metres north of that junction
- (ii) the east side from a point 3 metres north of the party wall of Nos 27 & 29 to its junction with the northern kerbline of the east to west length of St Alban's Road
- (iii) the north side the entire length including the vehicle turning area at its western end
- (iv) the south side from its junction with the western kerbline of the north to south length of St Alban's Road westwards for a distance of 10 metres

- (v) the south side from a point 46.5 metres west of the north to south length of St Alban's Road westwards for a distance of 11 metres
- (vi) the south side from a point 62.5 metres west of the north to south length of St Alban's Road westwards for the remainder of its length
- (vii) the west side from a point in line with the southern boundary of No.2 St Alban's Road to a point 5 metres south of that point
- (viii) the west side from its junction with Papillon Road to a point 5 metres north of that junction
- (ix) the west side from a point in line with the party wall of Nos 26 and 28 to its junction with the southern kerblines of the east to west length of St Alban's Road

**To introduce:**

- (i) the east side of the north to south leg from its junction with Papillon Road north for a distance of 16 metres
- (ii) the west side of the north to south leg from its junction with Papillon Road north for a distance of 5 metres
- (iii) the north and south sides of the east to west leg from a point in line with the northern flank wall of No.29 on the east side north, west, south then east to a point 16.2 metres east of the eastern garage wall of No.48, including the turning head
- (iv) the west side of the north to south leg from a point 0.7 metres north of the boundary of Nos 26 and 28 to a point 5.5 metres west of the eastern flank wall of No.28

**No Waiting Mon-Sat 8am-6pm restrictions to be introduced or revoked (existing restrictions contained within Schedule 5 of the 2008 Order)**

**Prettygate Road, Colchester**

**To revoke:**

- (i) the west side from a point 29 metres south of its junction with Cotman Road to a point 52 metres north-west of that junction

**To introduce:**

- (i) the west side from a point 52 metres north-west of its northern junction with The Commons north-west for a distance of 46.5 metres

**No Waiting At Any Time/No Loading At Any Time restrictions to be introduced or revoked (existing restrictions contained within Schedule 26 of the 2008 Order)**

**Crouch Street (West), Colchester**

**To revoke:**

- (i) the north and east side from its junction with Balkerne Hill to a point 59.5 metres north then west of that junction (measured along the kerblines)

- (ii) the south-west side from its junction with Balcerne Hill to a point 38.5 metres north-west of that junction (measured along the kerblne)

**To introduce:**

- (i) the north and east side from its junction with Balcerne Hill to a point 60 metres north then west of that junction
- (ii) the south-west side from its junction with Balcerne Hill to a point 44 metres north-west of that junction

**Limited Waiting 30 Mins No Return Within 2 Hours Mon-Sat 8am-6pm restrictions to be introduced or revoked (existing restrictions contained within Schedule 43 of the 2008 Order)**

**Crouch Street (West), Colchester**

**To revoke:**

- (i) the north side from a point 21.5 metres east of its junction with Rawstorn Road to a point 71.5 metres east of that junction

**To introduce:**

- (i) the north side from a point 21.5 metres east of its junction with Rawstorn Road east for a distance of 72.7 metres

**Limited Waiting 2 Hours No Return Within 2 Hours Mon-Sat 8am-6pm restrictions to be introduced or revoked (existing restrictions contained within Schedule 44 of the 2008 Order)**

**Crouch Street (West), Colchester**

**To revoke:**

- (i) the north side from a point 13.5 metres west of its junction with Rawstorn Road to a point 36 metres west of that point

**To introduce:**

- (i) the north side from a point 14 metres west of its junction with Rawstorn Road west for a distance of 16.5 metres
- (ii) the north side from a point 33.5 metres west of its junction with Rawstorn Road west for a distance of 16.5 metres

**No Waiting Mon-Fri 8am-4pm restrictions to be introduced or revoked (Existing restrictions contained within Schedule 51 of the 2008 Order)**

**Crowhurst Road, Colchester**

**To revoke:**

- (i) the east side from a point adjacent to the boundary of Nos 51 & 52 northwards to a point adjacent to the boundary of Nos 47 & 48

**To introduce:**

- (i) the east side from a point level with the boundary between Nos 50 & 51 north to the boundary of Nos 47 & 48

**Papillon Road, Colchester**

**To revoke:**

- (i) the north side from a point 7 metres west of its junction with Crowhurst Road westwards for a distance of 7 metres

**To introduce:**

- (i) the north side from a point 6 metres west of its junction with Crowhurst Road west for a distance of 7.7 metres
