# The Essex County Council (Colchester Borough) (Waiting Restriction) (Consolidation) (Amendment No. 24) Order 2010

WHEREAS the Essex County Council in exercise of its powers under Sections 1(1), 2(1) to (3), 4(1), 4(2), 32, 35, 45, 46, 49 and 53 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

- This Order may be cited as The Essex County Council (Colchester Borough) (Waiting Restriction) (Consolidation) (Amendment No.24) Order 2010 and shall come into operation on 24 May 2010.
- 2. The Essex County Council (Colchester Borough) (Waiting Restriction) (Consolidation) Order 2008 is hereby varied to the extent detailed in the Schedule to this Order.
- The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act or by or under any other enactment.

### SCHEDULE

The Essex County Council (Colchester Borough) (Waiting Restriction) (Consolidation)
Order 2008 is varied as follows:-

No Waiting At Any Time restrictions to be introduced or revoked (Existing restrictions contained within Schedule 1 of the 2008 Order)

## Balkerne Passage, Colchester

## To introduce:

(i) both sides from its junction with North Hill to its western extremity at Balkerne Gate including the turning area and western access to the Mercury Theatre.

## Church Street, Colchester

#### To revoke:

- (i) the north side from its junction with Head Street to a point opposite the north-west corner of No.8
- (ii) the south side from its western extremity to St Mary's Art Centre
- (iii) the north side from the eastern boundary of St Mary's Art Centre west to its end

#### To introduce:

- (i) both sides from its junction with Head Street to a point level with the north-west corner of No.8
- (ii) both sides from the eastern flank wall of St Mary's Art Centre west to and including its western extremity

## Mercury Theatre Access Road, Colchester

#### To introduce:

(i) both sides from its junction with Balkerne Passage to a point level with the boundary of Nos 3 & 4 Church Street

No Waiting At Any Time and No Loading At Any Time restrictions to be introduced or revoked (existing restrictions contained within Schedule 26 of the 2008 Order)

## Balkerne Gardens, Colchester

## To revoke:

(i) both sides from its junction with Church Street northwards to a point opposite the boundary of Nos 3 & 4

## **Church Street, Colchester**

## To revoke:

(i) both sides from a point opposite the north-west corner of No.8 west and south to the eastern boundary of St Mary's Art Centre

#### To introduce:

(i) both sides from the north-west corner of No.8 westwards and southwards to the eastern flank wall of St Mary's Art Centre

## Mercury Theatre Access Road, Colchester

#### To introduce:

(i) both sides from its junction with Church Street north to a point level with the boundary of Nos 3 & 4 Church Street

Pedal Cycle Parking Place restrictions to be introduced (existing restrictions contained within Schedule 58 of the 2008 Order)

## Mercury Theatre Access Road, Colchester

## To introduce:

(i) the west side to the western side of the footway from a point 9 metres north of its junction with Church Street north for a distance of 5.6 metres
