17(z) – to stop at any time in the lengths of verge and footway specified in Schedule 63A.

Access Road to Service Area, Colchester

To introduce: BOTH SIDES: from its junction with the Unnamed Road west for 10 metres.

No Stopping At Any Time on Verge and Footway restrictions to be introduced (To be inserted as new Schedule 63A to the 2008 Order)

Unnamed Road, Colchester

To introduce: BOTH SIDES: From its junction with the northern junction of the Roundabout where Axial Way meets United Way, generally north westerly for its entire length a distance of 466 metres.

Access Road to Service Area, Colchester

To introduce: BOTH SIDES: from its junction with the Unnamed Road west for 10 metres.

EFFECT OF THE ORDERS:

 To introduce a 40MPH speed limit on that length of Unnamed Road and Access Road to Service Area in the Borough of Colchester as specified:

Unnamed Road	From its junction with the northern junction of the Roundabout where Axia Way meets United Way, generally north westerly for its entire length a distance of 466 metres.

3. To introduce a 'No Stopping at Any Time on verge and footway' restriction on that length of the Unnamed Road and the Access Road to the Service Area in the Borough of Colchester as specified:

Road	Location/Distance
Unnamed Road	From its junction with the northern junction of the Roundabout where Axial Way meets United Way, generally north westerly for its entire length a distance of 466 metres.



Access Road to Service Area.	From its junction with the Unnamed Road west for 10 metres.

The Essex County Council (Colchester Borough) (Waiting Restriction) (Consolidation) Order 2008 will be varied by the above waiting restrictions order.
