


The Essex County Council (Colchester Borough) (Waiting Restriction)
(Consolidation) (Amendment No.29) Order 2011

WHEREAS the Essex County Council in exercise of its powers under Sections 1(1), 2(1) to (3), 4(1), 4(2), 32, 35, 45, 46, 49 and 53 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. This Order may be cited as The Essex County Council (Colchester Borough) (Waiting Restriction) (Consolidation) (Amendment No 29) Order 2011 and shall come into operation on 3 June 2011.
2. The Essex County Council (Colchester Borough) (Waiting Restriction) (Consolidation) Order 2008 (hereinafter referred to as '2008 Order') is hereby varied to the extent detailed in the Schedule to this Order
3. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restrictions or requirement imposed by any regulations made or having effect as if made under the Act or by any other enactment.

No Waiting At Any Time restrictions to be introduced or revoked (Existing restrictions contained within Schedule 1 of the 2008 Order)

To introduce the following in Rotary Way

BOTH SIDES: From its junction with A134 Westway proceeding in an easterly direction for a distance of approximately 30 metres.

WEST SIDE: From a point 90 metres east of its junction with A134 Westway north for a distance of approximately 140 metres.

No Loading at any Time/No Waiting at any time restrictions to be introduced or revoked (Existing restrictions contained within Schedule 26 of the 2008 Order)

To introduce the following in Rotary Way

BOTH SIDES: From a point 30 metres east from its junction with A134 Westway proceeding in an easterly then northerly direction for a distance of approximately 60 metres (to include the roundabout).
